- Mr Franklin made a request for finance committee and HofS to do a review of our financial policies during te 2018-19 school year. The goal would be to adopt updated policies/procedures for the spring of 2019 for 2019-20 school year.
- We will be hiring a part time CFO based on the recommendation of the ESD to do payroll/HR paperwork/processing.
- With the money that is remaining from the CFO position, it was requested that we hire a .5 office staff at the primary and a 1.0 Instructional Assistant at the middle academy to support our special education population. Approved.
