

Our Middle and High School scientists had a fantastic showing at the Region III Science and Engineering Fair at Bristol Community College in Fall River on Saturday, March 7th.








Congratulations to our Falcon Trophy Winners!

FRCS Mission (excerpt)

The Foxborough Regional Charter School will provide students a challenging academic program to prepare them for college by stressing achievement, discipline, hard work and accountability. We will continually challenge all of our students, regardless of ability, so that we will lead the Commonwealth of Massachusetts in all statewide standards and assessments.

The Foxborough Regional Charter School will promote positive ethical, moral, and civic values and prepare students to serve their respective communities as leaders and good citizens. We will present students with projects and issues requiring critical thinking, problem-solving, decision-making, and real-life applications of their academic studies through our Student Life and Community Service Learning programs which are integral components of the overall educational experience at Foxborough Regional Charter School.

FRCS recognizes the critical role career readiness has in long-term, sustained student success. The Vision statement emphasizes key career characteristics and skills including:

- measured achievement and accountability
- higher order thinking skills of problem solving, critical thinking, and applied learning
- professional habits of moral values, discipline, work ethic, and decision-making
- goal setting for continuing education beyond high school, and
- citizenship through service and leadership

These qualities are consistent with, and highlighted in, the Massachusetts definition of College and Career Readiness and Civic Preparation, as well as a progression of DESE and BHE recommendations and initiatives such as the ICCR Task Force, Career Development Education benchmarks, Individual Learning Plans, MyCAP, and High Quality College and Career Pathways (see Appendices). FRCS also endorses the Massachusetts School Counselors Association (MASCA) Massachusetts Model for Comprehensive School Counseling, which emphasizes a similar set of career readiness standards and competencies (https://masca.wildapricot.org/MA-Model-2.0). This Model is endorsed by MA DESE as best practice and based on the American School Counselors Association National Model.

Career Readiness Framework

This document outlines the district's program priorities and goals for continuing to build and strengthen student access, engagement, and accomplishment in:

- Career Readiness,
- Applied Learning, and
- Work-Based Competencies.

The district Career Readiness Vision is to provide students the curriculum, resources, and experiences to develop the skills and habits necessary for successful careers. **The primary indicator for program success will be:**

- graduating student's completing internships, apprenticeships, certifications, project-based learning, and other activities,
- which demonstrate the application of career knowledge and abilities in both content and application

The framework used to categorize and track program development will be three categories:

- Skills (Rigor /Challenge) meaning the understanding and demonstration of career information, problem solving, and abilities
- Pathways (Relevance/Connection) meaning understanding and engaging in plans for opportunity and progressing toward career credentials
- Relationship (Conversation/Advising) -meaning understanding and utilizing the skills and interactions necessary for career mentoring and networking

In addition, three levels related to the depth of career readiness learning will be considered in all programming:

- Awareness passive interaction and knowledge of career related themes and content
- Exploration active interaction and knowledge based on experiencing career related environments, people, and activities
- Immersion active demonstration of career related knowledge and skills through project based, experiential learning directly related to career readiness competencies

Note: This document is focused on Career Readiness. College Readiness involves other events, curriculum, programming, and experiential learning.

Curriculum

Curriculum delivers key content to provide students with understanding of concepts and information. For Career Readiness at FRCS, our academic and school counseling curriculum will emphasize a range of skills required for work-based and professional competencies identified in the school's mission statement and in the Massachusetts state



recommendations and guidelines found in the documents in the Appendices.





Appendix A

Massachusetts Definition of College and Career Readiness and Civic Preparation

Massachusetts educators at the secondary and post-secondary level have recognized career readiness programming, preparation, and skills are critical for all student's success. A number of statewide initiatives and reviews over several years resulted in the definition below which was adopted by both the Board of Elementary and Secondary Education as well as the Board of Higher Education in early 2016.



State Targets

To better prepare all students for successful futures, our efforts are anchored in the following DESE goals:

- Increasing the five year graduation rate
- Increasing the MassCore completion rate
- Increasing the number of students that enroll in postsecondary education
- Reducing the number of students who enroll in developmental (remedial) coursework during their postsecondary educational experience

All of these metrics are connected to DESE's goal of preparing all students for *Success after High School*.

Overview

Massachusetts students who are college and career ready and prepared for civic life will demonstrate the knowledge, skills and abilities that are necessary to successfully complete entry-level, credit-bearing college courses, participate in certificate or workplace training programs, enter economically viable career pathways, and engage as active and responsible citizens in our democracy. In order to meet this goal, the Commonwealth has defined a set of learning competencies, intellectual capacities and experiences essential for all students to become lifelong learners; positive contributors to their families, workplaces and communities; and successfully engaged citizens of a global 21stcentury.

Beyond achieving college and career ready levels of competence in English Language Arts / Literacy and Mathematics, all high school students should develop a foundation in the academic disciplines identified in the MassCore course of study¹, build competencies for workplace readiness as articulated in the Integrating College and Career Task Force Report², and focus on applying academic strategies to problem solving in diverse professional and life contexts, appropriate to individual student goals. Massachusetts will use its 2011 curriculum frameworks³, which include the Common Core State Standards, as the basis for an educational program that provides students with the academic knowledge, skills and experiences that are essential to postsecondary educational career, and personal success.

Essential Competencies

Learning

Students who are college and career ready in English Language Arts / Literacy will demonstrate the academic knowledge, skills, and practices necessary to enter into and succeed in entry-level, credit-bearing courses in College English Composition, Literature, or technical courses; certificate or workplace training programs requiring college-level reading and writing; or a comparable entry-level reading and writing course at the institution.

¹ MassCore is a rigorous and comprehensive four year course of high school study recommended by the Commonwealth as preparation for college and career. MassCore is also the vehicle through which high school students can gain competence in computational, scientific, visual, creative, and critical thinking and can engage in opportunities for "hands-on" application and exploration of new areas of knowledge and experiences.

College and career ready students in English Language Arts/ Literacy will be *academically prepared* to:

- Read and comprehend a range of sufficiently complex texts independently
- Write effectively when using and/or analyzing sources
- Build and present knowledge through research and the integration, comparison,
 and synthesis of ideas
- Use context to determine the meaning of words and phrases

Similarly, students who are college and career ready in Mathematics will demonstrate the academic knowledge, skills, and practices necessary to enter into and succeed in entry-level, credit bearing courses in College Algebra, Introductory College Statistics, or technical courses; certificate or workplace training programs requiring an equivalent level of mathematics; or a comparable entry-level math course at the institution. College and career ready students in Mathematics will be *academically prepared* to:

- Solve problems involving the major content with connections to the mathematical practices
- Solve problems involving the additional and supporting content with connections to the mathematical practices
- Express mathematical reasoning by constructing mathematical arguments and critiques
- Solve real world problems, engaging particularly in the modeling practice

Successful achievement of specified levels of competence in English Language Arts / Literacy and Mathematics will be required for students to be placed into entry-level courses in college or participate in certificate or workplace training programs without the need for remediation.

Workplace Readiness

Student preparation for college and career should emphasize career awareness, exploration and immersion as well as development of the foundational knowledge and skills necessary to successfully navigate the workplace. Students who are college and career ready and prepared for civic life will demonstrate:

Work Ethic and Professionalism

Attendance and punctuality expected by the workplace

- Workplace appearance appropriate for position and duties
- Accepting direction and constructive criticism with a positive attitude and response
- Motivation and taking initiative, taking projects from initiation to completion
- Understanding workplace culture, policy and safety, including respecting confidentiality and workplace ethics

Effective Communication and Interpersonal Skills

- Oral and written communication appropriate to the workplace
- Listening attentively and confirming understanding
- Interacting with co-workers, individually and in teams

Proficiency in these skills is common for success in all workplaces and should be viewed as the foundation upon which additional workplace and career skills are added based on the specifics of any job.

Civic Readiness

To be college and career ready and prepared for civic life, students must also possess the knowledge, intellectual skills, and applied competencies that citizens need for informed and effective participation in civic and democratic life. They must also acquire an understanding of the social values that underlie democratic structures and practices. Civic knowledge, skills, and competencies can be obtained in a variety of settings and ways, including in the classroom, across content areas, through service-learning, discussion of controversial issues, student government, and extracurricular opportunities. Key knowledge, skills, and dispositions that students should possess to be prepared to engage as active citizens include:

- Core civic content knowledge and the ability to apply that knowledge to different circumstances and settings.
- Civic intellectual skills, including the ability to identify, assess, interpret, describe, analyze and explain matters of concern in civic life.
- Civic participatory skills, including knowing how to work collaboratively in groups and organizational settings, interface with elected officials and community representatives, communicate perspectives and arguments, and plan strategically for civic change.
- Civic dispositions including interpersonal and intrapersonal values, virtues and behaviors (respect for others, commitment to equality, capacity for listening,

capacity to communicate in ways accessible to others, etc.).

Qualities and Strategies

Preparation for college, career, and civic life should help students develop a wide range of quantitative and qualitative abilities that go beyond the minimum levels of competence needed for entry-level college courses and employment. In high school, students should demonstrate:

- Higher order thinking skills of analysis, synthesis, and evaluation
- The ability to think critically, coherently, and creatively
- The ability to direct and evaluate their own learning, be aware of resources available to support their learning, and have the confidence to access these resources when needed.
- Motivation, intellectual curiosity, flexibility, discipline, self-advocacy, responsibility, and reasoned beliefs

Together these attributes provide the framework for college and career readiness and support educational and workplace success, as well as serve as the basis for being an active participant in our democracy.
