The whole YSCS team joined at the beginning of the call to be congratulated by Mr. Churchill and the entire Board for the team's hard work and determination.

# III. DISCUSSION TOPICS

### 1. Executive Director

- a Social Studies Content Team Introduction- The Social Studies content team introduced themselves. They talked about what they were working on, class priorities, and successes. Beth Birnkrant talked about the cohesive curriculum, teacher created materials, and the focus on writing through the social studies lens. To focus on writing, the content team is working with ELA teachers to improve writing across the curriculum. Moving forward, the team would like to make the curriculum more culturally relevant. They also talked about the shift to digital learning and what has been successful and challenging. They continued with a strong daily structure and stayed consistent with what they did in the regular classroom. A challenge has been fostering student discourse and debate. Next year, they would like to figure out how to work with local officials and participate in more community initiatives.
- b Distance Learning / Continuing Education Update- John Amenda went through the timeline of the distance learning process. On April 14, the staff shifted from review to continuing through curriculum. Report card conferences are happening virtually for Quarter 3. Families have appreciated the consistent structure and routine. Staff has had contact with 100% of families. The school purchased additional technology devices to ensure all students were connected. The staff was given a stipend for internet usage and 60% of them returned the stipend for a family assistance fund. Mr. Amenda also went through the daily schedule structure. Teachers are prerecording lessons and then going through them with students. He then discussed distance learning engagement statistics, highlighting

high attendance rates and strong student engagement. Mr. Amenda then talked about best practices and continuous improvements, including daily review of classroom practices, shifting focus on work quality and report card conferences. He concluded that the team is in good health overall. He conducted a "pulse survey" to see how staff was feeling about current situation. He also talked about 2020-21 planning. The school is anticipating state cuts and needs to raise funds to sustain programs and student supports. The school year will still begin on August 19<sup>th</sup>, whether that is online or in person. Different options for the school opening were discussed, including alternate schedules and distance learning.

- c Summer School Programming- The school is planning to offer summer school. They are prioritizing the program to be for 100 6<sup>th</sup> graders, as well as an enrichment opportunity for 7<sup>th</sup> and 8<sup>th</sup> graders. The program will also be used as remediation for students who are struggling and to help them move forward.
- d Re-Opening Options and Early Planning- Mr. Amenda went over this when giving the distance learning update.
- e 20-21 Event and fundraising- There will be no Fall event for reasons of uncertainty with the current situation. Ellyn Saft talked about how fundraising needs to sustain the school's programs and secure students' futures. Board members were encouraged to communicate with friends and families about the school. Mr. Churchill asked for 100% board participation.
- f SDP to now Eliminate Buses for 6<sup>th</sup> Grade- Mr. Amenda received a notification that the district is taking buses away from 5-6th graders which was addressed to 3 schools. District officials put together the following policy- if a student attends a K-8<sup>th</sup> school, buses will be available and if the student attends just a stand-alone 6-8<sup>th</sup> middle school then school buses will not be available. Mr. Amenda will be following up with the school's attorney and figuring out how to get bus transportation for YSCS students.
