Soleil Academy has continued to meaningfully consult with community members with the development of the school's Local Control & Accountability Plan (LCAP), development of the school's comprehensive needs assessment, and development of multiple school plans during the 2020-21 school year. Consultation with community members has been integral to the development of the multiple plans over the past few years. The following efforts have been made by Soleil Academy's Administrative Team to meaningfully consult with the required community members and to provide opportunities to seek public input with the development of this plan.

- Students were administered surveys which concluded they would like additional time to socialize with their peers, especially since most students participated in distance learning for over a year.
- Families, including families that speak languages other than English; and families (advocates) of Students with Disabilities were consulted during ELAC/DELAC meetings, Cafecitos with the Leadership Team (monthly), Family Nights, Parent University, and were surveyed in (Fall/Spring). Interpreter services were made available upon request for meetings, and was also provided by members of our bilingual/multi-lingual staff. Soleil Academy conducted numerous outreach efforts to ensure families representing all student groups participated including those representing Unduplicated Pupils and Students with Disabilities. As with all correspondence, all materials sent to families were written in a language that is understandable and accessible to parents. Accommodations as appropriate were also made for family members with disabilities including providing information and school reports in a format (to the extent practicable) in a language that parents understand.

- School administrators, including special education administrators; met weekly and were consulted on schoolwide needs based on a review and analysis of multiple forms of school and student data.
- Teachers, principals, school leaders, other educators, school staff, were consulted during weekly staff meetings, professional development, weekly check-ins (goal setting feedback meetings), Beginning/mid/end of year evaluations, huddles (take place 3 times per week), and surveys (administered 3 times per year).
- Community partners expanded learning providers, and other community organizations that include but are not limited to: Budding Artists, LA Care, Angel's Nest Pre-School, local daycares, and University of Chicago's Impact - Build, Excel and Sustain during meetings and conversations that took place virtually.
- Soleil Academy evaluated its community member engagement opportunities and determined that tribes, Civil Rights Organizations including Disability Rights Organizations and Individuals/advocates representing interests of English Learners, Homeless, foster youth, migratory students, children who are incarcerated and underserved students were neither present nor currently served by the school.

Soleil Academy collected community member input and feedback, which was analyzed and used to develop this plan.

At its core, Soleil Academy has consistently and continuously sought community input in the development of the multitude of school plans over the past 18 months including the development of the school's Local Control & Accountability Plan and ESSER III Expenditure Plan. Presentations to community members included schoolwide and student assessment data findings, and LCAP metrics (annual measurable outcomes).

- Students were administered surveys which concluded they would like additional time to socialize with their peers, especially since most students participated in distance learning for over a year.
- Families shared their concern with their child's learning loss and achievement gaps due to COVID-19 distance learning. Parents of Students with Disabilities requested additional in-person support during IEP meetings.

- School Administrators (Executive Director, Dean of Culture, Operations Manager, Operations Director) identified the need to provide struggling learners with targeted evidence-based interventions for all grade levels; focus on allocating services (ESSER III funded) for high-risk student groups; and the need to hire Interventionists and Aides to support students through push-in tiered supports.
- Teachers, principals, school leaders, other educators, school staff (including teachers, paraprofessionals) discussed the need to hire additional staff to provide struggling learners with additional academic supports/intervention; and provide small group instruction.
- Special Education Administration/Department discussed the need to acquire manipulatives for student use to access instructional materials; and provide hands-on experiential learning opportunities with Math and Science instruction.
- Community partners expanded learning providers, and other community organizations suggested the school expand after-school clubs offering and/or provide them on weekends; the need to continue to outreach for future events; and the need to expand social-emotional supports; and strengthen reading instruction.

In identifying actions/services to be funded with ESSER III funds, our priority was focus on addressing Lost Instructional Time through tiered academic support, using Tier 1-3 Evidence-based Interventions. As a result of findings from multiple forms of school/student assessment data (Comprehensive Needs Assessment), and in response to input from community members; and addressing Health & Safety concerns with the return to in-person instruction. The actions/services outlined in the ESSER III Expenditure Plan were influenced through meaningful consultation with community members and consensus was reached on the use of ESSER III Funds to focus on the following:

- Health & Safety – acquire additional staff to implement COVID-19 protocols (testing, contact tracing, etc.)
- Addressing Academic Needs to Accelerate Learning (Addressing the Impact of Lost Instructional Time)

ESSER III Expenditure Plan Instructions

Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.

The plan must be adopted by the local governing board or body of the LEA at a public meeting on or before September 30, 2021 and must be submitted for review and approval within five days of adoption. A school district must submit its ESSER III Expenditure Plan to its COE for review and approval; a COE must submit its plan to the California Department of Education for review and approval. A charter school must submit its plan to its chartering authority for review and to the COE of the county in which the charter school operates for review and approval.

- Written in an understandable and uniform format;
- Written in a language that parents can understand, to the extent practicable;

- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.
