### **Plan Descriptions**

A description of how parents, teachers, and school staff were involved in the development of the plan.

Teachers and school staff shared ideas regarding the plan for next year during our monthly team meetings. The need for more staff to support individualized learning was evident in our discussions regarding how to best support our scholars.

We shared the plan with parents during our monthly Cafecitos meeting and also shared our rationale for the draft plan to support scholars individually.

A description of how students will be identified and the needs of students will be assessed.

A scholar is considered low-achieving if s/he is performing below current grade level on class assignments and assessments with special attention to reading, not meeting standards or nearly meeting standards on the CAASPP exam, or below grade level on the NWEA MAP. If a scholar is low-achieving based on these internal and external measures, a conference is arranged with the parent,

teacher, and school leader to discuss possible interventions for the scholar. Progress is tracked and monitored on a weekly basis through exit tickets, classwork, and internal assessments.

A description of how parents and guardians of students will be informed of the opportunities for supplemental instruction and support.

A parent is informed of available supplemental instruction opportunities once a scholar is identified as low-performing. During the initial conference, interventions are assigned. After the mutually agreed upon time frame, typically six weeks, the student supports team will identify additional needs and more intervention opportunities are allocated at that time.

A description of the LEA's plan to provide supplemental instruction and support.

Soleil Academy will be providing supplemental small group instruction for low-performing scholars. Two credentialed interventionists will be hired during the 2021-22 school year to service scholars who are below grade level. Interventions will be provided during the school day in either a small group setting or one on one.

Necessary student materials will also be purchased to support interventions.

A description of how ELO Grant funds are being coordinated with other federal Elementary and Secondary School Emergency Relief Funds received by the LEA.

Soleil is coordinating the use of both ELO grant funds and federal ESSER funds to strategically support school reopening and systematically approach recovery from learning loss. We have analyzed the timelines and allowable expenses for each stream of funding and partnered with school stakeholders to understand how to best use these funds to support students. Initially, that meant targeting funds to needed facilities upgrades and securing PPE and other supplies and staffing for safety. Thereafter, we focused on providing additional programming and staffing to assess and identify our highest need students and work to mitigate learning loss through both whole school approaches and efforts targeted to the highest need students. These include working to grow staff capacity through professional development, investing in high quality intervention programming, paying teachers to analyze data and revise scope and sequences to meet student needs. It also includes providing additional support staff and programming to address students' academic and SEL needs to provide additional learning time during school breaks. Through these efforts, we collectively strategized to address students' immediate needs and have planned for the future needs.

During the budget process, these funds have been tagged for allowable expenses to support the learning of our low-performing scholars. This process prevents us from applying the same expenses to multiple funding sources.

### **Expanded Learning Opportunities Grant Plan Instructions: Introduction**

The Expanded Learning Opportunities Grant Plan must be completed by school districts, county offices of education, or charter schools, collectively referred to as Local Educational Agencies (LEAs), that receive Expanded Learning Opportunities (ELO) Grant funds under California *Education Code* (*EC*) Section 43521(b). ### **Instructions: Plan Requirements**

An LEA receiving ELO Grant funds under *EC* Section 43521(b) is required to implement a learning recovery program that, at a minimum, provides supplemental instruction, support for social and emotional well-being, and, to the maximum extent permissible under the guidelines of the United States Department of Agriculture, meals and snacks to, at a minimum, students who are included in one or more of the following groups:

- low-income,
- English learners,
- foster youth,
- homeless students,
- students with disabilities,
- students at risk of abuse, neglect, or exploitation,
- disengaged students, and
- students who are below grade level, including, but not limited to, those who did not enroll in kindergarten in the 2020–21 school year, credit-deficient students, high school students at risk of not graduating, and other students identified by certificated staff.

For purposes of this requirement

- "Supplemental instruction" means the instructional programs provided in addition to and complementary to the LEAs regular instructional programs, including services provided in accordance with an individualized education program (IEP).
- "Support" means interventions provided as a supplement to those regularly provided by the LEA, including services provided in accordance with an IEP, that are designed to meet students' needs for behavioral, social, emotional, and other integrated student supports, in order to enable students to engage in, and benefit from, the supplemental instruction being provided.

• "Students at risk of abuse, neglect, or exploitation" means students who are identified as being at risk of abuse, neglect, or exploitation in a written referral from a legal, medical, or social service agency, or emergency shelter.

*EC* Section 43522(b) identifies the seven supplemental instruction and support strategies listed below as the strategies that may be supported with ELO Grant funds and requires the LEA to use the funding only for any of these purposes. LEAs are not required to implement each supplemental instruction and support strategy; rather LEAs are to work collaboratively with their community partners to identify the supplemental instruction and support strategies that will be implemented. LEAs are encouraged to engage, plan, and collaborate on program operation with community partners and expanded learning programs, and to leverage existing behavioral health partnerships and Medi-Cal billing options in the design and implementation of the supplemental instruction and support strategies being provided (*EC* Section 43522[h]).

The seven supplemental instruction and support strategies are:

- 1. Extending instructional learning time in addition to what is required for the school year by increasing the number of instructional days or minutes provided during the school year, providing summer school or intersessional instructional programs, or taking any other action that increases the amount of instructional time or services provided to students based on their learning needs.
- 2. Accelerating progress to close learning gaps through the implementation, expansion, or enhancement of learning supports including, but not limited to, any of the following:
  - a. Tutoring or other one-on-one or small group learning supports provided by certificated or classified staff.
  - b. Learning recovery programs and materials designed to accelerate student academic proficiency or English language proficiency, or both.
  - c. Educator training, for both certificated and classified staff, in accelerated learning strategies and effectively addressing learning gaps, including training in facilitating quality and engaging learning opportunities for all students.
- 3. Integrated student supports to address other barriers to learning, such as the provision of health, counseling, or mental health services, access to school meal programs, before and after school programs, or programs to address student trauma and social-emotional learning, or referrals for support for family or student needs.
- 4. Community learning hubs that provide students with access to technology, high-speed internet, and other academic supports.
- 5. Supports for credit deficient students to complete graduation or grade promotion requirements and to increase or improve students' college eligibility.
- 6. Additional academic services for students, such as diagnostic, progress monitoring, and benchmark assessments of student learning.
- 7. Training for school staff on strategies, including trauma-informed practices, to engage students and families in addressing students' social-emotional health needs and academic needs.

As a reminder, *EC* Section 43522(g) requires that all services delivered to students with disabilities be delivered in accordance with an applicable IEP.

#### **Fiscal Requirements**

The following fiscal requirements are requirements of the ELO grant, but they are not addressed in this plan. Adherence to these requirements will be monitored through the annual audit process.

- The LEA must use at least 85 percent (85%) of its apportionment for expenditures related to providing in-person services in any of the seven purposes described above.
- The LEA must use at least 10 percent (10%) of the funding that is received based on LCFF entitlement to hire paraprofessionals to provide supplemental instruction and support through the duration of this program, with a priority for full-time paraprofessionals. The supplemental instruction and support provided by the paraprofessionals must be prioritized for English learners and students with disabilities. Funds expended to hire paraprofessionals count towards the LEAs requirement to spend at least 85% of its apportionment to provide in-person services.
- An LEA may use up to 15 percent (15%) of its apportionment to increase or improve services for students participating in distance learning or to support activities intended to prepare the LEA for in-person instruction, before in-person instructional services are offered.
