Describe how the funds received under this section will increase or improve services for unduplicated pupils to improve A-G eligibility.

Animo Jackie Robinson Charter High will be using funds to increase or improve services for unduplicated pupils to improve A-G eligibility by investing in activities that directly support to meet the needs of students. The funds are intended to expand counseling capacity to provide academic and college readiness guidance, and further promote parent engagement. Additional professional development opportunities for teachers are intended to increase course offerings, strengthen standards aligned teaching practices, bolster education quality, and provide intentional support to struggling students. Finally, the funds will allow us to expand class offerings to remove barriers for students who need support with credit recovery, including online credit recovery curriculum and courses. The combination of multiple strategies are aimed towards increasing and improving services for all to ensure each student has a pathway to improved A-G eligibility and beyond.

Our school has 1-2 counselors who provide academic and college readiness counseling. Where necessary, supplementary investments will be made to expand counseling capacity by adding additional staff (counselor and/or college success advisor) to continue to support students to track promotion progress and develop plans for college readiness.

Our school will provide professional development opportunities to train teachers to increase AP course offerings so pupils continue to have access to completing A-G course requirements. These funds will allow us to create more avenues for students to satisfy requisites beyond the multiple pathways created in the master schedule to meet A-G requirements. By broadening options for our students, those aiming to bridge progress from 9th-10th grade will have the opportunity to engage in targeted summer intervention activities to improve A-G eligibility.

In addition to the robust scaffolds and support we offer students for test preparation, the school will cover the cost of advanced placement exam fees to remove financial barriers for students.

Based on evolving school needs, we intend to expand professional development opportunities to continue to improve A-G eligibility school wide. Standards Institute provides professional development for teachers on instructional practices to increase rigor and college readiness in their classes. Training will strengthen standards-alignment, include targeted scaffolds and prepare teachers to meet the unique needs of each student while maintaining high expectations and rigor.

We intend to provide extended semester support to students in credit recovery. Teachers, counselors, materials and supplies will be made available for students who need more program offerings to improve. We are estimating an additional 12-20 hours of support provided in Fall and Spring Semester. Intentional support for struggling students will also be provided through a digital curriculum designed to support students in credit recovery. Online licenses will be made available to students in need to take courses through APEX, Accellus, and Edgenuity.

Animo Jackie Robinson Charter High offers grade-specific, college readiness support and enrichment for all students. The funds will help subsidize our current academic supports and enrichment opportunities to ensure our students are on track to complete A-G courses and AP courses. Students have access to standards-aligned materials, additional instructional materials and educational programs as outlined in the school's charter petition and LCAP. Master schedules will reflect that students are enrolled in and have access to a broad range of courses that are appropriate for student needs. Where applicable, students have access to technology devices and connectivity to ensure they have access to A-G courses in a distance learning environment and for access at night, weekends and in the summer.
