#### **Academics**

- 1. During our last full faculty PD, we again received training in Academic Language and Literacy (ALL) strategies which will be a yearlong focus. Teachers are continuing to build a safe, brave learning environment while ensuring language supports such as stems, academic scripts, and word banks are in place. Teachers are working on posting clear content and language objectives which they can reference throughout their lesson, so students know what they're learning and how they are expected to demonstrate their knowledge. The junior high is using a common observation form centered around ALL strategies to conduct peer observations and inform next steps for professional development.

  - a. We had our program manager, Eric, and his supervisor visit the school for three hours. They observed AVID Elective, AVID Excel, Math 8 Honors, History 7, and ELA 8. OPA was the fourth day of Utah observations. We received excellent feedback and the team was incredibly impressed with the culture at OPA and the quality of instruction. They suggested making OPA the AVID showcase school for the state and we are currently considering how to make that happen.

- b. Grants submitted (with assistance of the Stephanies and Courtnie and Spencer)
  - Title I Risk Assessment and Plan. The Title I plan aligns with our School Plan. We use Title I funds to support Reading and Math, supplementing teacher salaries and funding Teaching Assistants working on interventions.
  - TSSA plan was accepted and has been funded.
- c. After school program. We have been using ESSER funds to support our after school program and summer program. This funding expires September 2023. We are currently looking at possible partnerships and grants to support this program moving forward. We hope to find the fundinging necessary to continue to manage the staff as part of OPA, and to provide this service to families free of charge.
- 2. Other submissions
  - a. Privacy Compliance Survey and updated MetaData Dictionary have been submitted.
- 3. Title III visit. Representatives from USBE visited OPA on November 3 to observe classrooms. They were looking for evidence of implementation of strategies to support English Learners. We are waiting for their feedback report, and then we will determine next steps to help improve this program.

## **Operations**

- 1. Early Childhood Center
  - a. The groundbreaking went well thanks to Teryl Young, Kasey Kennington, and Shevon Lopez. Rebecca Kiernan, Jenny Westbroek, and Brittany Ladley were also a big help.
  - b. Construction is in full swing.
  - c. We had to write a letter of assurance that we would not fence the area between the parking lot and sidewalk to the north of the ECC and to the South of the Elem. Due to other underground utilities, the water meter is being placed in this location. Should we decide to restrict Ogden City access to the meter, we will have to relocate it.
  - d. We are researching funding options for the preschool start up.
  - e. A playground was selected. We are still researching potential ground covers. (Procurement comparison attached.)
- 2. Family Engagement
  - a. The Family Engagement Committee has been formed and will meet monthly.
  - b. The Committee consists of several parents and school representatives from each signature program.
