#### Policy and Plans

In our April board meeting, the board approved policies *substantially similar* to those proposed. That authorized me to make small tweaks (e.g., word choice, grammar) to our policies that does not affect intent or meaning. The reason we keep approving reviewing policies and plans is because they reflect new information (e.g., the Title I Plan) or substantively amended information (e.g., when we have summer school days in the annual calendar).

empowering students to direct their own lives and learning

- <u>Annual Calendar</u>
  - *Summary:* Moved summer school up in April so that we could take state tests when most other schools in St. Louis do. We want to maximize instructional days before state assessments.

#### • Emergent Bilingual (Lau) Plan

- *Summary:* Federally required plan on how Kairos will support students with limited English proficiency.
- <u>Attendance Accounting for Remedial Instruction</u>
  - *Summary:* Kairos has outlined a policy for students at-risk of non-promotion, which qualifies them for remedial instruction (and qualifies Kairos to receive state funding for remedial attendance hours).
- <u>Parent/Student (Community) Handbook</u>
  - *Summary:* The same community handbook we had before, revised to add new staff and a couple extra forms.
- <u>Staff Handbook</u>
  - *Summary:* A standard staff handbook (based on a number of exemplars) with required sections and details around employee behavior, compensation, and procedures.
- <u>Title I.A Plan</u>
  - *Summary:* Required plans for us to receive federal grant money.
- <u>Emergency Response Handbook</u>
  - *Summary:* Action items in case of various emergencies at Kairos.

**Motion:** "I move to adopt policies and plans substantively similar to those listed above." (Second? Objections?)

Kairos Academies Vanguard Contract

- Approve a contract with <u>Kairos Academies Vanguard</u> for operational and administrative support.
  - Summary: It is advantageous to legally separate our administration and operation teams from our core teaching team. This contract hires Kairos Academies Vanguard, a third-party contractor, to provide those services to the school. There will be no functional change in how the school or board operates.



**Motion:** "I move to approve a contract substantively similar to the above with Kairos Academies Vanguard and, at his or her discretion, to authorize the Board President to nullify the current Kairos Academies contract with the CEO, Gavin Schiffres." (Second? Objections?)

#### Appointing State Required Coordinators

The Board is required to appoint a school-based coordinator for homeless students and those learning English as a second language. This coordinator is the point-of-contact for public requests or concerns surrounding these two at-risk subgroups. The CEO recommends appointing Kairos' Head of Neurodiverse Learning, who is responsible for coordinating and supporting all at-risk students, inclusive of these two groups.

- Foster Care Liaison: Head of Neurodiverse (Kat Lucido)
