Gap Funding: Emergency Charter School Funding Rule, does not affect Kairos, but it will help charter schools who are having issues growing due to the pandemic. MCPSA is looking for funders to help with gaps. Governor released additional dollars for the CARES Act yesterday. Low interest lending from IFF for gap funding. MCPSA are looking for ways to help and provide financial security while we work through the pandemic. Board to write a letter of support for policies that MCPSA are behind.

Model Policies: legal counsel did a deep review, so we will receive the 2020 policies next week.

Title IX Training

“As mentioned in my September 18th email, in August, the U.S. Department of Education released its Final Rule under Title IX of the Education Amendments of 1972, which prohibits discrimination on the basis of sex in education programs or activities receiving federal financial assistance. This Rule does require that all Schools must ensure that Title IX personnel (school leaders, human resource managers, board members, etc.) receive training.”
