Thank you to those who were able to join us yesterday afternoon for discussion of the St. Louis lawsuit and an appeal. At this time the State has filed their appeal with the 8th Circuit and an appeal on behalf of charter school parents is forthcoming. As a reminder, this lawsuit could potentially damage St. Louis charter school funding collectively more than \$89 million in arrears as well as approximately \$600 per student per year moving forward.

As in the past, we have established a St. Louis Charter Schools Defense Consortium to cover legal expenses. I have attached a Defense Consortium Agreement as well as a description of invoicing procedures. The Agreement again places a \$10 per student cap on the amount of legal fees your LEA would incur without additional approval. We encourage every charter school in St. Louis to participate in this Defense Consortium helping reduce the expense burden for everyone while effectively fighting this baseless lawsuit. To date 5 charter school LEAs have already submitted their 2020 - 21 Agreement (Gateway Science Academies, KIPP:St. Louis, La Salle Middle School, Lafayette Preparatory Academy, Lift for Life Academy).

If you and your Board determine you will participate in the Consortium please execute the joint representation agreement and return to me. Please have all agreements returned by January 15, 2021. If you have any questions and would like to discuss please feel free to give me a call. If your Board would like to discuss let me know and I am happy to come by their Board Meeting).

As in the past, moving forward, we will have opportunities for each of your legal counsel to confer with the lead counsel for this lawsuit (Stinson LLP). Next Tuesday afternoon we will be holding a briefing for Board Chairs with Stinson.

Once again, we will be making an application to the National Alliance for Charter Public Schools Legal Action Committee for a \$50,000 matching grant to assist with legal expenses.



Finally, feel free to reply ALL on this email and let other LEAs know that your LEA is participating in the Consortium so no one or two charters are carrying the financial burden.
