

Budget Overview for the 2023-24 School Year







Plan Summary [2023-24]

General Information

A description of the LEA, its schools, and its students in grades transitional kindergarten-12, as applicable to the LEA.

Ánimo James B. Taylor Charter Middle School (AJBT) opened in 2013 with 129 6th graders and continued to grow each year until the school reached full capacity serving 515 students in grades 6-8. In 2016, the school proudly promoted its first graduating class of 8th graders to high school. AJBT is committed to serving all students in our community to ensure they are prepared for college, leadership and life. We have built a strong reputation in our community in which we do things differently. We set high expectations and the cornerstone of our school is a strong student and staff culture that is centered on restorative practices to address the academic and socio-emotional needs of our students. The school is located in South Central Los Angeles in the Watts community, an urban area densely populated with primarily single-family units. The 2021 Census Reporter indicates that the median income of our community is \$47,682 for an average household size of 4 people in comparison to California which is \$84,097. Approximately 58% of residents have some high school or have graduated from high school. Less than 10% graduated from college with a bachelor's degree or higher. AJBT predominantly serves students who are Latino (86.4%) or African American (12.6%) with 93.1% of our students qualifying for Free/Reduced Meals. 13% of students at AJBT receive accommodations and modifications to their academic program as dictated by their Individualized Education Plans. A quarter of our students (25.9%) classify as English Learners (EL), which is 7% higher than our district's average EL population.

Reflections: Successes

A description of successes and/or progress based on a review of the California School Dashboard (Dashboard) and local data.

At AJBT we are proud that our suspension and expulsion rates for all students remain very low, thus JBT scoring "Very Low" on the California School Dashboard. Our work regarding Restorative Practices, Culturally Responsive Teaching and Trauma-Informed Care has

made a considerable impact on reducing our suspension rates for all subgroups. In addition, our 2022-23 Local Control Accountability Plan for Ánimo James B. Taylor Charter Middle School Page 12 of 82 Empowered Reading program, coupled with our focus on complex, gradelevel texts in core classes and strategic interventions in literacy enrichment and intervention classes has been a key driver of reading achievement for our students, as evident by our ELA Reading Inventory growth. Consistent with our school wide focus on Empowered Reading, there has been significant growth in reading as measured by Universal Read 180, our literacy intervention curriculum assessment, Reading Inventory (RI). It is administered school-wide 3 times per year to measure progress of all students toward and beyond grade level proficiency in reading via Lexile score.

We are very proud of our English Language Student's, as they performed in the "High" indicator on the CA Dashboard as 54.4% have made significant progress towards English Language Proficiency as compared to California state at 50.3%. We anticipate continued growth both in Lexile and in SBAC performance for our English Language Learners as a result of their participation in Empowered Reading, including for some a differentiated Empowered Reading class with more explicit reading instruction. We are also seeing continued success in our family engagement surveys. We continue to meet our goals around families that recommend our school to others.

Reflections: Identified Need

A description of any areas that need significant improvement based on a review of Dashboard and local data, including any areas of low performance and significant performance gaps among student groups on Dashboard indicators, and any steps taken to address those areas.

Ánimo James B. Taylor Middle School was identified as an ATSI school. The Dashboard data reflected a need to focus on three major areas: ELA Proficiency (Low), Math proficiency (Very Low), and chronic absenteeism (Very High) for all students. While we acknowledge that the effects of the pandemic have been significant and long-lasting and our students are entering our school with below grade level in Math and English, we continue to pour resources into these resource inequities in order to accelerate our impact and increase student achievement. As a result of these efforts we are proud to see that JBT students have demonstrated significant growth in both ELA and Math within our internal reading and math data, although their progress is not transferring over into proficiency on SBAC assessments at the rate in which we expect. To address the resource inequities of learning for our students in Math, we continue to:

target support for students in our Math Foundation classes based on proficiency levels. This allows teachers to hone in on the foundational skills absent and intensify the instruction.

transition materials to a virtual space to make learning more accessible by using Nearpod, Geogebra and Desmos platforms.

strengthen our High Impact Tutoring Program which is embedded within the school day and uses a pull out small group instruction model to differentiate for groups of 2-4 students with similar targeted needs based on their iReady data.

implement the Illustrative Math curriculum with fidelity, leveraging built in strategies in order to address grade level standards at the appropriate level of rigor

provide push-in support for students with IEPs with two one-on-one instructional aides.

leverage strategies that consistently increase academic discourse and ultimately reducing the teacher: student talking ratio (supports EL students)

In ELA, we continue to:

engage in interdisciplinary collaboration with our ELA, Special Education, and History departments. During these cross collaborative sessions, teachers calibrate on grading, rubrics, and alignment to CCSS literacy standards.

increase our focus on student engagement and student voice. Teachers continue to hone in on strategies to increase student engagement such as frequent checks for understanding as well as providing students with rapid feedback in order to set students up for success and create multiple opportunities to demonstrate mastery of grade level standards. Students are given multiple opportunities to collaborate with their peers and justify their solutions with evidence from their learning.

utilize our Push-in support model that allows for 3 case carriers and one Instructional Aide to provide push-in support to SWD in math, ELA, and history and science classes as well as providing small group testing support. Students with more significant needs receive support via an Academic Success course with a reading and writing instructional focus.

We continue to focus on the barriers that exist that prevent students from attending school by making personal phone calls to our chronically absent students, speaking with them about their challenges, and then connecting them with services or removing barriers that prevent them from attending classes. The slight reduction we have observed recently may be, in part, due to setting interventions in place such as Chronic Absenteeism team of counselors, admin, and office staff who meet biweekly to set up parent meetings and home visits (2023). The team also works with teachers and staff to plan student culture activities and events that allow students to feel connected and engaged in the JBT community. In addition, the team has led focus groups to learn more about the barriers that remain and the long lasting impacts of chronic absenteeism on student attendance. Admin also discusses chronic absenteeism with families during parent meetings such as Coffee with the Principal and our School Advisory Council to solicit meaningful feedback from parents. We continue to funnel resources to our JBT students and community in order to combat this national educational challenge.

On the 2022 CA Dashboard, the school received a status of "Not Met" for all 5 local indicators. The school presented its findings regarding the local indicators to the public and Green Dot's governing board. The local indicators were approved, along with the LCAP, by the Green Dot board on June 24, 2022. The school did not submit the local indicators by CDE deadline, therefore receiving a status level of "Not Met." The school is continuously working to meet the local indicators of basic: teachers, instructional, materials facilities; implementation of academic standards; parent and family engagement; local climate survey; and access to broad course of study.

Based on our LCAP and despite the long lasting effects of the pandemic, James B. Taylor is proud to have met many of our LCAP goals in the following areas:

Most areas met in Goal 1 around having credentialed teachers and offering a broad range of courses.

Our subgroups are making progress on the SBAC in both ELA and Math and increasing their proficiency. We have met some of our metrics in Goal 2B by increasing the percentage of SBAC students who scored proficient or above in ELA in 3 or our subgroups and 2 of our subgroups met this metric in Math. Our 8th grade students met the LACP goal around increasing proficiency on the CAST Science Assessment, including 3 of our subgroups: African Americans, Latino, and socioeconomically disadvantaged. Our Emergent Bilinguals increased the percent of students growing at least one ELPI level or maintaining the highest ELPI level based on ELPAC testing by 3% per year or be at/above 2018-19 local district ELPI rate.

We have also met all goals in Metric 4C and 4D by significantly reducing suspensions and expulsions. We were able to do this by building upon our restorative program that uses a progressive system to attempt to correct the behavior opposed to automatically issuing consequences such as suspensions/expulsions.

We have met the majority of Goal 5 by working with all educational partners, especially our parents, to ensure their voices are heard through multiple avenues of parent participation.

Engaging Educational Partners

A summary of the process used to engage educational partners and how this engagement was considered before finalizing the LCAP.

During the 2022-23 school year, the School used several outreach strategies to engage with educational partners on the LCAP and ATSI plan. The School Advisory Council ("SAC") has reviewed goals, outcomes data, and expenditures data at multiple points throughout the year. The School's efforts began in the fall of 2022 when the School Principal, Mrs. Diggs, and Operations and Finance Manager, Mr. Hulmaro Augustin, reviewed the data with the SAC. Since the first SAC meeting, Mrs. Diggs referred to the plans goals during subsequent SAC meetings to ensure the LCAP and ATSI plan were kept top of mind. The SAC is composed of administrators, teachers, counselors, classified staff members, parents and students. The SAC also includes representation from the Asociación de Maestros Unidos, the union that represents Green Dot's certificated staff.

The Green Dot Public Schools Home Office ("Green Dot Home Office"), including members of the Education, Knowledge Management, Policy & Public Affairs, Finance & Accounting and Operations teams, provided the School with updated data for each goal to help monitor and track progress. Mrs. Diggs reviewed the updated data with the SAC and reflected on changes from the previous year.

The school also utilizes other meetings, including "Coffee with the Principal" on a monthly basis. These meetings provide parents the opportunity to provide feedback and recommendations on the LCAP and ATSI plan.

In conjunction with the different educational partners groups, the Green Dot Home Office worked with School Leadership to update the 2023-2024 LCAP. The 2023-2024 LCAP was presented to the School Advisory Council during the February meeting. The SAC reviewed the LCAP and provided feedback. In the May SAC meeting, the School Advisory approved the 23-24 LCAP.

The School LCAP was presented to the Green Dot Governing Board in June for final approval. The LCAP was submitted to the Authorizing School District and the Los Angeles County Office of Education in June. The Green Dot Home Office, School Leadership and SAC will regularly monitor and evaluate progress made towards the School's LCAP goals.

A summary of the feedback provided by specific educational partners.

Overall, JBT parents and educational partners in the community feel connected to the school and expressed that the school has provided a college going culture for their students. Our parents and families also value mental health support available on campus as well as the additional academic support provided such as tutoring services and instructional aids. It is imperative that we continue to offer these services and/or increase these specific services. Lastly, parents also value security on campus as safety is of the utmost importance.

A description of the aspects of the LCAP that were influenced by specific input from educational partners.

Our LCAP plan includes our approach to using standards aligned and Green Dot vetted curriculum, professional development, and monthly observation and feedback as ways to support teachers in accelerating student achievement. Funding has been used to increase our counseling team to two as well as a student support specialist who focus on students support and well-being as well as supporting academically. This year parents also discussed their desire to learn ways to better support their children. As a result, we were able to partner with PIQUE, a program designed to support parents with understanding how to support their students' education. There are also parent classes (PIQE In April) that teach parents how to navigate and support their students. Parents discussed the importance of instructional supports for their students so we have hired an additional aide to support in the classroom. In addition our teachers have shared a desired for more differentiated Professional developments so we have partnered with the Lavinia group to provide that differentiation they needed to support their instruction.

- 100% of teachers were appropriately credentialed in the subject areas.
- 100% of ELA and Math teachers had access to standards-aligned materials though online curricular resources on the internal platform.
- 100% of courses offered have been approved through the Green Dot Course Catalog.

The supports we provided to meet Goal 1 were effective. By following the systems we have in place for personnel hiring, reviewing and maintaining high standards in curricular offerings, we were able to meet these goals at 100%.

The area where we did not meet our goal was in facilities where we were aiming for 90% satisfaction rate on the Green Dot facilities survey and fell short at 86%. We have been working to improve any challenges that come up with our facility by working with the Green Dot Facilities teams to quickly submit work orders and follow up to ensure that issues such as air conditioning that needs repair are fixed in a timely manner.

A description of any changes made to the planned goal, metrics, desired outcomes, or actions for the coming year that resulted from reflections on prior practice.

With regards to Goal 1, we are not intending to make any changes to our programs and supports to meet this goal as we are experiencing success in these areas and intend to continue our work in order to maintain our 100% success rate. To increase our Green Dot Facility Survey rates, we will continue to collaborate with our Green Dot team to ensure that our building is being maintained with the highest standards in a timely manner.

There was a change made to Goal 1 – Description, Metric 1B – Students will have access and be enrolled in a broad course of study, and Actions 1.3 – Academic – Master Scheduling & Staff. "PE for high school students" was removed from the goal description, metric, and action. "PE for high school students" was listed as an example, but it is not reflective of current courses offer to our middle school students. We will continue to offer a variety of courses to our students to help them succeed in college, leadership, and life.

Goal Analysis [2022-23]

An analysis of how this goal was carried out in the previous year. A description of any substantive differences in planned actions and actual implementation of these actions.

While we did not meet in every area of Goal 2, we are very proud of the fact that overall, our students have shown significant growth in both ELA and Math as described below:

On average, students schoolwide met 189% of their annual ELA growth goal in 2021-22, which is an increase of 28% from the previous year, despite the long lasting impacts of the pandemic. We attribute this considerable growth to intentional intellectual planning with Common Core State Standards and a school wide focus on student engagement.

When examining subgroups, students still demonstrated considerable growth, and nearly all (statistically significant) subgroups were within 10% of their growth goal. Students with disabilities met 103% of their annual growth goal, on average, which is an increase from 74% in the previous year. We continue to work hard this year to accelerate student achievement for all, including our subgroups so that they may exceed their growth goals, moving them closer to grade level proficiency. Similarly, our Emergent Bilingual and Homeless subgroups also demonstrated more growth this year than in the previous year. We have continued to increase supports available to these students in this school year. In order to meet our LCAP goals with our Emergent Bilinguals (ELL/EB), we continue to assess them quarterly using the Reading Inventory (RI) tests and quarterly SBAC-aligned ELA benchmark exams in order to truly capture their progress and target more specific instructional supports to close the gap and increase EB achievement outcomes. In addition, all teachers engaged in 3 ELD PD sessions focused on instructional support and accommodations for EB students' present levels of performance. Lastly, we also increased our class offerings to include more EB specialized advisory classes to provide more targeted interventions and frequent check-in with their emergent bilingual teacher. We have also refocused our current chronic absenteeism staff such as our counselor and office team members to help identify barriers to these impacted subgroups' attendance. They then work in collaboration with the family to remove barriers and set goals to ensure students are attending school on a regular basis. In addition, we also strategically paired many of our subgroups of students with our High Impact Tutor who targets supports during small group pull out instruction.

On average, students schoolwide met 187% of their Typical Math growth goals in 2021-22 which is an increase of 60% from the previous year as measured by iReady, despite the long lasting impacts of the pandemic. We attribute this success to intentional intellectual planning, targeted intervention courses and an increased focus on academic language. Targeted math foundations courses allow teachers to hone in on the foundational skills absent and intensify the instruction. We have transitioned materials to a virtual space to make learning more accessible by using Nearpod, Geogebra and Desmos platforms in addition to adopting a new High Impact Tutoring Program that is embedded within the school day and uses a pull out small group instruction model to differentiate for groups of 2-4 students with similar targeted needs based on their iReady data. All teachers implemented the Illustrative Math curriculum with fidelity, leveraging built in strategies in order to address grade level standards at the appropriate level of rigor provide push-in support for students with IEPs with a

one-on-one instructional aide. Teachers also leverage strategies learned through PD that consistently increase academic discourse and ultimately reduce the teacher to student talking ratio (supports EL students). Math teachers are able to conduct multiple monthly rounds of progress monitoring within their math classes that include the teacher frequently checking in with students about their data, tracking progress and measuring/celebrating growth to increase student investment.

With this being said, there were many areas where we met our goals. We were able to meet our goals in the following areas: In the ELA SBAC, we are proud that our Students with Disabilities (SWD), Homeless Youth, and Foster Youth subgroups In the Math SBAC, we are proud that the following subgroups met the LCAP goals: African American students, Homeless Youth, and our Foster Youth.

On the CAST- Science State test, we are proud that overall, students met our LCAP goals as well as the following subgroups: Socioeconomically disadvantaged, African Americans and our Latino students.

On the English Learner Progress Indicator (ELPI levels) on the CA Dashboard, we are proud that we met our LCAP Goals with 55.4% of our students making progress towards English language proficiency.

We were not able to meet our goals in the following areas:

For ELA SBAC: we did not meet our goal as a whole. Our student subgroups that did not meet their targeted goal were Socioeconomically disadvantaged students, Latinx students and EL students.

For Math SBAC: we did not meet our goal as a whole. Also, the following student subgroups did not meet their targeted goal -

socioeconomically disadvantaged students, Latinx students and students with disabilities.

For CAST: our emergent bilinguals, and students with disabilities did not meet the targeted goal

While some subgroups demonstrated growth on our internal assessments, our initiatives were not as effective as we would have liked them to be. Our students' growth did not translate into proficiency on the ELA SBAC and as a result we will continue to work to accelerate achievement outcomes for all students. In collaboration with our Area Superintendent and our School Leadership Teams, we revised our school vision and created goals within our Schools Improvement Plan that were reflective of the team's observations and findings of our critical areas of growth, LCAP, and student data. Outlined in our plan, we identified the following goals to support student growth and achievement:

- Rigorous standards-based curriculum will be used with fidelity in every classroom coupled with highly-effective teaching practices that are culturally relevant and Antiracist.
- Increased focus on standards through Intellectual Prep and planning
- Standards Institute- teaches educators how to plan grade level, engaging, affirming and meaningful lessons.
- Lavinia Partnership, who has a clear focus on increasing student outcomes
- CCEJ Collaboration- nurtures a restorative culture of reflection and growth
- Overcoming Racism/EPOCH Training to support anti-racist practices
- One on one coaching focused on data analysis and lesson planning

JBT Teachers will collaboratively engage in student work data analysis to adapt lesson plans based on student needs (data driven instruction):

- One on One Data Meetings
- Co-Planning and Observations
- Peer Observation Protocol Cycles via PD

There was a change made to Action 2.3 – Special Education. During the pandemic, students with disabilities had access to transportation in order to provide services per their Individualized Education Plan (IEP). Transportation was provided for students with disabilities because in SY 2020-21, distance learning was in full effect, and these students needed access to IEP services. Since the pandemic, SY2021-22 was the first full year of in-person instruction and IEP services were provided on campus.

For Action 2.4 - High Achieving Students, middle school students are not automatically enrolled in AP courses. This was an in-house error when updating the LCAP. The error was fixed by describing current practice for our high achieving middle school students. Students whose data reflects achievement above grade are supported through differentiated instruction in the classroom.

For Metrics 2F and 2G, the CORE data for ELA and Math is not available for the 2021-2022 school year. CORE data will be available for middle schools this upcoming school year.

Overall, the actions and services were implemented as described, and have been effective in ensuring our students are prepared for college, leadership, and life.

JBT's goals were to maintain a high Average Daily Attendance ("ADA") rate, decrease student chronic absenteeism rate year-over-year or reduce its school wide chronic absenteeism rate to 10% or less, decrease suspension rate year-over-year or reduce its school wide suspension rate to 5% or less, and maintain a low annual expulsion rate. The way we have implemented this goal into actionable steps is by ensuring that attendance is taken daily and tracked via Power School (Green Dot's student information system), maintaining daily communication with parents to inform them of student absences and/or tardies, holding monthly parent workshops on campus via zoom and in person which often includes updates on student attendance rates for the month and chronically absenteeism. We are proud to have met the LCAP goals in the following areas:

- We have met our Average Daily Attendance Goals in all areas, including our subgroups such as Socioeconomically Disadvantaged, Latino Emergent Bilinguals (EL student's), Homeless Youth, and our Foster Youth.
- We are also very proud to have met out LCAP goals in our Suspension and Expulsion rates in all categories and in all subgroups

Areas where we did not meet are as follows:

- Although we were very close, we did not meet in the Average Daily Attendance with our African American students (81%) and our Students with Disabilities (89%).
- We also did not meet our goals in the Chronically Absent indicator school wide which also includes all subgroups.

Due to the long lasting impacts of COVID, it has been extremely difficult to decrease chronic absenteeism with such high rates of our students and families being impacted by COVID, mental and physical health, food instability etc. We have refocused our current Chronic absenteeism staff such as our Counselors and office team members to help identify barriers to student attendance. They then work in collaboration with the family to remove barriers and set goals to ensure students are attending school on a regular basis. We also have a School Culture team (designated group of teacher leaders) and African American Achievement Lead teachers charged with analyzing attendance data, developing professional development and supporting school-wide policies to create a safe and civil environment and restorative community for staff and students. Overall, the actions/services were implemented as described in the previous year's LCAP and the school was only partially effective in impacting attendance.

JBT is now working to increase interventions around chronically absenteeism to include things like home visits, as well as incorporating frequent SART meetings with our chronically absent students and families and plan additional opportunities to engage our families in attendance during our monthly Parent meetings in the next school year. The school will continue to collaborate with the chronic absenteeism team members across the district, attendance clerk, parent coordinator, and counselors during our biweekly attendance meetings to further analyze the barriers that continue to exist amongst these subgroups and provide the support and resources needed to increase our attendance data amongst our students and subgroups as well as continue to target our outreach to students through daily phone calls, parent conferences and home visits. Lastly, we have started implementing monthly student surveys that elevate student voice and provide a pathway to increasing student attendance data outcomes.

In order to surpass this goal, we conducted 8 SAC meetings with at least 2 parents to serve on the School Advisory Council ("SAC") where we consistently discuss our LCAP goals. During these meetings, we are able to reflect, prioritize, and determine school-wide strategic planning for the upcoming year. They also monitored progress on current year strategic plans. In addition, the LCAP is included in our agendas for Coffee With the Principal so that parents are able to understand and provide the admin team with input, feedback, and suggestions for improvement that meets the needs of their children.

Teachers also give input by department and through grade level teams on instructional priorities. Our School Culture team provides oversight for the "Focus on School Culture" goals. The Instructional Leadership Team reviews the "Proficiency for All" and the "Preparation for College, Leadership, & Life" goals.

As a result of the educational partner engagement, the school also made the following changes:

- Updated anticipated measurable outcomes to better align with available data
- Supplemented the Proficiency for All Goal (with new activities, services and expenditures to support the School in meeting all LCAP goals and targets
- Prioritized emphasis on student growth by adding growth measure to Proficiency for All Goal

Due to our level of parent engagement, we were proud to receive a 95% score on the Survey Question: "Would you recommend this school

to a friend?" on the Green Dot Family survey.

Overall, the school was effective in implementing the services to meet its parent, student, and community engagement goals. Parents and educational partners have many opportunities to be active participants in their child's education. JBT holds consistent SAC and DELAC meetings throughout the year. Parents are able to give feedback on programmatic needs, budget, instructional initiatives, and LCAP. Consistent parent engagement attributes to a vast majority of JBT parents recommending the school on the annual educational partner survey.

Actionable steps we took to accomplish parent engagement was by having over 15 parent events each semester such as Coffee with The Principal, Monthly DELAC Meetings, SAC meetings, Middle School Monday Orientations, Back to School, and Student Led Parent conferences. Overall, the actions/services were implemented as described in the previous year's LCAP and the school was effective in implementing the services to meet its LCAP goals.

We added metric 5E-Parent Participation to capture the participation of all parents, including parents of our unduplicated students. Parents are engaged through various activities such as SAC, DELAC, Coffee with the Principal, Back to School Nights, Open House, Parent Conferences, Professional Developments and other school activities. For this metric, the school did not meet the goal. COVID-19 had a tremendous impact on social gatherings. Since our return to in-person instruction and meetings, parents have been hesitant to participate in meetings due to the fear of COVID. The school is currently exploring hybrid avenues for parent meetings. The school wants to provide parents with the opportunity to join meetings in-person and online. Also, the school is exploring tools to centralize parent sign-in for meetings. The school currently uses a mixture of online forms and paper-forms to capture parent sign-in. The school will continue to explore tools and programs that can centralize parent participation data. The school is committed to improving and capturing its parent participation in school activities.

Required Descriptions

For each action being provided to an entire school, or across the entire school district or county office of education (COE), an explanation of (1) how the needs of foster youth, English learners, and low-income students were considered first, and (2) how these actions are effective in meeting the goals for these students.

Given the high percentage of unduplicated pupils at the school, the funds will be spent on improving the charter-wide educational program and meeting the academic goals specified earlier in the LCAP. The needs of low-income students are largely met based on the charter-wide educational model, with additional services provided for foster youth and Emergent Bilinguals. In order to meet the needs of its diverse student population the school will implement Green Dot's academic model with fidelity.

The model outlines the framework that allows Green Dot teachers and administrators to be successful and focuses on four key elements: 1) Ensuring Quality Teaching and Instruction, 2) Cultivating a College-going Culture, 3) Eliminating Barriers to Learning, and 4) Promoting Leadership and Life Skills. Implementation strategies are provided in the areas of curriculum, student intervention, professional development, parent participation and school operations to help principals and teachers make the most informed decisions for their schools.

1. Ensuring Quality Teaching & Instruction: Dedicated, effective teachers with a passion for their work and their students are at the heart of the Green Dot model. Green Dot ensures high quality teaching and instruction in every classroom through its research-based methods of instruction, teacher effectiveness initiatives and robust professional development and support. The College-Ready Teaching Framework

("CRTF") – a rubric that defines the core competencies expected of all Green Dot teachers is the foundation of the evaluation system. In addition, teachers will be able to pursue professional development and coaching support from the Instructional Coaches as well as from the Green Dot Home Office Education Team.

2. Cultivating a College-going Culture: Green Dot strives to attain high college acceptance rates by creating a culture of college-for-certain. School leaders create systems for ongoing academic counseling with counselors and advisors and offering college tours at every grade level. In addition, the school master schedule offers elective courses that support core content development (i.e., drama), as well as pre-AP pathways (i.e., honors courses in high school). Courses are structured to build students' key cognitive strategies: intellectual openness, analysis, reasoning, accuracy and precision, and interpretation. School classrooms demonstrate the successful implementation of behavior management strategies. Support is provided to build key behaviors necessary for success in high school and college, such as self-monitoring, persistence, independent preparation abilities, and college-level study skills. Lastly, all Green Dot schools provide support to build students' contextual awareness of college systems and culture.

3. Eliminating Barriers to Learning: Students come to Green Dot from a variety of backgrounds. Academically, many are far behind gradelevel. Socially and emotionally, many require emotional guidance in order to be able to succeed academically. Green Dot strives to provide the academic intervention, counseling and clinical services necessary to break down these barriers. Green Dot school leaders successfully implement all three tiers of the Multi-Tiered System of Supports by appropriately providing intervention in Literacy, Math, English Language Development and Special Education. Green Dot schools offer an Advisory program that provides academic guidance, school culture & safety; college and career; and personal development. Additionally, each school provides a menu of wrap-around services: mental health supports and psychological services; counseling groups; mentoring programs; supports for foster youth and students experiencing homelessness; and links to community partners for health and wellness programs.

4. Promoting Leadership & Life Skills: Green Dot aims to provide students with a broad set of tools, behaviors and skills to prepare them for college and beyond. Systems for student leadership such as student government, student ambassador program, student mentorship, and the Principal's Advisory Committee give students internal leadership experience. External experience is available through partnerships with community programs, including public speaking opportunities, job shadowing, volunteer work, mentorships, and summer internships. Advisory programs teach and promote life skills and help to reduce dropouts, foster youth development, enhance academic achievement, and promote whole-being development.

A description of how services for foster youth, English learners, and low-income students are being increased or improved by the percentage required.

"The schools' educational program will successfully meet the needs of its foster youth, Emergent Bilinguals and low-income student population. Examples of theses supports include:

- Implementation of all three tiers of the Multi-Tiered System of Supports in Literacy, Math, English Language Development and Special Education
- Intensive interventions for students requiring additional enrichment and support, including Literacy Enrichment, Math Foundations, individualized tutoring, classroom push-in and co-teaching models and small strategic groupings
- An Advisory program for all students to prepare them with the tools and behaviors to succeed in high school, college, leadership and life – covering topics such as: academic preparation, promotion of college awareness, developing strong peer relationships, developing life skills in areas such as resilience/grit, growth mindset, organization, communication, health/nutrition and personal finance
- Integrated wraparound services to help address social and non-academic barriers to student learning including small group counseling and individual student counseling. Foster youth and students experiencing homelessness are provided services and supports tailored to their individualized needs including uniform and transportation assistance and navigation to community resources such as housing, food, and mental health services.
- Proactive and positive student behavior management, including various alternatives to suspension
- Opportunities for students to explore student leadership and other interests through participation in elective courses, student government, after-school programs and clubs
- Special education programs that cultivate collaboration between general and special education teachers to guarantee that students with disabilities are integrated into the school to the maximum extent possible to allow them full access to all programs.

The school has developed a research-based curriculum appropriate to the student demographics it serves that includes the following: course offerings, textbooks, curriculum maps, pacing guides, sample lesson plans, interim assessments and intervention programs. The model is derived from the following continuum of research-based practices:

• Planning and Preparation: Based on Essential Elements of Effective Instruction by Madeline Hunter. Madeline Hunter developed the teacher "decision-making model" for planning instruction known as Instructional Theory in Practice ("ITIP"). This approach to

teaching uses Direct Instruction ("DI") as the framework for planning. DI refers to a rigorously developed, highly scripted method that is fast-paced and provides constant interaction with students.

- Assessment and Learning: Based on Understanding by Design: Backwards Design by Jay McTighe and Grant Wiggins. The emphasis of Understanding by Design ("UbD") is on ""backward design,"" the practice of identifying the desired outcomes in order to design curriculum units, performance assessments and classroom instruction that will enable students to achieve these outcomes. The backward design approach is developed in three stages. Stage 1 starts with educators identifying the desired results of their students by establishing the overall goal of the lessons by using content standards, common core or state standards. Stage 2 focuses on evidence of learning by assessment. Teachers plan performance tasks and evidence of understanding. Performance tasks determine what the students will demonstrate in the unit and what evidence will prove their understanding. This can include self-reflections and self-assessments on learning. Lastly, Stage 3 lists the learning activities that will lead students to the desired results.
- Instructional Techniques: Based on Teach Like a Champion by Doug Lemov. Teach Like a Champion offers effective teaching techniques to help teachers become champions in the classroom. Additional details provided in the section entitled "Instructional Design, Methods and Strategies."
- Classroom Environment: Based on "Safe and Civil Schools" by Randy Sprick. Safe & Civil provides high-quality programs and staff
 development services to help educators create proactive and positive behavior management strategies in schools. In addition, a
 focus on Restorative Practices provides schools with the resources to build community amongst staff and students. School site
 walk-throughs with administrators, teacher leaders and members of the Green Dot Home Office Education Team are scheduled
 regularly to observe discipline and school culture. Findings from these sessions are compiled to create school-specific professional
 development for teachers and the necessary support to create an environment where students can learn and where teachers can
 teach.
- Culturally Responsive Pedagogy: Green Dot Public Schools believes that culturally responsive pedagogy can increase student engagement, provide access to content, and as a result, bolster feelings of confidence and understanding in students. School leaders and teachers have read Zaretta Hammond's Culturally Responsive Teaching and the Brain and use her Ready for Rigor framework to work towards a culturally responsive classroom experience for all students.

Academic Support and Intervention is based on incoming student need and a schedule of intervention and acceleration courses will be available to students so that all students can complete the required courses:

- Summer Bridge: Summer Bridge is a recommended multi-week summer program that acclimates students to the culture of the school, high expectations and the development of a trusting community. During the Summer Bridge program, students will also be identified for special needs, English Learner levels, non-proficiency in standards and social-emotional supports, and staff will make the necessary adjustments to the master schedule to better accommodate them. Students receive standards-based instruction in Math and English Language Arts and are acclimated to the culture and expectations of the school. Students will engage in culture-building exercises that promote a positive community of trust and respect. Social and personal issues will also be surfaced in small group settings complemented with educational field trips.
- Literacy Intervention/Enrichment (Read 180): Literacy Intervention/Enrichment is a standards-aligned program for reading that is provided to students that test low in reading. Typically, this course is given to students through an elective class.
- Math Foundations: Students who are struggling in Math (not proficient and/or recommended by their Math teachers) will receive an additional period of Math support, where their teacher and tutors will work on skill building through their current curriculum, as well as remediation strategies to strengthen skills in group tutorial and one-on-one formats.
- Designated and Integrated English Language Development (ELD): Designated ELD classes are provided for all English Learner students and Integrated ELD is provided in all other content classes throughout the school day for Emergent Bilinguals. Designated ELD focuses on listening, speaking, reading and writing skills in English with the CA ELD Standards and Features of Designated ELD driving instruction. Integrated ELD focuses on academic content and English language skills in tandem so that Emergent Bilinguals practice English language skills with academic content in all classes.
- Special Needs/Academic Success: Designated SPED students will be provided extra support to reflect the needs outlined in the Individualized Education Plan (IEP) and in all of their academic courses through one-on-one instruction, group support and guided instruction.
- Homework Club: Students who are struggling with a particular class or want more support in a subject can attend Homework Club, which is offered an hour every day after school and run by a credentialed teacher and/or college interns.
- Office Hours: Teachers hold office hours twice a week before and after school to provide additional support.
- After School Program: Students who are not achieving a satisfactory grade within a particular class or simply want more support in a subject can attend tutoring, which is offered for an hour every day after school.

Social and Life Skills Development is a key component of the school meeting the diverse needs of its student population including the establishment of an advisory course and clinical services available to all students.

Students will participate in an Advisory class with the same group of students for their school career to maintain a tighter sense of community. Advisory serves as a structured time and space for students to reflect on their learning and to discuss the connection between learning and life-long success. Advisory activities are organized around four pillars: 1) school culture and safety, 2) academics, 3) social life skills and 4) civic engagement. During Advisory, students will:

- Discuss issues related to the pressures of being a young adult including but not limited to puberty, relationships, mental health, family, substance abuse, etc.
- Acquire different study skill strategies, test-taking strategies and communication tools that will enable them to succeed in their academic career.
- Learn about the college process as they are encouraged to think beyond middle and high school in an effort to realize that the tools they gain today will be beneficial in the near future
- Gain self-efficacy skills that will allow them to address the barriers of learning with resiliency

We have built an Advisory course into the master schedule to serve as a level 1 intervention using the Multi-Tiered System of Supports(MTSS). Using the MTSS, all students receive the core literacy and math courses as their Tier 1 instruction. In addition to the core courses, students who need more intensive intervention (Tier 2) and support with a lower student-to-teacher ratio are provided with math and literacy interventions classes. If the student continues to struggle, the Grade Level team will determine if there are specific individual interventions (Tier 3) necessary to address the student's needs or if a referral to the Student Success Team is required.

Our Clinical Services team provides individual, group and family therapy to the students and families, and serves as a Tier 2 and 3 intervention within the MTSS Framework. The main purpose of our clinical services program is to address the barriers to learning from the mental health perspective. In addition, we provide crisis intervention, parent consultation, teacher consultation, and case management which include providing resources and referrals to outside agencies.

In order to ensure services are provided free of charge, services are provided by pre- and post- graduate Marriage and Family Therapy, Psychology and Social Work interns who receive extensive training and supervision in exchange for their work. All services are supervised by one of our licensed Marriage and Family Therapists or Licensed Clinical Social Workers. Interns provide social and emotional counseling including small group and individual therapy.

The School Mental Health Services team uses a referral process for students to receive services. Once students and parents have consented to services, students will work with a School Mental Health Therapist or School Mental Health Intern (under the supervision of a Licensed Mental Health provider) that follows them through the process of services, and provides mental health services. Students are provided with assessments that measure symptoms of depression, anxiety, & trauma, along with other evidenced-based interventions during clinical psychotherapy. The School Mental Health Services team works with parents, staff, and students throughout the referral process to ensure they are aware of their options. School Mental Health Services provides a proactive approach to addressing the barriers of learning by utilizing prevention and wellness to enable our students to possess the necessary skills to navigate their academic and social skills.

The school will improve its entire educational program by investing in additional technology to increase its ratio of students to computers, additional special education services to support high needs students, and instructional material to increase support for classroom learning experience.

- The school will offer a spectrum of special education services that may include a resource program and special day program. The programs are designed to foster a high-quality program for students with special education needs. Additionally, our special education programs cultivate collaboration between general and special education teachers to guarantee that students with disabilities are integrated into the school to the maximum extent possible to allow them full access to all programs.
- The school will offer ELD courses to prepare Emergent Bilinguals recently arrived in the U.S. for success in English-medium instruction, including English Language Arts. Skills in all four strands of language listening, speaking, reading and writing are systematically developed. Students of mixed grade levels are grouped according to proficiency in English. Cultural knowledge needed for success in U.S. schools is integrated throughout. The Green Dot EL Master Plan includes the new CA ELD standards and a five step process for the identification of Emergent Bilinguals including: 1) Initial Identification, 2) EL Proficiency Assessment, 3) Primary Language Assessment, 4) Parent Notification, and 5) Program Placement. Green Dot schools provide on-going training for administrators and teachers on the identification process.
- All Emergent Bilinguals students are served in both Designated and Integrated ELD designed to meet their needs. Instruction is based on the CA ELD Standards and the Features of Designated and Integrated ELD. These programs are built into the school's

master schedule and take place within the school day. The school will work with the Human Resources (HR) Department to ensure appropriate staffing and authorizations for teachers in these courses.

• Technology is widely used at the school to drive higher levels of achievement and prepare students for the information driven economy of the 21st century. It is also used as a critical tool for gathering data for school management.

Technology investments will be made in the following areas:

- Increased computing devices (e.g., desktops, laptops, Chromebooks) that are available for student use;
- Each teacher is provided with a laptop and given training on effectively using technology in the classroom;
- · Courses often include web-based research projects and assignments;
- Technology elective classes are included in the recommended curriculum to train students on computers and different software programs; and
- A web-based student information and school management system is implemented at the school and used by parents, students and school staff "

A description of the plan for how the additional concentration grant add-on funding identified above will be used to increase the number of staff providing direct services to students at schools that have a high concentration (above 55 percent) of foster youth, English learners, and low-income students, as applicable.

The LEA received additional concentration grant funding due to its high percentage of unduplicated pupils, which is well above the 55% threshold for receiving these funds. The LEA has utilized the additional concentration grant add-on funding to hire and maintain staff at the school who provide direct services to students. We have used these funds to provide high impact tutoring services through the hiring of instructional aides, as well as to hire additional staff such as clinical supervisors, a homeless youth coordinator, attendance case managers, African American Support Specialists, push-in substitutes, and additional support staff to address the ongoing impact of COVID-19. Retention efforts for existing staff include increased mental health supports and additional professional development opportunities.

Goal 2, Actions 2.1, 2.2, 2.5 and 2.8 address this requirement, as well as Goal 3, Action 3.1, and Goal 4, Actions 4.1 and 4.2.
