





# Plan Summary [2023-24]

#### **General Information**

A description of the LEA, its schools, and its students in grades transitional kindergarten-12, as applicable to the LEA.

Ánimo Jackie Robinson Charter High School (AJR) is a member of the Green Dot Public Schools California network. We founded our school in July 2006 with a mission of transforming the way young adults are educated in the inner city of South Los Angeles. Green Dot Public Schools is a Charter Management Organization (CMO) that operates twenty-seven public secondary schools in Los Angeles, Memphis, and Tacoma, serving over 12,000 students across the nation. Green Dot is a non-profit organization that seeks to transform public education in historically-underserved urban communities in order to provide students with increased access to a rigorous college-prep education. In doing this, Green Dot's mission is to ensure that all students graduate prepared for college, leadership and life.

Our school community is situated just east of the University of Southern California. To date, we have had twelve graduating classes of approximately 150 students each. Our current enrollment is approximately 604 students in grades 9-12. Demographically, we serve a population of low income minority students, most of whom will become first generation college students. Our population is 91.4% Latinx and 5.9% African American, with over 95% of students qualifying for free and reduced lunch. We have one student who identifies himself and part Causian and part Thai and one Native American student. This school year, 14.5% of our student body has special needs, and 13.8% are English Learners.

Our school is a Proposition 39 school, co-located on the campus of William J. Clinton Middle School, a Los Angeles Unified school. Throughout various staffing changes, we continue to work to establish a positive, cohesive relationship with the staff and students at Clinton MS. Collaboration between Clinton MS and our school continues to grow. Through Prop 39 meetings and creative PD we focus on developing our relationships and furthering our collaboration and consistency in an effort to support our community on a united front. Together both Clinton and AJR put our students first because a majority of AJR students attended Clinton during grades six, seven, and eight, and we serve the same families. AJR offers a comprehensive college-preparatory academic program. All students are enrolled in courses that meet the A-G requirements for the California State University/University of California college systems. In the 2020-21 school year 89% of our students graduated A-G ready. In the 2021-22 year we had 81% of our students graduate A-G ready. We offer a significant number of Honors and AP courses to our advanced students in an effort to increase their college-readiness, as well as increasing our summer enrichment courses for underclass students. We also offer a comprehensive Special Education program and a substantial intervention program for struggling learners, including a comprehensive EL program of designated and integrated EL courses for our English Language Learners. We pride ourselves in the fact that we have established a safe, nurturing yet challenging academic environment for all students.

Ánimo Jackie Robinson's intention is to continue to carry out our school mission to ensure that all students graduate prepared for college, leadership and life and to provide an education for our community that will equip our resilient, self-reliant, and compassionate students with the skills necessary for success in their lives. Ultimately, we want to inspire our students to become agents of change, empowered with a unique voice, critical thinking skills, and the knowledge necessary to improve the world and transform the cultural landscape.

## **Reflections: Successes**

A description of successes and/or progress based on a review of the California School Dashboard (Dashboard) and local data.

According to the 2022 California Dashboard, AJR received a status level of "high" for graduation and status level of "low" for suspension, and a status level of "medium" for ELA. In each of these areas, the school out-performed the state status levels. We have maintained a high percentage of at least 92% of students graduating from high school. 1% of students were suspended and 0% were expelled. Two years ago in 2020-21 we added new AP courses, and we are more effectively placing students into those courses in an effort to widen our net of college readiness for all. Last year in 2021-22 we added two more AP classes. This year we are supporting more students in AP classes, and our students are doing better overall in terms of their social-emotional health. In the 2020-21 school year AJR improved our cohort dropout rate by taking it down to 0%. In the 2021-22 school year we saw an increase to 5%. In 2020-21 we increased our A-G readiness percentages to 89% and, though it dropped to 81% last year, we are already seeing A-G growth again this year.

Our overall attendance rate is at least 93%, our overall retention rate of both students and teachers is extremely high. Overwhelmingly, families indicate satisfaction with the school and rate they would recommend the school, year after year. In terms of students recommending the school, we achieved 98% on the satisfaction survey. Teachers also stay at AJR, indicating that they appreciate and contribute to the positive school culture we have created at our school. We achieved a 100% in teacher satisfaction on their survey last year. These highlights indicate that we are building a learning community that is both challenging and nurturing to all our students. We acknowledge that our students and families are happy to attend our school, and our data demonstrates this with 98% of families indicating that they would recommend our school to a friend.

## **Reflections: Identified Need**

AJR's 2022 California School Dashboard report on the school's performance in Math indicates that the school has earned a status level of "Low" for All Students which is similar to the state's status level of "Low." The report shows AJR 99.3 points below standard in Math for the All Students group, which is greater than the state's average of 51.7 points below standard.. We acknowledge that the effects of the pandemic will be significant and long-lasting. We have enjoyed a significant increase in our SBAC Math scores overall in recent years, but our performance rate, although higher than local LAUSD schools,have declined for four straight years, and we know that our scores need to improve. To address this, we are continuing to use the i-Ready assessment to help teachers monitor the growth of our students at all grade levels in math and to cater the math program to meet the needs of students, who are struggling in math in their classes. Additionally, teachers are working with the Illustrative Math (IM) curriculum and continue to receive professional development and coaching from Green Dot's curriculum specialists who work one on one with math teachers to develop skills appropriate for 9-12 grade math. Teachers continue to receive ongoing professional development to support from our local CS's and our admin team, as they roll out the new curriculum.

AJR received a status level of "Medium" for the ELPI rating, which is to par with the state's status level of "medium." Although AJR's ELA rating was a "Medium" on the CA Dashboard, which is higher than the state's rating of "Low", AJR is working to improve this status level. In 2019-20 our reclassification rate was 9.6%. In the 2020-21 school year we decreased further, achieving a 5.3% reclassification rate. This is a problem we need to continue to address. In 2021-2022, we were able to bring our reclassification rate to 9.2%. We have established our own site-based EL Lead Teacher to help ensure that all our teachers are better equipped to meet the needs of our EL students and that each of our students has a specialized plan to receive support in core subject areas. Additionally, teachers will continue working with Reading Inventory, a nationally recognized program, to support English Learners in gaining literacy skills. Still, our EL students are performing at a significantly lower rate on the SBAC and in other measures of the LCAP. We are continuing to address this important issue in several ways, including professional development for our teachers to support them with integrating EL standards, language criteria and instructional strategies into their daily practice. We intend to continue this very intentional professional development in the coming years, and to integrate it with our PD that supports our teachers in rolling out their two new curricula. Our math teachers attended Illustrative Math Professional Development to incorporate language development in their courses more explicitly. Additionally, we have added 11th and 12th grade courses, ELD Curriculum Skills 11 and 12, specifically for our LTELS, in an effort to support, so that our EL students will receive more intentional support, as they prepare for this rigorous exam.

On the 2022 CA Dashboard, the school received a status of "Not Met" for all 5 local indicators. The school presented its findings regarding the local indicators to the public and Green Dot's governing board. The local indicators were approved, along with the LCAP, by the Green Dot board on June 24, 2022. The school did not submit the local indicators by CDE deadline, therefore receiving a status level of "Not Met." The school is continuously working to meet the local indicators of basic: teachers, instructional, materials facilities; implementation of academic standards; parent and family engagement; local climate survey; and access to broad course of study.

Each year we review the LCAP through SAC, DELAC and other parent meetings, as well as in teacher PD sessions. We work to align our work on the LCAP with our annual strategic planning, LAUSD Oversight planning, WASC writing and monitoring, etc. so that all our goals are in sync and we address them every year. The pandemic not only set us back in terms of our data monitoring and academic progress, but it also added new facets to our work in the form of health and safety planning and monitoring. We are confident that as we move forward into the new LCAP window, we will continue to progress toward reaching our goals.

# **Engaging Educational Partners**

A summary of the process used to engage educational partners and how this engagement was considered before finalizing the LCAP.

During the 2022-2023 school year, Ánimo Jackie Robinson Charter High School used several outreach strategies to engage with educational partners on the LCAP. Ms. Botello, our principal, reviewed the 2023-24 LCAP with the School Advisory Council (SAC). Since the first SAC meeting, Ms. Botello has referred to the LCAP and its goals during subsequent SAC meetings to ensure the LCAP is kept top of mind. The SAC is composed of administrators, teachers, counselors, classified staff members, parents and students. The SAC also includes representation from the Asociación de Maestros Unidos, the union that represents Green Dot's certificated staff.

The Green Dot Public Schools Home Office, including members of the Education, Knowledge Management, Policy & Public Affairs, Finance & Accounting and Operations teams, provided the School with updated data for each goal to help monitor and track progress each year. Ms. Botello reviews the updated data with the SAC and reflects on changes from the previous year at each meeting.

The school also utilizes other meetings, including Coffee with the Principal (CWTP), which occurs during the first Friday of every month in Spanish. We hold our Black Parent Advisory Committee (BPAC) meetings quarterly. At the CWTP and BPAC meetings Ms. Botello provides parents the opportunity to provide feedback and recommendations on items directly related to our LCAP goals. We also facilitate regular parent workshops, whose content is established directly from input from parents at both the CWTP and SAC meetings, which are driven by our LCAP goals.

In conjunction with the different educational partner groups, the Green Dot Home Office worked with School Leadership to update this LCAP, taking into account the progress identified in the Goal Analysis sections, revisions to actions/services, and updates to future expenditures. The Green Dot Home Office reviewed the SAC and DELAC feedback across all Green Dot schools to identify trends, achievements, and areas for improvement. This information was also shared with the Green Dot's Board of Directors Executive Committee on May 25, 2023, which includes the President of the Asociación de Maestros Unidos. The school's LCAP was presented to the Green Dot Governing Board on June 30, 2023 for final approval. The LCAP was submitted to the Authorizing School District and the Los Angeles County Office of Education before July 1, 2023. The Green Dot Home Office, School Leadership, SAC, and DELAC will regularly monitor and evaluate progress made towards the School's LCAP goals.

Chronic Absence update: Information shared research around the number of absences and the impact on learning, and the impact on the budget to the school. We explained the differences between excused and unexcused absences and we gave parents some strategies for changes to routines, and helped them with logging on to PowerSchool to better monitor their child's attendance. East Coast, Nor Cal and HBCU Junior College Trip parent information meetings: We met with parents and students to prepare them for the various weeklong college visits.

PIQE:

In past years we focused on helping parents understand A-G readiness, financial preparation for college, talking to a counselor, school-site specific questions. We were not able to have PIQE at school during the 2020-21 or during the 2021-22 school year, but we are going to bring it back as soon as parents can return to our school campus.

The schools used several methods to allow for educational partners to provide feedback in the LCAP process. After conducting 7 SAC meetings and 6 DELAC meetings and 15 Coffee with the Principal meetings (in Spanish and English), AJR has identified the following recurring themes to support the educational achievement of students. These themes are reflected in the sustaining goals, services, and investments of the LCAP

Themes include:

Increasing support for lower performing students Provide appropriate interventions for English Learners and Students with Disabilities, especially for ELPAC passing and reclassification Addressing the dangers of vaping on campus and across the community

Addressing chronic absenteeism

Intentional support programs for AA students with regards to the benefits of regular attendamnce; building developmental relationships with our students and leveraging them

Iproving supports for EL students; providing ESL courses for parents

Improving college-readiness for our students by educating our parents on the college application process, financial aid programs and application processes, the significance of A-G completion, SAT preparation, etc.; bringing PIQUE and other parent education programs back to in-person

Making sure to bump AP passing rates back up to what our school community considers to be our average performance

Maintaining our A-G class completion rates, our graduation rates and our low drop-out rates

Maintaining the safety of our school, both physically and emotionally and continuing to provide social emotional wellness supports

A description of the aspects of the LCAP that were influenced by specific input from educational partners.

There are several ways that parents, teachers, and students at AJR influenced the LCAP. The LCAP was included as a discussion/review point of all monthly SAC meetings so educational partners have time to understand, reflect, prioritize, and determine school-wide strategic planning goals for the upcoming year. They also monitor progress on current year strategic plans. In addition, the LCAP is included in our agendas for both Coffee With the Principal and in our Parent Workshops, so that parents are able to understand and provide our admin. team with input, feedback, and suggestions for improvement that meets the needs of their children. Teachers also give input by department and through grade level teams on instructional priorities. Our School Culture team provides oversight for the "Focus on School Culture" goals. The Instructional Leadership Team reviews the "Proficiency for All" and the "Preparation for College, Leadership, & Life" goals. In each DELAC meeting, we provided an academic update for all parents on their students' progress. We reviewed ways to support development of literacy skills and math skills at home through group readings and presentations by guest teachers. Parents helped to create and monitor our Title III budget in order to best support the needs of English Learners.

As a result of the educational partner engagement, the school also made the following changes:

Updated Anticipated Measurable Outcomes to better align with available data

Supplemented the "Proficiency for All" goal with new activities, services and expenditures to support AJR in meeting all LCAP goals and targets, especially in the area of student performance on the SBAC and ELPAC.

Prioritized emphasis on student growth by adding growth measures to "Proficiency for All" goal.

Made sure to add chronic absenteeism, especially among the Students with Special Needs, African American students and EL subgroups, to our school culture goals.

Added health concerns regarding vaping to our monthly strategic planning and goal setting/monitoring discussions.

Added Covid priorities and action steps to our school wide priorities.

Added a revisit to school lunch program

Goal 1: Provide for Basic Services Overall implementation:

AJR did not experience any significant challenges in meeting this goal during the 2021-22 school year or the 2022-23 school year. We were able to meet all the criteria of our goal with a 100% performance rate. We are a co-location school with LAUSD, so we were also able to address any facilities issues with the District.

Goal 1: Provide for Basic Services

Overall Effectiveness:

Maintained credentialed teachers--AJR met this goal with 100% performance rate. All our teachers are credentialed.

Access to standards aligned materials--AJR met this goal with 100% performance rate, as all of our teachers in our core classes use standards-based curriculum and materials.

Access to the educational program--at AJR 100% of our courses are in the high school course catalog. All our students have access to the educational program as outlined in our charter petition.

Participation in PE, VAPA and other electives offered--AJR met this goal with 100% performance rate. All our students take at least one visual and performing arts elective class, as well as Physical Education.

Keeping facilities in good repair--AJR met this goal with 100% performance rate. Our facilities are in good repair.

The supports AJR provided to meet Goal 1 were effective. By following the systems we have in place for personnel hiring, reviewing and maintaining high standards in curricular offerings, and maintaining expectations for all students to enroll in A-G courses and pass them with a C or better, we were able to meet these goals at 100%.

# Goal Analysis [2022-23]

An analysis of how this goal was carried out in the previous year. A description of any substantive differences in planned actions and actual implementation of these actions.

**Overall Implementation:** 

This is the most challenging goal to meet in the LCAP, but we have remained diligent and persistent in our efforts to meet all the criteria of this goal. Prior to the pandemic, we were not able to meet the SBAC ELA and Math criteria, nor the EL Reclassification criteria. The ELA pass rate was 52% and the Math pass rate was 24%. Since returning to in person learning, the 21-22 pass rates remained within range of the prior year, with the ELA pass rate of 50% (2% decline) and a Math pass rate of 22% (2% decline). We fell significantly behind in the reclassification data metric. During the 2021-22 year, we made some growth in our reclassification rate, from a 5.3% passage rate to a 9.2% reclassification rate, reflecting a growth just shy of 4%. This data creates an urgency in us to support our students as they recover from the Distance Learning experience and the difficult return experience of last year. It is critical that we continue the work we have done in terms of intentional, well-planned and aligned professional development for teachers in the areas of standards-based instruction and addressing the needs of ELL students and students with special needs. We must also be diligent in supporting teachers in the implementation of our new curricula and in supporting our new teachers. We must also strategically plan and implement plans to support students directly, as they prepare for these exams in both the academic areas and in the area of motivation. In terms of the SBAC, the three year gap in testing data, from 18-19 to 21-22, showed a 2% decrease in English, and a 2% decrease in Math, dropping from 52% to 50% and 24% to 22% respectively. We need to refocus our efforts on supporting our students and teachers as they prepare for these high stakes tests, while we simultaneously focus on their physical and mental health.

An explanation of how effective the specific actions were in making progress toward the goal.

Goal 2: Proficiency for All

Overall Effectiveness:

Increase SBAC proficiency (ELA and Math)--At AJR we are focusing on meeting this goal this year. Although we came up short in the 21-22 school year, and we did not meet our LCAP goal of increasing the percentage of students who score meet/exceeded, we did meet the component of our LCAP goal that calls for us to outperform the district average. Improving our overall and subgroup SBAC performance in both ELA and Math continues to be an identified area of need for us.

Increase CAST proficiency--In 2018-19 23.8% of our students met standard and 1% exceeded standard. On average compared to the state of California that year that had 20.54% meets standard, we outperformed the state average. Additionally, the state had 18% of students not meet standard, and we had 15% of students not meet standard. Last year, 19.72% met standard and 1.41% exceeded standard. Although we declined and our data was lower than the state average, our percentage of met standard was within 1% of the state (state data 20.86%)

met standard). Our science teachers are continuing to help students better understand the concepts in science, through our district curriculum as well as embedding elements of the Open Sci Ed field test, we are preparing for the upcoming exam this Spring.

Increase EL proficiency on ELPAC--this will remain an important goal for us at AJR, since the test is fairly new and challenging for our students. In the Spring of 2021 it was extremely challenging to administer this exam with the students who were still in Distance Learning. We had trouble helping them prepare for this test, determining which students could come to school to take the test in person and then administering the test online to those students who were not able to come in person. I assume that our significant decrease in scores is a direct result of these significant challenges. Last year, our ELD team was able to do more prep in their classes. Students analyzed their previous year ELPAC scores to set goals for themselves. The teachers used release material to review the writing and reading sections, two of our lower performing bands.

Reclassify EL students--due to the switch from CELDT to ELPAC, AJR experienced a significant decrease in our reclassification rates in 2018-2019. We dipped from 26% to 8%. We then decreased even further in the 2020-21 school year to 5.3%. Still, we have every intention of increasing our reclassification numbers this year and in future years, as students adjust to the demands of the new ELPAC test and as we recover from the learning loss of the pandemic. In the 2021-22 school year our reclassification rate was 9.2%. We hope to exceed our goal of increasing by 3% for next school year, so we can build back up to our CELDT numbers.

One new indicator of our ELs is the ELPI, which measures growth on the ELPAC exam. Last year 51% of our students were making progress towards English language proficiency. We shared this data with our students and had one-on-one conversations with students who did not grow or decreased last year. We hope to increase this indicator with each coming year, especially now that we have more newcomers enrolling in our school.

Increase or maintain CORE SGP (ELA and Math)--At AJR in 2018-19 we scored 81% on our CORE SGP for Math and 79% on our CORE SGP for English. This represents a dip in our scores from the year prior, where we were 99% for math and 89% for English. This performance correlates with our dip in SBAC performance. Nevertheless, these scores still represent "strong growth", which is more than an average year of growth. For the 2020-21 we have no SGP data since the students did not take the SBAC and this year's hasn't been released yet. Our goal is to increase our SBAC scores and our CORE SGP in the coming years.

This year we are implementing in-person support for SBAC administration in several areas including: training for proctors, SBAC preparation with regards to curriculum and instruction, CAST preparation for science teachers, ELPAC preparation for teachers and students and support in terms of motivation and incentives for all students for all tests. In our professional development plan we are focusing on intentional, standards-based instruction and planning for rigor and productive struggle. We are focusing on the three R's of rigor, relevance and relationships, especially through the lens of our two focus areas- academic rigor and academic monitoring. We are implementing this plan

this year as we return to in-person schooling, and we will continue this professional development in the next few years. We are confident that this will result in - at the very least - meeting our LCAP Goal #2 and hopefully increasing our scores each year moving forward.

There was a change made to Action 2.3 – Special Education. During the pandemic, students with disabilities had access to transportation in order to provide services per their Individualized Education Plan (IEP). Transportation was provided for students with disabilities because in SY 2020-21, distance learning was in full effect, and these students needed access to IEP services. Since the pandemic, SY2021-22 was the first full year of in-person instruction and IEP services were provided on campus.

## Goal Analysis [2022-23]

An analysis of how this goal was carried out in the previous year. A description of any substantive differences in planned actions and actual implementation of these actions.

#### **Overall Implementation:**

In terms of Goal 3, AJR met nearly all the metrics of our goal. We have a strong graduation rate, a strong A-G completion rate, and a low cohort dropout rate. In the 2020-21 school year our cohort dropout rate was 0%. In the 2021-22 school year, our cohort dropout rate was 5%. We have a robust set of AP course offerings as well, and we have added two new AP courses (AP Psychology and AP Drawing) in the last two years. This coming year we are adding AP Pre-Calculus. In the last two years we dipped in AP passage rate. We assume that this dip was a direct result of both teaching AP courses and administering AP testing online via Distance Learning in 2021 and also on teacher turn-over. Last year we changed AP teachers in AP Language and we lost our AP government teacher. We need to replace that teacher and train new folks in the coming summer for AP Government and APUSH.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

There were no material differences between the budgeted expenditures and estimated actual expenditures for this goal.

An explanation of how effective the specific actions were in making progress toward the goal.

Goal 3: College, Leadership and Life Overall Effectiveness:

A-G completion--Our graduation rates have remained steady at over the 90% range for the last three years; in the 2020-21 school year our cohort graduation rate was 95% for all students and higher for African American students (100%) and Students with Disabilities (96%). This year also reflected our highest A-G graduation rate with 89% of all students graduating A-G ready. In the 2021-22 year our graduation rate was 92% for all students. For EL students our graduation rate was 75%.

AP passage rate--At AJR in 2019-20 we met our goal of increasing our passing scores on AP tests from the year before. Several Advanced Placement (AP) classes are available for students at Ánimo Jackie Robinson Charter High School. In 2019-20 we offered our highest number of AP courses with eight offerings, spanning five different departments. English Language and Composition English Literature and Composition Calculus AB World History United States History Government Spanish Language and Culture Environmental Science Psychology The 2018-2019 school year represented our highest percentage of passed AP exams, which correlates with the increase in AP courses offered.

In 2019-20 and 2020-21 we had to teach AP classes online via zoom, which impacted us tremendously, although some students did pass their AP exams, which they also took online.

In 2021-22 we returned to in-person learning, which improved our instruction and impact on students, but we also had some changes in our teaching staff, so we were dealing with teachers who had never taught AP at our school before or at all. We also dealt with the tremendous challenges of returning to in-person schooling during Covid and teaching students who had been taught for a year and a half online. Our scores overall decreased.

Our AP passing rate decreased significantly last year. In 2021-22, students had a passing rate of 53%. We attribute this drop to the challenges of both teaching and learning, as well as assessing online. We plan to recover from this drop and bounce back with in-person learning. We have retained most of the teachers and been very intentional about upping the rigor and effectively preparing our students for the AP exams, as well as testing them in person in the best testing environment possible.

A description of any changes made to the planned goal, metrics, desired outcomes, or actions for the coming year that resulted from reflections on prior practice.

As described above, we intend to implement all the necessary in-person teaching strategies, programs, interventions and supports to increase our AP scores and to maintain the success we have achieved in A-G readiness, cohort graduation rates and low drop-out rates.

Metrics 3F – CTE, 3G– CTE & A-G, and 3H – EAP, were added to be aligned with state requirements. The metrics were not added the year before because there is no data available for Metrics 3F and 3G. Currently, there is no data available because the school does not offer an approved CTE pathway. As for Metric 3H – EAP, there is no data available for SY20-21 and SY21-22 because the graduating classes of 2021 and 2022 did not test in the 11th grade due to the COVID-19 pandemic. The class of 2020 was the last class to have tested in the 11th grade. The data for the 2020 class was used as the baseline for the metric 3H – EAP.

# Goal Analysis [2022-23]

An analysis of how this goal was carried out in the previous year.

A description of any substantive differences in planned actions and actual implementation of these actions.

#### **Overall Implementation:**

At AJR our school culture has been one of our strongest areas since our inception as a school. We performed above the targeted goal in every criteria, except chronic absenteeism, which we attribute to Distance Learning during the pandemic and recovery when we returned to

in-person learning. Although we are working to get back to our "normal" attendance rates for all students this year and in the years to come, we continue to see the effects of the pandemic on our students' attendance and overall attitudes toward school.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

There were no material differences between the budgeted expenditures and estimated actual expenditures for this goal.

An explanation of how effective the specific actions were in making progress toward the goal.

Goal 4: Focus on School Culture Overall Effectiveness:

Maintaining high ADA--AJR maintained an ADA of 93% for most students, which exceeds our goal of maintaining a 90% ADA. For our African American students (AA), Distance Learning was not very effective. Our ADA average was 89% for that subgroup. When we returned to school last year our overall ADA was 93% and our AA ADA average was 89%. Our EL ADA average was 92%, and our Students with Disabilities ADA average was 91%.

Decrease chronic absenteeism--In the 2020-21 school year AJR did not meet our goal of having 10% or less chronic absenteeism, except with Lantinx (8.8%) and Homeless Youth (8.5%). The chronic absenteeism rate increased to 11% for All Students, 34.9% for African American students, 15.9% for EL students and 19% for Students with Disabilities. We acknowledge that this increase was due to online learning and the pandemic. Last school year indicates that we were still recovering from the stresses and strains of the pandemic. In the 2021-22 school year, our chronic absenteeism rates were: 18% for SED, 23% for SPED, 41% for AA and 16% for Latinx and 18% overall. We are working to make sure that our overall chronic absenteeism rate decreases back to under 10% and that each subgroup's chronic absenteeism rate decreases as well.

Decrease suspension rate--Our suspension rate in 2020-21 decreased from 2.2% to 0%, which met our goal. Our suspension rate in 2021-22 was 1%.

Maintaining a low expulsion rate--AJR met our goal of having an expulsion rate of less than 0.5%. During our 2020-21 school year, our expulsion rate was 0%. During the 2021-22 year our expulsion rate was 0%.

A description of any changes made to the planned goal, metrics, desired outcomes, or actions for the coming year that resulted from reflections on prior practice.

The most significant change that we are implementing this year is in-person schooling, with all the incentives and benefits that it provides. Last year we also implemented an additional support program for our African American students, as a way to target specific students with high absences. This program is called Intensified Supports for Chronic Absenteeism. An attendance case manager meets weekly via zoom with students "on the cusp" of being chronically absent, to help them navigate the factors which hinder them from maintaining a healthy attendance. We implemented this program from the beginning of February of 2022 to June of 2022, and we saw positive results from it. It enabled us to reach our goal of decreasing the chronic absenteeism rate for our African American students. That program was cut for us, but we continue to work closely with our AASA lead teacher and others to improve AA student attendance.

In the current school year, some programs we are implementing to decrease chronic absenteeism are Attendance Works and the LEAP program. Attendance Works coordinates ongoing messaging through targeted outreach calls and mailers, a calendar of pre-programmed messages reminding parents of holidays, school days, as well as other dates that may impact attendance, and we share our attendance progress in our monthly parent meetings. The Learner Engagement and Attendance Program (LEAP) is a program that fully aligns with our focus on relationships and restorative practice and in fact focuses on building relationships with families and assessing needs and is less about addressing absences. Nine weeks into the program we have seen an increase in the attendance of 54% of the targeted students. We will continue with the program and continue to monitor the attendance of our targeted students.

Overall Implementation: At AJR we have been very successful at maintaining our parent, student and community engagement. We have maintained very positive relationships with all our educational partners and enjoy support and positive feedback from them.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

There were no material differences between the budgeted expenditures and estimated actual expenditures for this goal.

An explanation of how effective the specific actions were in making progress toward the goal.

Goal 5: Parent, Student and Community Engagement Overall Effectiveness: At least 4 SAC meetings are held each school year--We met this goal, because we had a total of 7 SAC meetings in the 2020-21 school year. We had a total of 8 SAC meetings in 2021-22. We are scheduled to have 8 SAC meetings in the current 2022-23 school year.

At least 2 DELAC meetings--We met this goal, because we had a total of 6 DELAC meetings in the 2020-21 year. We had 5 DELAC meetings in the 2021-22 school year. We are scheduled to have 6 DELAC meetings this year.

Student/family sense of connectedness-- Overwhelmingly, families indicate satisfaction with the school and rate they would recommend the school, year after year. In the 2019-20 school year, we earned a 96% satisfaction rate, answering the question, "would you recommend this school to a friend?" In the 2020-21 school year, that rate increased to 97.3%. In the 2021-22 school year our satisfaction rate, based on the question, "would you recommend this school to a friend?" increased to 98%. In terms of students recommending the school, we scored 95% in 2020-2021 and 91% in the 2021-2022 internal student survey. Overwhelmingly, students feel safe at school.

Staff sense of support--AJR hires and retains highly qualified staff members. Several staff members have been at AJR for many years, with three teachers on staff who attended AJR as students and have returned to their community to serve our students. Our school is a family and we work to embed that in all aspects of the school community. AJR currently has three administrators, two of which were previously teachers within GDPS. At AJR we take pride in our excellent Professional Development Program, which incorporates teacher voice and talent and includes differentiated sessions led by AJR faculty members. At AJR each summer the Instructional Leadership Team (ILT) creates a unit-based PD program, based on annual department PD goals, where we develop our teachers' expertise in instructional strategies, which include planning, incorporating rituals and routines and refining EL strategies, as well as accommodations and modifications for students with special needs. We also respond to teacher feedback. It has been our experience over the last several years that this PD model fosters sustained implementation and real growth among our teachers. On our staff survey in 2019-20, we earned a 96% satisfaction rate among our staff and in the 2020-21 school year we also earned a 96% satisfaction rating on the questions, "I feel successful in my role", "I am developing my professional practice" and "I enjoy my work in this community." In 2021-22 our satisfaction rating among teachers was 100%.

A description of any changes made to the planned goal, metrics, desired outcomes, or actions for the coming year that resulted from reflections on prior practice.

We added metric 5E-Parent Participation to capture the participation of all parents, including parents of our unduplicated students. Parents are engaged through various activities such as SAC, DELAC, Coffee with the Principal, Back to School Nights, Open House, Parent Conferences, Professional Developments and other school activities. For this metric, the school did not meet the goal. COVID-19 had a tremendous impact on social gatherings. Since our return to in-person instruction and meetings, parents have been hesitant to participate in meetings due to the fear of COVID. The school is currently exploring hybrid avenues for parent meetings. The school wants to provide parents with the opportunity to join meetings in-person and online. Also, the school is exploring tools to centralize parent sign-in for meetings. The school currently uses a mixture of online forms and paper-forms to capture parent sign-in. The school will continue to explore tools and

programs that can centralize parent participation data. The school is committed to improving and capturing its parent participation in school activities.

In the next school year we will be transitioning to a new parent communication platform, "ParentSquare" which has increased functionality to better meet the needs of parents and the school.

For each action being provided to an entire school, or across the entire school district or county office of education (COE), an explanation of (1) how the needs of foster youth, English learners, and low-income students were considered first, and (2) how these actions are effective in meeting the goals for these students.

Given the high percentage of unduplicated pupils at the school, the funds will be spent on improving the charter-wide educational program and meeting the academic goals specified earlier in the LCAP. The needs of low-income students are largely met based on the charter-wide educational model, with additional services provided for foster youth and Emergent Bilinguals. In order to meet the needs of its diverse student population the school will implement Green Dot's academic model with fidelity.

The model outlines the framework that allows Green Dot teachers and administrators to be successful and focuses on four key elements: 1) Ensuring Quality Teaching and Instruction, 2) Cultivating a College-going Culture, 3) Eliminating Barriers to Learning, and 4) Promoting Leadership and Life Skills. Implementation strategies are provided in the areas of curriculum, student intervention, professional development, parent participation and school operations to help principals and teachers make the most informed decisions for their schools.

1. Ensuring Quality Teaching & Instruction: Dedicated, effective teachers with a passion for their work and their students are at the heart of the Green Dot model. Green Dot ensures high quality teaching and instruction in every classroom through its research-based methods of instruction, teacher effectiveness initiatives and robust professional development and support. The College-Ready Teaching Framework

("CRTF") – a rubric that defines the core competencies expected of all Green Dot teachers is the foundation of the evaluation system. In addition, teachers will be able to pursue professional development and coaching support from the Instructional Coaches as well as from the Green Dot Home Office Education Team.

2. Cultivating a College-going Culture: Green Dot strives to attain high college acceptance rates by creating a culture of college-for-certain. School leaders create systems for ongoing academic counseling with counselors and advisors and offering college tours at every grade level. In addition, the school master schedule offers elective courses that support core content development (i.e., drama), as well as pre-AP pathways (i.e., honors courses in high school). Courses are structured to build students' key cognitive strategies: intellectual openness, analysis, reasoning, accuracy and precision, and interpretation. School classrooms demonstrate the successful implementation of behavior management strategies. Support is provided to build key behaviors necessary for success in high school and college, such as self-monitoring, persistence, independent preparation abilities, and college-level study skills. Lastly, all Green Dot schools provide support to build students' contextual awareness of college systems and culture.

3. Eliminating Barriers to Learning: Students come to Green Dot from a variety of backgrounds. Academically, many are far behind gradelevel. Socially and emotionally, many require emotional guidance in order to be able to succeed academically. Green Dot strives to provide the academic intervention, counseling and clinical services necessary to break down these barriers. Green Dot school leaders successfully implement all three tiers of the Multi-Tiered System of Supports by appropriately providing intervention in Literacy, Math, English Language Development and Special Education. Green Dot schools offer an Advisory program that provides academic guidance, school culture & safety; college and career; and personal development. Additionally, each school provides a menu of wrap-around services: mental health supports and psychological services; counseling groups; mentoring programs; supports for foster youth and students experiencing homelessness; and links to community partners for health and wellness programs.

4. Promoting Leadership & Life Skills: Green Dot aims to provide students with a broad set of tools, behaviors and skills to prepare them for college and beyond. Systems for student leadership such as student government, student ambassador program, student mentorship, and the Principal's Advisory Committee give students internal leadership experience. External experience is available through partnerships with community programs, including public speaking opportunities, job shadowing, volunteer work, mentorships, and summer internships. Advisory programs teach and promote life skills and help to reduce dropouts, foster youth development, enhance academic achievement, and promote whole-being development.

A description of how services for foster youth, English learners, and low-income students are being increased or improved by the percentage required.

"The schools' educational program will successfully meet the needs of its foster youth, Emergent Bilinguals and low-income student population. Examples of theses supports include:

- Implementation of all three tiers of the Multi-Tiered System of Supports in Literacy, Math, English Language Development and Special Education
- Intensive interventions for students requiring additional enrichment and support, including Literacy Enrichment, Math Foundations, individualized tutoring, classroom push-in and co-teaching models and small strategic groupings
- An Advisory program for all students to prepare them with the tools and behaviors to succeed in high school, college, leadership and life – covering topics such as: academic preparation, promotion of college awareness, developing strong peer relationships, developing life skills in areas such as resilience/grit, growth mindset, organization, communication, health/nutrition and personal finance
- Integrated wraparound services to help address social and non-academic barriers to student learning including small group counseling and individual student counseling. Foster youth and students experiencing homelessness are provided services and supports tailored to their individualized needs including uniform and transportation assistance and navigation to community resources such as housing, food, and mental health services.
- Proactive and positive student behavior management, including various alternatives to suspension
- Opportunities for students to explore student leadership and other interests through participation in elective courses, student government, after-school programs and clubs
- Special education programs that cultivate collaboration between general and special education teachers to guarantee that students with disabilities are integrated into the school to the maximum extent possible to allow them full access to all programs.

The school has developed a research-based curriculum appropriate to the student demographics it serves that includes the following: course offerings, textbooks, curriculum maps, pacing guides, sample lesson plans, interim assessments and intervention programs. The model is derived from the following continuum of research-based practices:

• Planning and Preparation: Based on Essential Elements of Effective Instruction by Madeline Hunter. Madeline Hunter developed the teacher "decision-making model" for planning instruction known as Instructional Theory in Practice ("ITIP"). This approach to

teaching uses Direct Instruction ("DI") as the framework for planning. DI refers to a rigorously developed, highly scripted method that is fast-paced and provides constant interaction with students.

- Assessment and Learning: Based on Understanding by Design: Backwards Design by Jay McTighe and Grant Wiggins. The emphasis of Understanding by Design ("UbD") is on ""backward design,"" the practice of identifying the desired outcomes in order to design curriculum units, performance assessments and classroom instruction that will enable students to achieve these outcomes. The backward design approach is developed in three stages. Stage 1 starts with educators identifying the desired results of their students by establishing the overall goal of the lessons by using content standards, common core or state standards. Stage 2 focuses on evidence of learning by assessment. Teachers plan performance tasks and evidence of understanding. Performance tasks determine what the students will demonstrate in the unit and what evidence will prove their understanding. This can include self-reflections and self-assessments on learning. Lastly, Stage 3 lists the learning activities that will lead students to the desired results.
- Instructional Techniques: Based on Teach Like a Champion by Doug Lemov. Teach Like a Champion offers effective teaching techniques to help teachers become champions in the classroom. Additional details provided in the section entitled "Instructional Design, Methods and Strategies."
- Classroom Environment: Based on "Safe and Civil Schools" by Randy Sprick. Safe & Civil provides high-quality programs and staff
  development services to help educators create proactive and positive behavior management strategies in schools. In addition, a
  focus on Restorative Practices provides schools with the resources to build community amongst staff and students. School site
  walk-throughs with administrators, teacher leaders and members of the Green Dot Home Office Education Team are scheduled
  regularly to observe discipline and school culture. Findings from these sessions are compiled to create school-specific professional
  development for teachers and the necessary support to create an environment where students can learn and where teachers can
  teach.
- Culturally Responsive Pedagogy: Green Dot Public Schools believes that culturally responsive pedagogy can increase student engagement, provide access to content, and as a result, bolster feelings of confidence and understanding in students. School leaders and teachers have read Zaretta Hammond's Culturally Responsive Teaching and the Brain and use her Ready for Rigor framework to work towards a culturally responsive classroom experience for all students.

Academic Support and Intervention is based on incoming student need and a schedule of intervention and acceleration courses will be available to students so that all students can complete the required courses:

- Summer Bridge: Summer Bridge is a recommended multi-week summer program that acclimates students to the culture of the school, high expectations and the development of a trusting community. During the Summer Bridge program, students will also be identified for special needs, English Learner levels, non-proficiency in standards and social-emotional supports, and staff will make the necessary adjustments to the master schedule to better accommodate them. Students receive standards-based instruction in Math and English Language Arts and are acclimated to the culture and expectations of the school. Students will engage in culture-building exercises that promote a positive community of trust and respect. Social and personal issues will also be surfaced in small group settings complemented with educational field trips.
- Literacy Intervention/Enrichment (Read 180): Literacy Intervention/Enrichment is a standards-aligned program for reading that is provided to students that test low in reading. Typically, this course is given to students through an elective class.
- Math Foundations: Students who are struggling in Math (not proficient and/or recommended by their Math teachers) will receive an additional period of Math support, where their teacher and tutors will work on skill building through their current curriculum, as well as remediation strategies to strengthen skills in group tutorial and one-on-one formats.
- Designated and Integrated English Language Development (ELD): Designated ELD classes are provided for all English Learner students and Integrated ELD is provided in all other content classes throughout the school day for Emergent Bilinguals. Designated ELD focuses on listening, speaking, reading and writing skills in English with the CA ELD Standards and Features of Designated ELD driving instruction. Integrated ELD focuses on academic content and English language skills in tandem so that Emergent Bilinguals practice English language skills with academic content in all classes.
- Special Needs/Academic Success: Designated SPED students will be provided extra support to reflect the needs outlined in the Individualized Education Plan (IEP) and in all of their academic courses through one-on-one instruction, group support and guided instruction.
- Homework Club: Students who are struggling with a particular class or want more support in a subject can attend Homework Club, which is offered an hour every day after school and run by a credentialed teacher and/or college interns.
- Office Hours: Teachers hold office hours twice a week before and after school to provide additional support.
- After School Program: Students who are not achieving a satisfactory grade within a particular class or simply want more support in a subject can attend tutoring, which is offered for an hour every day after school.

Social and Life Skills Development is a key component of the school meeting the diverse needs of its student population including the establishment of an advisory course and clinical services available to all students.

Students will participate in an Advisory class with the same group of students for their school career to maintain a tighter sense of community. Advisory serves as a structured time and space for students to reflect on their learning and to discuss the connection between learning and life-long success. Advisory activities are organized around four pillars: 1) school culture and safety, 2) academics, 3) social life skills and 4) civic engagement. During Advisory, students will:

- Discuss issues related to the pressures of being a young adult including but not limited to puberty, relationships, mental health, family, substance abuse, etc.
- Acquire different study skill strategies, test-taking strategies and communication tools that will enable them to succeed in their academic career.
- Learn about the college process as they are encouraged to think beyond middle and high school in an effort to realize that the tools they gain today will be beneficial in the near future
- Gain self-efficacy skills that will allow them to address the barriers of learning with resiliency

We have built an Advisory course into the master schedule to serve as a level 1 intervention using the Multi-Tiered System of Supports(MTSS). Using the MTSS, all students receive the core literacy and math courses as their Tier 1 instruction. In addition to the core courses, students who need more intensive intervention (Tier 2) and support with a lower student-to-teacher ratio are provided with math and literacy interventions classes. If the student continues to struggle, the Grade Level team will determine if there are specific individual interventions (Tier 3) necessary to address the student's needs or if a referral to the Student Success Team is required.

Our Clinical Services team provides individual, group and family therapy to the students and families, and serves as a Tier 2 and 3 intervention within the MTSS Framework. The main purpose of our clinical services program is to address the barriers to learning from the mental health perspective. In addition, we provide crisis intervention, parent consultation, teacher consultation, and case management which include providing resources and referrals to outside agencies.

In order to ensure services are provided free of charge, services are provided by pre- and post- graduate Marriage and Family Therapy, Psychology and Social Work interns who receive extensive training and supervision in exchange for their work. All services are supervised by one of our licensed Marriage and Family Therapists or Licensed Clinical Social Workers. Interns provide social and emotional counseling including small group and individual therapy.

The School Mental Health Services team uses a referral process for students to receive services. Once students and parents have consented to services, students will work with a School Mental Health Therapist or School Mental Health Intern (under the supervision of a Licensed Mental Health provider) that follows them through the process of services, and provides mental health services. Students are provided with assessments that measure symptoms of depression, anxiety, & trauma, along with other evidenced-based interventions during clinical psychotherapy. The School Mental Health Services team works with parents, staff, and students throughout the referral process to ensure they are aware of their options. School Mental Health Services provides a proactive approach to addressing the barriers of learning by utilizing prevention and wellness to enable our students to possess the necessary skills to navigate their academic and social skills.

The school will improve its entire educational program by investing in additional technology to increase its ratio of students to computers, additional special education services to support high needs students, and instructional material to increase support for classroom learning experience.

- The school will offer a spectrum of special education services that may include a resource program and special day program. The programs are designed to foster a high-quality program for students with special education needs. Additionally, our special education programs cultivate collaboration between general and special education teachers to guarantee that students with disabilities are integrated into the school to the maximum extent possible to allow them full access to all programs.
- The school will offer ELD courses to prepare Emergent Bilinguals recently arrived in the U.S. for success in English-medium instruction, including English Language Arts. Skills in all four strands of language listening, speaking, reading and writing are systematically developed. Students of mixed grade levels are grouped according to proficiency in English. Cultural knowledge needed for success in U.S. schools is integrated throughout. The Green Dot EL Master Plan includes the new CA ELD standards and a five step process for the identification of Emergent Bilinguals including: 1) Initial Identification, 2) EL Proficiency Assessment, 3) Primary Language Assessment, 4) Parent Notification, and 5) Program Placement. Green Dot schools provide on-going training for administrators and teachers on the identification process.
- All Emergent Bilinguals students are served in both Designated and Integrated ELD designed to meet their needs. Instruction is based on the CA ELD Standards and the Features of Designated and Integrated ELD. These programs are built into the school's

master schedule and take place within the school day. The school will work with the Human Resources (HR) Department to ensure appropriate staffing and authorizations for teachers in these courses.

• Technology is widely used at the school to drive higher levels of achievement and prepare students for the information driven economy of the 21st century. It is also used as a critical tool for gathering data for school management.

Technology investments will be made in the following areas:

- Increased computing devices (e.g., desktops, laptops, Chromebooks) that are available for student use;
- Each teacher is provided with a laptop and given training on effectively using technology in the classroom;
- · Courses often include web-based research projects and assignments;
- Technology elective classes are included in the recommended curriculum to train students on computers and different software programs; and
- A web-based student information and school management system is implemented at the school and used by parents, students and school staff "

A description of the plan for how the additional concentration grant add-on funding identified above will be used to increase the number of staff providing direct services to students at schools that have a high concentration (above 55 percent) of foster youth, English learners, and low-income students, as applicable.

The LEA received additional concentration grant funding due to its high percentage of unduplicated pupils, which is well above the 55% threshold for receiving these funds. The LEA has utilized the additional concentration grant add-on funding to hire and maintain staff at the school who provide direct services to students. We have used these funds to provide high impact tutoring services through the hiring of instructional aides, as well as to hire additional staff such as clinical supervisors, a homeless youth coordinator, attendance case managers, African American Support Specialists, push-in substitutes, and additional support staff to address the ongoing impact of COVID-19. Retention efforts for existing staff include increased mental health supports and additional professional development opportunities.

Goal 2, Actions 2.1, 2.2, 2.5 and 2.8 address this requirement, as well as Goal 3, Action 3.1, and Goal 4, Actions 4.1 and 4.2.

# **Introduction and Instructions**

The Local Control Funding Formula (LCFF) requires local educational agencies (LEAs) to engage their local educational partners in an annual planning process to evaluate their progress within eight state priority areas encompassing all statutory metrics (COEs have 10 state priorities). LEAs document the results of this planning process in the LCAP using the template adopted by the State Board of Education.

The LCAP development process serves three distinct, but related functions:

- **Comprehensive Strategic Planning:** The process of developing and annually updating the LCAP supports comprehensive strategic planning (California *Education Code* [*EC*] Section 52064[e][1]). Strategic planning that is comprehensive connects budgetary decisions to teaching and learning performance data.
