

Budget Overview for the 2023-24 School Year







Plan Summary [2023-24]

General Information

A description of the LEA, its schools, and its students in grades transitional kindergarten-12, as applicable to the LEA.

Ánimo Inglewood Charter High School was founded in 2002 as the second school of the Charter Management Organization Green Dot Public Schools CA. Ánimo Inglewood is located in South Los Angeles, in the city of Inglewood, serving students in grades 9-12. It is a free and public charter high school, and functions as a community school for students who primarily live within the Inglewood, California area. Current enrollment numbers show that Ánimo Inglewood currently serves 613 students, with 155 - 9th graders, 150 - 10th graders, 159 - 11th graders, and 149 - 12th graders. The racial backgrounds of our students are majority Latino & African-American- with 11.3% of our student body identifying as African-American (69), and 88.4% (542) Latino, in addition to .2% (1) identifying as white. Additionally, 307 of our students are classified as RFEP having previously redesignated from their EL classification, 34 IFEP students, and 199 students who are classified as English-only speakers. Additionally, 8.5% (52) of our students have an IEP and receive special education services with 50 in the resource specialist program (RSP). Ánimo Inglewood also serves 5 homeless youth and 2 foster youth. The School's Average Daily Attendance Rate is 93% and the graduation rate for AICHS was 97% for the 2022-2023 academic year. The mission of Ánimo Inglewood Charter High School is to "prepare ethnically and economically diverse students for college, leadership, and life through innovative instruction, a rigorous curriculum, and the use of technology."

Reflections: Successes

A description of successes and/or progress based on a review of the California School Dashboard (Dashboard) and local data.

Ánimo Inglewood Charter High School is proud to have achieved the best possible status rating on the 2022 California School Dashboard for school performance on English Learner Progress, Graduation Rate and Suspension Rate. In each of these areas, the school out-performed the state status levels.

On the English Learner Progress Indicator of the 2022 California School Dashboard report, Ánimo Inglewood Charter High School earned a status level of "Very High", which is higher than the state's status level of Medium. The report shows that 66.7 percent of students are making progress towards English language proficiency which is higher than the state at 50.3 percent.

For the Graduation Rate Indicator, Ánimo Inglewood Charter High School earned a status level of "Very High" for All Students which is higher than the state's status level of "Medium". The report shows that 97.3 percent of students graduated which is higher than the state at 87.4 percent.

On the Suspension Rate Indicator, Ánimo Inglewood Charter High School earned a status level of "Very Low" for All Students which is lower than the state's status level of "Medium". The report shows that 0.2 percent of students were suspended which is lower than the state at 3.1 percent.

The mission of Ánimo Inglewood Charter High School is to prepare all students for College, Leadership, and Life. The culture at Ánimo Inglewood Charter High School has shown significant progress towards the mission, through a 97% graduation rate and 0% dropout rate in the 2021-2022 academic year. In line with reflection on the culture of the school is the very low suspension rate, and achieving a daily attendance average of 93%. With respect to English Learners, the reclassification rate increased from 7.9% to 23.3% in 2021 - 2022. Additionally, ELPI level growth increased from 28% in 2018-19 to 67%. These successes were also made possible by the engagement of all educational partners through varied spaces such as SAC and DELAC, and the retention of credentialed educators and a standards-aligned broad course offering. In addition to the above successes, we celebrate the growth, as measured by the nationally normed assessments of Reading Inventory (for ELA) and iReady (for Math). All students, including subgroups, met and even exceeded their growth goals.

Reflections: Identified Need

Ánimo Inglewood Charter High School's 2022 California School Dashboard report on the school's performance in Math indicates that the school has earned a Status level of "Very Low" for All Students which is lower than the state's status level of "Low". The report shows Ánimo Inglewood Charter High School at 119.2 points below standard in Math for the All Students group, which is greater than the State, 51.7 points below standard. All numerically significant student groups, African American students, students with disabilities, and Socioeconomically Disadvantaged students had greater points below standard compared to the State's average points below standard for those student groups.

On the 2022 CA Dashboard, the school received a status of "Not Met" for all 5 local indicators. The school presented its findings regarding the local indicators to the public and Green Dot's governing board. The local indicators were approved, along with the LCAP, by the Green Dot board on June 24, 2022. The school did not submit the local indicators by CDE deadline, therefore receiving a status level of "Not Met." The school is continuously working to meet the local indicators of basic: teachers, instructional, materials facilities; implementation of academic standards; parent and family engagement; local climate survey; and access to broad course of study.

Ánimo Inglewood Charter High School's 2022-2023 LCAP data evidences strong performance in many areas, including the provision of basic services, proficiency for all students, preparation for college, leadership, and life, and school culture. Specific areas of strength include course offerings, graduation rates, dropout rates, A-G completion rates (overall and for some subgroups), ADA, suspension and expulsion rates, and educational partners engagement.

Engaging Educational Partners

A summary of the process used to engage educational partners and how this engagement was considered before finalizing the LCAP.

During the 2022-23 school year, the school used several outreach strategies to engage with educational partners on the LCAP. The School Advisory Council ("SAC") has reviewed the LCAP goals, outcomes data, and expenditures data at multiple points throughout the year. The SAC is composed of administrators, teachers, counselors, classified staff members, parents and students. The SAC had the opportunity to provide specific feedback on the various elements of the LCAP and identify areas of success and challenge to focus on in the coming year. The District English Learner Advisory Committee ("DELAC") has also reviewed the documents in Spring of 2023, both to provide feedback and final approval of the document. The DELAC is similarly composed of diverse members of the school community, but Parents or guardians of English Learners constitute the majority membership (51 percent or more) of the committee.

In addition to discussion within these two committees, the LCAP documents were shared with the public during a public hearing of the Board before approval at a subsequent board meeting. The school further engages parents and family through student orientation, Ánimo Parent Academy, Community Organizing Institute, Coffee with the Principal, parent conferences, and/or meaningful two-way conversations between schools and parents in the parents' home language. This engagement included parents with limited English proficiencies, parents of migrant students, English Learners, and students with disabilities.

In conjunction with the different educational partners groups, the Green Dot Home Office worked with School Leadership to update this LCAP, taking into account the progress identified in the Goal Analysis sections, revisions to actions/services, and updates to future expenditures. The Green Dot Home Office reviewed the SAC and DELAC feedback across all Green Dot schools to identify trends, achievements, and areas for improvement. This information was also shared with the Green Dot's Board of Directors Executive Committee on May 25, 2023, which includes the President of the Asociación de Maestros Unidos. The school's LCAP was presented to the Green Dot Governing Board on June 30, 2023 for final approval. The LCAP was submitted to the Authorizing School District and the Los Angeles County Office of Education before July 1, 2023. The Green Dot Home Office, School Leadership, SAC, and DELAC will regularly monitor and evaluate progress made towards the School's LCAP goals.

A summary of the feedback provided by specific educational partners.

During the 2022-2023 school year, the school used several outreach strategies to engage with educational partners on the LCAP. The School's efforts began in the Fall of 2022 when the School Principal and Operations and Finance Manager reviewed the 2022- 23 LCAP with the School Advisory Council ("SAC"). Since the first SAC meeting, the Principal referred to the LCAP and its goals during subsequent SAC meetings to ensure the LCAP was kept top of mind, and to receive feedback on goals. The SAC is composed of administrators, teachers, counselors, classified staff members, parents and students. The SAC also included representation from the Asociación de Maestros Unidos, the union that represents Green Dot's certificated staff. In addition, other parent groups were presented with the information; DELAC and provided feedback as it related to the whole plan and specific subgroups. The Green Dot Public Schools Home Office ("Green Dot Home Office"), including members of the Education, Knowledge Management, Policy & Public Affairs, Finance & Accounting and Operations teams, provided the School with updated data for each goal to help monitor 2023-24 Local Control Accountability Plan for Ánimo Inglewood Charter

High School. The Principal reviewed the updated data with the SAC and reflected on changes from the previous year. The 2023-2024 LCAP was presented to the School Advisory Council during the May 2023 SAC meeting. The SAC reviewed the LCAP, including areas in the Annual Update where targets were missed, and provided feedback on additional actions/activities to address these areas in the future.

A description of the aspects of the LCAP that were influenced by specific input from educational partners.

The LCAP was influenced by conversations with multiple education partners groups over the past year and prior. These conversations took place in various formats including Coffee with the Principal, DELAC meetings, staff meetings, via surveys and social media communications, and the SAC meetings specifically dedicated to reviewing and providing feedback on the LCAP. As a result, we have identified our top priorities and added or expanded upon the actions and services to support these goals. We have also built out our budget to support the key priorities identified by the school community, including following the recommendation of the SAC to focus on chronic absenteeism to increase student success and address learning loss. Given the trauma of the pandemic still impacting schools, and the increased need for mental health has not diminished. Our school is committed to ensuring this concern is met through the use of our multi-tiered systems of support (MTSS) and the efforts of our Coordination of Services Team (COST) with the added support of a School Mental Supervisor. Lastly, in response to educational partners' feedback from earlier in the year and years prior, we improved the LCAP review process to ensure transparency and enable authentic and specific feedback to be incorporated into the plan throughout its development.

An analysis of how this goal was carried out in the previous year.

A description of any substantive differences in planned actions and actual implementation of these actions.

The school was effective in implementing the actions and services to meet the goal of providing basic services to students as it relates to maintaining credentialed teachers and access to a broad course of study as described above. We were able to meet these criterias with our goal of a 100% performance rate. During the master scheduling process and throughout the year to ensure all credentials are properly maintained, the principal continues to review teacher, counselor, and administrator credentials. We also work closely with the district Human Capital and hiring team to ensure we only interview quality candidates with appropriate credentials, in a timely and effective manner, and maintain the employee lifecycle process. Student data analyzed by administrators is used to assess student course progress and place students in appropriate classes. The course offerings and Master schedule reflect an emphasis on Common Core and Next Generation Science Standard curriculum, in addition to providing the necessary and appropriate interventions for ELA and math. Advisory has been instrumental in driving student academic success and social emotional well being, providing the space for academic consulting, additional support for core classes and opportunities to build relationships. Additionally, students have access to standards-aligned materials in all core classes, including district-wide curriculum in ELA and math. Continued professional development is provided to all teachers and administrators to support the effective use of aligned curricular materials. Students also have multiple access points to the standards-aligned

curriculum via technology and electronic materials. All students take one year of Physical Education and several electives during their time at Ánimo Inglewood. Facilities performance was 89% and in working towards this goal, regular facility inspections and audits are conducted by Green Dot Operations and Facilities ensures that any facility repairs that are needed are accomplished quickly. Green Dot maintains school sites in accordance with the FUA and communicates any repairs required by the district through their work order system.

There were no material differences between the budgeted expenditures and estimated actual expenditures for this goal.

An explanation of how effective the specific actions were in making progress toward the goal.

Collaborating with our Human Capital team whenever we have teacher openings to make sure we are only hiring qualified, appropriately-credentialed teachers helps us meet goal 1A each year. We are able to meet goal 1B by following our academic model and course pathways, which are aligned to A-G requirements. Contributing to our very high Graduation Rate of 97%.

We will continue screening highly-qualified candidates for any openings we have. Last year, we added a new elective offering, Ethnic Studies, and this year we added AP Statistics in response to student data and educational partners voice/choice in A-G course offerings. We also partnered with a local community college to offer dual enrollment as an added opportunity for students to increase their access to academic curriculum. We also continue to have conversations about expanding possible elective options and access to enrichment courses, such as AP classes, in the future.

Despite the challenges of returning in-person after distance learning. Overall, we were able to meet proficiency for all. We attribute this growth to collaborative strategies that supported students with reading for comprehension and writing across content areas. When examining subgroups all subgroups met their growth goal above the required 3%. In addition, all teachers engaged in three ELD PD sessions focused on instructional support and the impact of writing and supporting a Language Criteria for Success for our EB students. We also increased our

class offerings to include EB specialized Advisory, Latinx and African American Studies classes to provide stability and consistent support. In Math, students school wide and across subgroups performed at or above our goal. We attribute this success to the strategies outlined below and are continuing to see success in this area in the current school year. Target support for students in our Foundation classes based on proficiency levels. This allows teachers to hone in on the foundational skills absent and intensify the instruction. All teachers implemented the Illustrative Math curriculum with fidelity, leveraging built in strategies in order to address grade level standards at the appropriate level of rigor provide push-in support for students with IEPs with a one-on-one instructional aide. Teachers leveraged strategies learned through PD that consistently increase student and teachers of EB needs in the classroom and demonstration of mastery of content by writing Language Criteria for Success aligned to ELD and content standards. However, standards-aligned instruction in all core subject areas continues to be a focus. Benchmarks administered quarterly in core classes, through the MasteryConnect platform, are SBAC-aligned and allow teachers to monitor student growth and progress and conduct data analysis to plan targeted instruction and intervention. Teachers engage in professional development and coaching focused on Intellection Preparation and Planning (IPP), data-informed planning of instruction at the unit and lesson level.

AICHS was effective in meeting our goals of proficiency for all in both ELA and Math, CAST and EL proficiency on the ELPAC, in addition to EL reclassification rates. The supports provided were impactful for students and accelerated student growth outcomes. An area where we continue to make improvements is in metric 2D, our Reclassification rates for our EL students. We are adding a number of additional actions to support these students, in the 2023-24 school year.

In order to support our Emergent Bilinguals and the re-classification of students, we will provide more targeted strategies and continue to focus on planning and instruction by delivering professional developments to support all teachers with improving their integrated ELD instruction and implementing strategies outlined and identified in the ELLevation platform. We will continue to leverage the ELD Advisory as an additional space for academic support by offering it in the upcoming school year. In order to support our Emergent Bilinguals, we are also continuing to engage teachers in ELD professional development sessions where teachers identify their EBs, their proficiency levels and

analyze EB supports. In addition, teachers will continue to explore ELD standards and Language Criteria For Success (LCFS) in alignment with their respective content in order to plan and implement explicit language instruction.

There was a change made to Action 2.3 – Special Education. During the pandemic, students with disabilities had access to transportation in order to provide services per their Individualized Education Plan (IEP). Transportation was provided for students with disabilities because in SY 2020-21, distance learning was in full effect, and these students needed access to IEP services. Since the pandemic, SY2021-22 was the first full year of in-person instruction and IEP services were provided on campus.

Overall, our school was quite effective in implementing the actions and services required to ensure students are prepared for college, leadership, and life. In goals 3A and 3B (cohort dropout rate and graduation rate) we met our goals for the whole-school population, as well as for all subgroups for which we have data, as we were able to have a 97% graduation rate, and 0% dropout rate. In goal 3C, we met our A-G completion goals for the whole-school population and, and we had no data for our foster youth, homeless youth, EL, AA, and SWD populations. Goal 3D, we met our AP passage rate only for our Latinx population as there was no data for other subgroups. In goal 3E, we do not have data available for this year. However, all students participated in College and Career Readiness instruction using CCGI through their advisory courses. In addition, we added an additional counselor this year and have 3 school counselors who provide academic and college readiness counseling. Students have individual meetings with their counselors to track promotion progress and develop plans for post secondary college and career options on a yearly basis. Progress reports are sent home quarterly to inform students and parents of academic progress in each course. All students have an advisory course which provides individualized academic consultancy. Parent meetings are held to support parents in understanding their students' academic needs and goals. Overall, the school was effective in implementing the services to meet its LCAP goals.

There were no material differences between the budgeted expenditures and estimated actual expenditures for this goal.

Actions that have supported meeting our dropout rate, 99% graduation rate, and A-G completion rate goals include annual (and sometimes more frequent) family/student meetings held by our counselors to keep families updated on students' progress, academic check-ins, ample opportunities for credit recovery through summer school, APEX, Acellus, and our extended semester program, and our academic consultancy program run through advisory. While students enrolled in AP classes during SY23 worked hard to learn college-level material and prepare for their AP exams, the return of in-person instruction allowed for opportunities to engage in mock exams and extended practice sessions to increase our AP passage rate and students feeling prepared enough to take the exam this year. We continue to analyze pass rates and other relevant data to support our AP teachers in improving instruction and student outcomes.

A description of any changes made to the planned goal, metrics, desired outcomes, or actions for the coming year that resulted from reflections on prior practice.

This year, we centered on supporting our EB students through collaboration between general education teachers and case carriers, professional development, and Push-in support for content for courses. We have also sought to strengthen AP instruction and outcomes through updated curricular materials, coaching, data analysis, and opportunities for extended preparation sessions leading up to the May 2023 exams. In addition, increase parent workshops to inform parents of content and strategies to support students in their academic endeavors. We will also continue to look at data to increase and motivate the participation of all subgroups in AP courses and preparation for taking AP exams.

Metrics 3F – CTE, 3G– CTE & A-G, and 3H – EAP, were added to be aligned with state requirements. The metrics were not added the year before because there is no data available for Metrics 3F and 3G. Currently, there is no data available because the school does not offer an approved CTE pathway. As for Metric 3H – EAP, there is no data available for SY20-21 and SY21-22 because the graduating classes of 2021 and 2022 did not test in the 11th grade due to the COVID-19 pandemic. The class of 2020 was the last class to have tested in the 11th grade. The data for the 2020 class was used as the baseline for the metric 3H – EAP.

Goal Analysis [2022-23]

An analysis of how this goal was carried out in the previous year.

A description of any substantive differences in planned actions and actual implementation of these actions.

Ánimo Inglewood (AICHS) was able to meet goal 4A for the majority of subgroups by meeting a whole-school ADA rate of 91%, surpassing the 90% ADA goal for all subgroups except EL, which had an ADA rate of 88%. We did not meet goal 4B, chronic absenteeism, a similar reflection of the nation. However, our homeless and foster youth group had a rate of 10% and 0% respectively due to our ability to address their individual needs in a multitude of ways. In goals 4C and 4D, we met our whole-school goals and goals for all subgroups, with zero expulsions and a 0% suspension rate. AICHS was able to achieve their goals by creating actionable steps that were both technical and adaptive. We ensure that attendance is taken daily and tracked via PowerSchool (Green Dot's student information system), maintain daily communication with parents to inform them of student absences and/or tardies, providing attendance and academic data during all parent meetings (by subgroup) via Zoom. The COST team is used to help identify and address barriers to these impacted subgroups' attendance. They worked in collaboration with the family to remove barriers and set goals to ensure students are attending school on a regular basis. Teachers and staff focus on relationship building understanding the importance of academics and mental health as a way to remove a significant barrier to attendance. In addition too, restorative practices, such mediations and projects were essential to our 0 expulsion and 0% suspension rates. We also had an Advisory Culture Team (designated group of teachers) and African American Achievement Lead teachers charged with developing lessons, professional development and supporting school-wide policies to create a safe and civil environment and restorative community for staff and students.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

There were no material differences between the budgeted expenditures and estimated actual expenditures for this goal.

An explanation of how effective the specific actions were in making progress toward the goal.

Our school team worked hard to maintain attendance and engagement for our students and families throughout the school year and support students and families with inconsistent attendance. These efforts included partnership with having a McKinney-Vento and Foster Youth case manager whose number one focus was on removing barriers and providing interventions for homeless and foster youth who were exhibiting chronic absenteeism and attendance issues. The case manager met with a caseload of students on a weekly basis and worked collaboratively with administration and counseling to create multiple points of check in and support. In addition, we focused on chronically absent students, accurate attendance taking and logging, regular phone calls to monitor and seek information about attendance. The Administration team will continue to collaborate with the McKinney-Vento and Foster Youth case manager, operations team, and counselors to continue to analyze the barriers that continue to exist amongst students exhibiting attendance challenges.

A description of any changes made to the planned goal, metrics, desired outcomes, or actions for the coming year that resulted from reflections on prior practice.

Students who have needed to be absent this year due to illness or quarantine requirements have been able to keep up with their studies through access to course content via Google Classroom, and with the support of teacher office hours. In addition, we have begun to use the Remind app to communicate more frequently with parents and conduct coordinated home visits to build relationships with families and the school site to improve attendance and address chronic absenteeism. In regards to suspensions and expulsions, we have continued to work as a school on approaching disciplinary issues restoratively rather than punitively, and are seeking further training for our staff and student leaders in restorative practices. We are also continuing our professional developments, advisory lessons, and strategies for building relationships and using student voice as another data point with their responses to our SEL screener, student surveys, and formal check-ins with groups and clubs on our campus. In addition, hearing from our families as it relates to additional barriers not identified to address collaboratively and holistically.

Goal Analysis [2022-23]

An analysis of how this goal was carried out in the previous year.

A description of any substantive differences in planned actions and actual implementation of these actions.

AICHS met subgoals 5A and 5B. We held more than 4 SAC meetings and more than 2 DELAC meetings during the year. All of these meetings were held on Zoom, increasing accessibility and participation. In these meetings, parents and families were able to receive important updates, provide feedback, ask questions, and vote on various aspects of our school site. Data was collected via family survey in which we identified meeting goal 5C with 88% of our families reporting. "They would recommend this school site to a friend". Knowing that our parents and families are key educational partners whose input we need and value in shaping the direction of our school, we centered their voices in addition to the survey through parent meetings held on campus such as Coffee with The Principal, Monthly DELAC Meetings, SAC meetings, African American Family Meetings, General Family Meetings, and Student Led Parent conferences. In addition to informal means such as drop-ins, during morning and after school supervision, and direct communication via texts, e-mails, and phone calls. As we seek to increase the opportunities for family participation and voice, we will continue to deliver the family survey. Returning in person, a year after distance learning, still provides challenges and areas of growth as it relates to education not only felt by students through learning loss but also by staff in seeking to fill the gaps created by the pandemic. This was expressed through the staff survey with 63% of staff expressing "I do not feel successful in my role: I am developing my professional practice seeing growth in the students I serve and enjoying my work in this community".

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

There were no material differences between the budgeted expenditures and estimated actual expenditures for this goal.

An explanation of how effective the specific actions were in making progress toward the goal.

Our families have various opportunities to be involved and connect with our school. It is our hope to develop a community school where families feel they can partner with us in both academic and personal endeavors towards the success of their families. A goal which we have begun and continue to prioritize. Because of our efforts, parents have been connected with mental health specialists for family therapy, received food and housing resources, provided resources to students and staff from personal endeavors and community connections, increased voter participation, understand immigration law and have opportunities to advocate for community needs through UPAS.

A description of any changes made to the planned goal, metrics, desired outcomes, or actions for the coming year that resulted from reflections on prior practice.

This year, we have continued to place great emphasis on the value and importance of family engagement. We have tried to strike a balance between the desire of some in-person engagement and the appreciated flexibility offered by virtual engagement opportunities by offering elements of both this school year. The return to in-person instruction has been difficult for all educational partners even after two years out of distance learning, and we have worked hard to continue to seek and implement feedback to create initiatives that boost morale, connection, engagement, and the success of students, families, and staff. We will continue to seek feedback from parents on what type of workshops they want to engage in every year, and leverage all educational partners' voices to provide the resources our families need. In addition, identify and address the needs of staff to support their feeling of positively impacting and engaging with the school community.

We added metric 5E-Parent Participation to capture the participation of all parents, including parents of our unduplicated students. Parents are engaged through various activities such as SAC, DELAC, Coffee with the Principal, Back to School Nights, Open House, Parent Conferences, Professional Developments and other school activities. For this metric, the school did not meet the goal. COVID-19 had a tremendous impact on social gatherings. Since our return to in-person instruction and meetings, parents have been hesitant to participate in meetings due to the fear of COVID. The school is currently exploring hybrid avenues for parent meetings. The school wants to provide parents with the opportunity to join meetings in-person and online. Also, the school is exploring tools to centralize parent sign-in for meetings. The school currently uses a mixture of online forms and paper-forms to capture parent sign-in. The school will continue to explore tools and programs that can centralize parent participation data. The school is committed to improving and capturing its parent participation in school activities.

Required Descriptions

For each action being provided to an entire school, or across the entire school district or county office of education (COE), an explanation of (1) how the needs of foster youth, English learners, and low-income students were considered first, and (2) how these actions are effective in meeting the goals for these students.

Given the high percentage of unduplicated pupils at the school, the funds will be spent on improving the charter-wide educational program and meeting the academic goals specified earlier in the LCAP. The needs of low-income students are largely met based on the charter-wide educational model, with additional services provided for foster youth and Emergent Bilinguals. In order to meet the needs of its diverse student population the school will implement Green Dot's academic model with fidelity.

The model outlines the framework that allows Green Dot teachers and administrators to be successful and focuses on four key elements: 1) Ensuring Quality Teaching and Instruction, 2) Cultivating a College-going Culture, 3) Eliminating Barriers to Learning, and 4) Promoting Leadership and Life Skills. Implementation strategies are provided in the areas of curriculum, student intervention, professional development, parent participation and school operations to help principals and teachers make the most informed decisions for their schools.

1. Ensuring Quality Teaching & Instruction: Dedicated, effective teachers with a passion for their work and their students are at the heart of the Green Dot model. Green Dot ensures high quality teaching and instruction in every classroom through its research-based methods of instruction, teacher effectiveness initiatives and robust professional development and support. The College-Ready Teaching Framework

("CRTF") – a rubric that defines the core competencies expected of all Green Dot teachers is the foundation of the evaluation system. In addition, teachers will be able to pursue professional development and coaching support from the Instructional Coaches as well as from the Green Dot Home Office Education Team.

- 2. Cultivating a College-going Culture: Green Dot strives to attain high college acceptance rates by creating a culture of college-for-certain. School leaders create systems for ongoing academic counseling with counselors and advisors and offering college tours at every grade level. In addition, the school master schedule offers elective courses that support core content development (i.e., drama), as well as pre-AP pathways (i.e., honors courses in high school). Courses are structured to build students' key cognitive strategies: intellectual openness, analysis, reasoning, accuracy and precision, and interpretation. School classrooms demonstrate the successful implementation of behavior management strategies. Support is provided to build key behaviors necessary for success in high school and college, such as self-monitoring, persistence, independent preparation abilities, and college-level study skills. Lastly, all Green Dot schools provide support to build students' contextual awareness of college systems and culture.
- 3. Eliminating Barriers to Learning: Students come to Green Dot from a variety of backgrounds. Academically, many are far behind grade-level. Socially and emotionally, many require emotional guidance in order to be able to succeed academically. Green Dot strives to provide the academic intervention, counseling and clinical services necessary to break down these barriers. Green Dot school leaders successfully implement all three tiers of the Multi-Tiered System of Supports by appropriately providing intervention in Literacy, Math, English Language Development and Special Education. Green Dot schools offer an Advisory program that provides academic guidance, school culture & safety; college and career; and personal development. Additionally, each school provides a menu of wrap-around services: mental health supports and psychological services; counseling groups; mentoring programs; supports for foster youth and students experiencing homelessness; and links to community partners for health and wellness programs.
- 4. Promoting Leadership & Life Skills: Green Dot aims to provide students with a broad set of tools, behaviors and skills to prepare them for college and beyond. Systems for student leadership such as student government, student ambassador program, student mentorship, and the Principal's Advisory Committee give students internal leadership experience. External experience is available through partnerships with community programs, including public speaking opportunities, job shadowing, volunteer work, mentorships, and summer internships. Advisory programs teach and promote life skills and help to reduce dropouts, foster youth development, enhance academic achievement, and promote whole-being development.

A description of how services for foster youth, English learners, and low-income students are being increased or improved by the percentage required.

The schools' educational program will successfully meet the needs of its foster youth, Emergent Bilinguals and low-income student population. Examples of theses supports include:

- Implementation of all three tiers of the Multi-Tiered System of Supports in Literacy, Math, English Language Development and Special Education
- Intensive interventions for students requiring additional enrichment and support, including Literacy Enrichment, Math Foundations, individualized tutoring, classroom push-in and co-teaching models and small strategic groupings
- An Advisory program for all students to prepare them with the tools and behaviors to succeed in high school, college, leadership and life – covering topics such as: academic preparation, promotion of college awareness, developing strong peer relationships, developing life skills in areas such as resilience/grit, growth mindset, organization, communication, health/nutrition and personal finance
- Integrated wraparound services to help address social and non-academic barriers to student learning including small group
 counseling and individual student counseling. Foster youth and students experiencing homelessness are provided services and
 supports tailored to their individualized needs including uniform and transportation assistance and navigation to community
 resources such as housing, food, and mental health services.
- Proactive and positive student behavior management, including various alternatives to suspension
- Opportunities for students to explore student leadership and other interests through participation in elective courses, student government, after-school programs and clubs
- Special education programs that cultivate collaboration between general and special education teachers to guarantee that students with disabilities are integrated into the school to the maximum extent possible to allow them full access to all programs.

The school has developed a research-based curriculum appropriate to the student demographics it serves that includes the following: course offerings, textbooks, curriculum maps, pacing guides, sample lesson plans, interim assessments and intervention programs. The model is derived from the following continuum of research-based practices:

• Planning and Preparation: Based on Essential Elements of Effective Instruction by Madeline Hunter. Madeline Hunter developed the teacher "decision-making model" for planning instruction known as Instructional Theory in Practice ("ITIP"). This approach to

teaching uses Direct Instruction ("DI") as the framework for planning. DI refers to a rigorously developed, highly scripted method that is fast-paced and provides constant interaction with students.

- Assessment and Learning: Based on Understanding by Design: Backwards Design by Jay McTighe and Grant Wiggins. The
 emphasis of Understanding by Design ("UbD") is on ""backward design,"" the practice of identifying the desired outcomes in order
 to design curriculum units, performance assessments and classroom instruction that will enable students to achieve these
 outcomes. The backward design approach is developed in three stages. Stage 1 starts with educators identifying the desired results
 of their students by establishing the overall goal of the lessons by using content standards, common core or state standards. Stage
 2 focuses on evidence of learning by assessment. Teachers plan performance tasks and evidence of understanding. Performance
 tasks determine what the students will demonstrate in the unit and what evidence will prove their understanding. This can include
 self-reflections and self-assessments on learning. Lastly, Stage 3 lists the learning activities that will lead students to the desired
 results.
- Instructional Techniques: Based on Teach Like a Champion by Doug Lemov. Teach Like a Champion offers effective teaching techniques to help teachers become champions in the classroom. Additional details provided in the section entitled "Instructional Design, Methods and Strategies."
- Classroom Environment: Based on "Safe and Civil Schools" by Randy Sprick. Safe & Civil provides high-quality programs and staff
 development services to help educators create proactive and positive behavior management strategies in schools. In addition, a
 focus on Restorative Practices provides schools with the resources to build community amongst staff and students. School site
 walk-throughs with administrators, teacher leaders and members of the Green Dot Home Office Education Team are scheduled
 regularly to observe discipline and school culture. Findings from these sessions are compiled to create school-specific professional
 development for teachers and the necessary support to create an environment where students can learn and where teachers can
 teach.
- Culturally Responsive Pedagogy: Green Dot Public Schools believes that culturally responsive pedagogy can increase student
 engagement, provide access to content, and as a result, bolster feelings of confidence and understanding in students. School
 leaders and teachers have read Zaretta Hammond's Culturally Responsive Teaching and the Brain and use her Ready for Rigor
 framework to work towards a culturally responsive classroom experience for all students.

Academic Support and Intervention is based on incoming student need and a schedule of intervention and acceleration courses will be available to students so that all students can complete the required courses:

- Summer Bridge: Summer Bridge is a recommended multi-week summer program that acclimates students to the culture of the
 school, high expectations and the development of a trusting community. During the Summer Bridge program, students will also be
 identified for special needs, English Learner levels, non-proficiency in standards and social-emotional supports, and staff will make
 the necessary adjustments to the master schedule to better accommodate them. Students receive standards-based instruction in
 Math and English Language Arts and are acclimated to the culture and expectations of the school. Students will engage in culturebuilding exercises that promote a positive community of trust and respect. Social and personal issues will also be surfaced in small
 group settings complemented with educational field trips.
- Literacy Intervention/Enrichment (Read 180): Literacy Intervention/Enrichment is a standards-aligned program for reading that is provided to students that test low in reading. Typically, this course is given to students through an elective class.
- Math Foundations: Students who are struggling in Math (not proficient and/or recommended by their Math teachers) will receive an additional period of Math support, where their teacher and tutors will work on skill building through their current curriculum, as well as remediation strategies to strengthen skills in group tutorial and one-on-one formats.
- Designated and Integrated English Language Development (ELD): Designated ELD classes are provided for all English Learner students and Integrated ELD is provided in all other content classes throughout the school day for Emergent Bilinguals. Designated ELD focuses on listening, speaking, reading and writing skills in English with the CA ELD Standards and Features of Designated ELD driving instruction. Integrated ELD focuses on academic content and English language skills in tandem so that Emergent Bilinguals practice English language skills with academic content in all classes.
- Special Needs/Academic Success: Designated SPED students will be provided extra support to reflect the needs outlined in the Individualized Education Plan (IEP) and in all of their academic courses through one-on-one instruction, group support and guided instruction.
- Homework Club: Students who are struggling with a particular class or want more support in a subject can attend Homework Club, which is offered an hour every day after school and run by a credentialed teacher and/or college interns.
- Office Hours: Teachers hold office hours twice a week before and after school to provide additional support.
- After School Program: Students who are not achieving a satisfactory grade within a particular class or simply want more support in a subject can attend tutoring, which is offered for an hour every day after school.

Social and Life Skills Development is a key component of the school meeting the diverse needs of its student population including the establishment of an advisory course and clinical services available to all students.

Students will participate in an Advisory class with the same group of students for their school career to maintain a tighter sense of community. Advisory serves as a structured time and space for students to reflect on their learning and to discuss the connection between learning and life-long success. Advisory activities are organized around four pillars: 1) school culture and safety, 2) academics, 3) social life skills and 4) civic engagement. During Advisory, students will:

- Discuss issues related to the pressures of being a young adult including but not limited to puberty, relationships, mental health, family, substance abuse, etc.
- Acquire different study skill strategies, test-taking strategies and communication tools that will enable them to succeed in their academic career.
- Learn about the college process as they are encouraged to think beyond middle and high school in an effort to realize that the tools they gain today will be beneficial in the near future
- Gain self-efficacy skills that will allow them to address the barriers of learning with resiliency

We have built an Advisory course into the master schedule to serve as a level 1 intervention using the Multi-Tiered System of Supports(MTSS). Using the MTSS, all students receive the core literacy and math courses as their Tier 1 instruction. In addition to the core courses, students who need more intensive intervention (Tier 2) and support with a lower student-to-teacher ratio are provided with math and literacy interventions classes. If the student continues to struggle, the Grade Level team will determine if there are specific individual interventions (Tier 3) necessary to address the student's needs or if a referral to the Student Success Team is required.

Our Clinical Services team provides individual, group and family therapy to the students and families, and serves as a Tier 2 and 3 intervention within the MTSS Framework. The main purpose of our clinical services program is to address the barriers to learning from the mental health perspective. In addition, we provide crisis intervention, parent consultation, teacher consultation, and case management which include providing resources and referrals to outside agencies.

In order to ensure services are provided free of charge, services are provided by pre- and post- graduate Marriage and Family Therapy, Psychology and Social Work interns who receive extensive training and supervision in exchange for their work. All services are supervised by one of our licensed Marriage and Family Therapists or Licensed Clinical Social Workers. Interns provide social and emotional counseling including small group and individual therapy.

The School Mental Health Services team uses a referral process for students to receive services. Once students and parents have consented to services, students will work with a School Mental Health Therapist or School Mental Health Intern (under the supervision of a Licensed Mental Health provider) that follows them through the process of services, and provides mental health services. Students are provided with assessments that measure symptoms of depression, anxiety, & trauma, along with other evidenced-based interventions during clinical psychotherapy. The School Mental Health Services team works with parents, staff, and students throughout the referral process to ensure they are aware of their options. School Mental Health Services provides a proactive approach to addressing the barriers of learning by utilizing prevention and wellness to enable our students to possess the necessary skills to navigate their academic and social skills.

The school will improve its entire educational program by investing in additional technology to increase its ratio of students to computers, additional special education services to support high needs students, and instructional material to increase support for classroom learning experience.

- The school will offer a spectrum of special education services that may include a resource program and special day program. The programs are designed to foster a high-quality program for students with special education needs. Additionally, our special education programs cultivate collaboration between general and special education teachers to guarantee that students with disabilities are integrated into the school to the maximum extent possible to allow them full access to all programs.
- The school will offer ELD courses to prepare Emergent Bilinguals recently arrived in the U.S. for success in English-medium instruction, including English Language Arts. Skills in all four strands of language listening, speaking, reading and writing are systematically developed. Students of mixed grade levels are grouped according to proficiency in English. Cultural knowledge needed for success in U.S. schools is integrated throughout. The Green Dot EL Master Plan includes the new CA ELD standards and a five step process for the identification of Emergent Bilinguals including: 1) Initial Identification, 2) EL Proficiency Assessment, 3) Primary Language Assessment, 4) Parent Notification, and 5) Program Placement. Green Dot schools provide on-going training for administrators and teachers on the identification process.
- All Emergent Bilinguals students are served in both Designated and Integrated ELD designed to meet their needs. Instruction is based on the CA ELD Standards and the Features of Designated and Integrated ELD. These programs are built into the school's

master schedule and take place within the school day. The school will work with the Human Resources (HR) Department to ensure appropriate staffing and authorizations for teachers in these courses.

 Technology is widely used at the school to drive higher levels of achievement and prepare students for the information driven economy of the 21st century. It is also used as a critical tool for gathering data for school management.

Technology investments will be made in the following areas:

- Increased computing devices (e.g., desktops, laptops, Chromebooks) that are available for student use;
- Each teacher is provided with a laptop and given training on effectively using technology in the classroom;
- Courses often include web-based research projects and assignments;
- Technology elective classes are included in the recommended curriculum to train students on computers and different software programs; and
- A web-based student information and school management system is implemented at the school and used by parents, students and school staff

A description of the plan for how the additional concentration grant add-on funding identified above will be used to increase the number of staff providing direct services to students at schools that have a high concentration (above 55 percent) of foster youth, English learners, and low-income students, as applicable.

The LEA received additional concentration grant funding due to its high percentage of unduplicated pupils, which is well above the 55% threshold for receiving these funds. The LEA has utilized the additional concentration grant add-on funding to hire and maintain staff at the school who provide direct services to students. We have used these funds to provide high impact tutoring services through the hiring of instructional aides, as well as to hire additional staff such as clinical supervisors, a homeless youth coordinator, attendance case managers, African American Support Specialists, push-in substitutes, and additional support staff to address the ongoing impact of COVID-19. Retention efforts for existing staff include increased mental health supports and additional professional development opportunities.

Goal 2, Actions 2.1, 2.2, 2.5 and 2.8 address this requirement, as well as Goal 3, Action 3.1, and Goal 4, Actions 4.1 and 4.2.

 - This percentage is calculated by dividing the Total Planned Contributing Expenditures (4) by the Projected LCFF Base Grant (1), converting
 the quotient to a percentage, and adding it to the Total Planned Percentage of Improved Services (5).

Contributing Actions Annual Update Table

 - o This amount is the total of the Planned Percentage of Improved Services column
- 8. Total Estimated Actual Percentage of Improved Services (%)
 - This amount is the total of the Estimated Actual Percentage of Improved Services column
- Difference Between Planned and Estimated Actual Percentage of Improved Services (Subtract 5 from 8)
 - This amount is the Total Planned Percentage of Improved Services (5) subtracted from the Total Estimated Actual Percentage of Improved Services (8)

LCFF Carryover Table

- 10. Total Percentage to Increase or Improve Services for the Current School Year (6 divided by 9 + Carryover %)
 - This percentage is the Estimated Actual LCFF Supplemental and/or Concentration Grants (6) divided by the Estimated Actual LCFF Base
 Grant (9) plus the LCFF Carryover Percentage from the prior year.
- 11. Estimated Actual Percentage of Increased or Improved Services (7 divided by 9, plus 8)
 - This percentage is the Total Estimated Actual Expenditures for Contributing Actions (7) divided by the LCFF Funding (9), then converting the quotient to a percentage and adding the Total Estimated Actual Percentage of Improved Services (8).
- 12. LCFF Carryover Dollar Amount LCFF Carryover (Subtract 11 from 10 and multiply by 9)
 - o If the Estimated Actual Percentage of Increased or Improved Services (11) is less than the Estimated Actual Percentage to Increase or Improve Services (10), the LEA is required to carry over LCFF funds.

The amount of LCFF funds is calculated by subtracting the Estimated Actual Percentage to Increase or Improve Services (11) from the Estimated Actual Percentage of Increased or Improved Services (10) and then multiplying by the Estimated Actual LCFF Base Grant (9). This amount is the amount of LCFF funds that is required to be carried over to the coming year.
