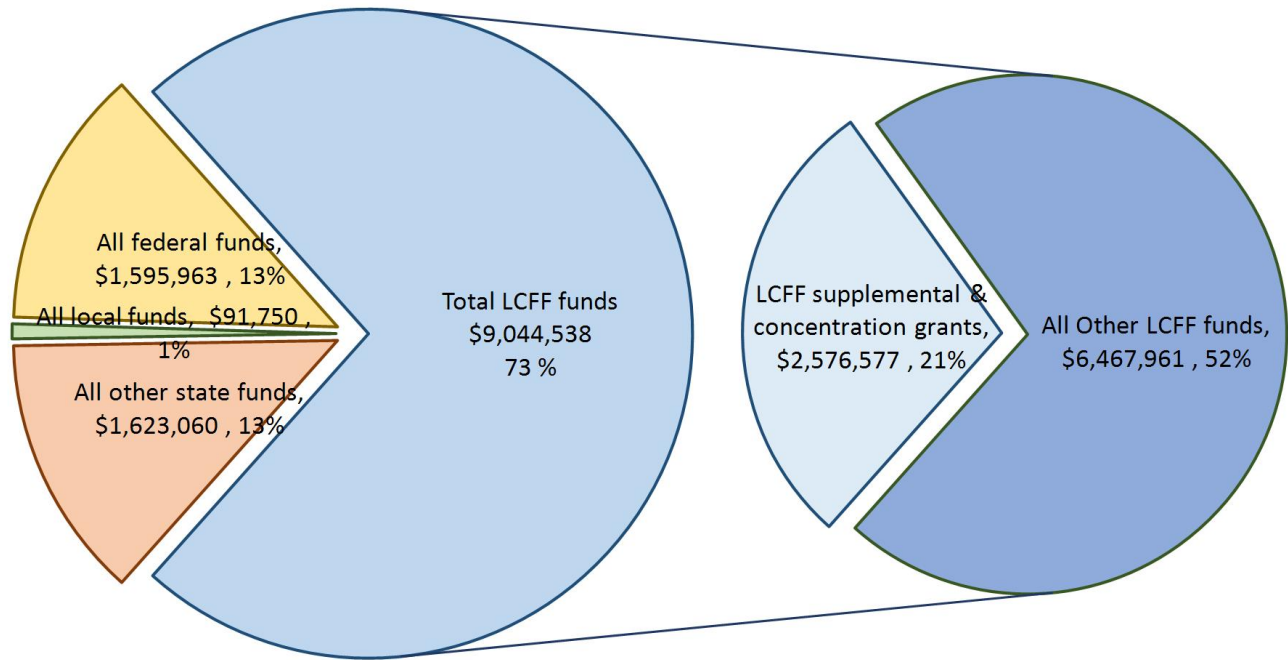

Projected Revenue by Fund Source



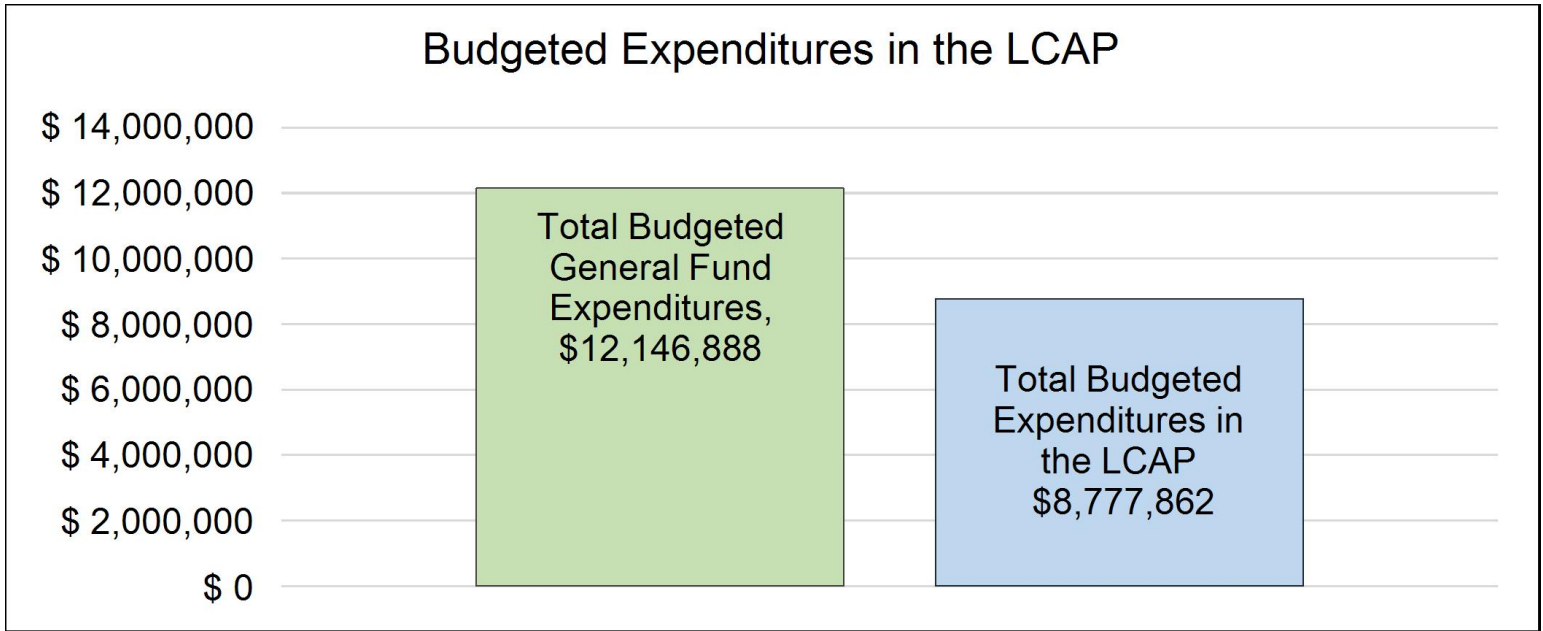
This chart shows the total general purpose revenue **Ánimo Pat Brown Charter High School** expects to receive in the coming year from all sources.

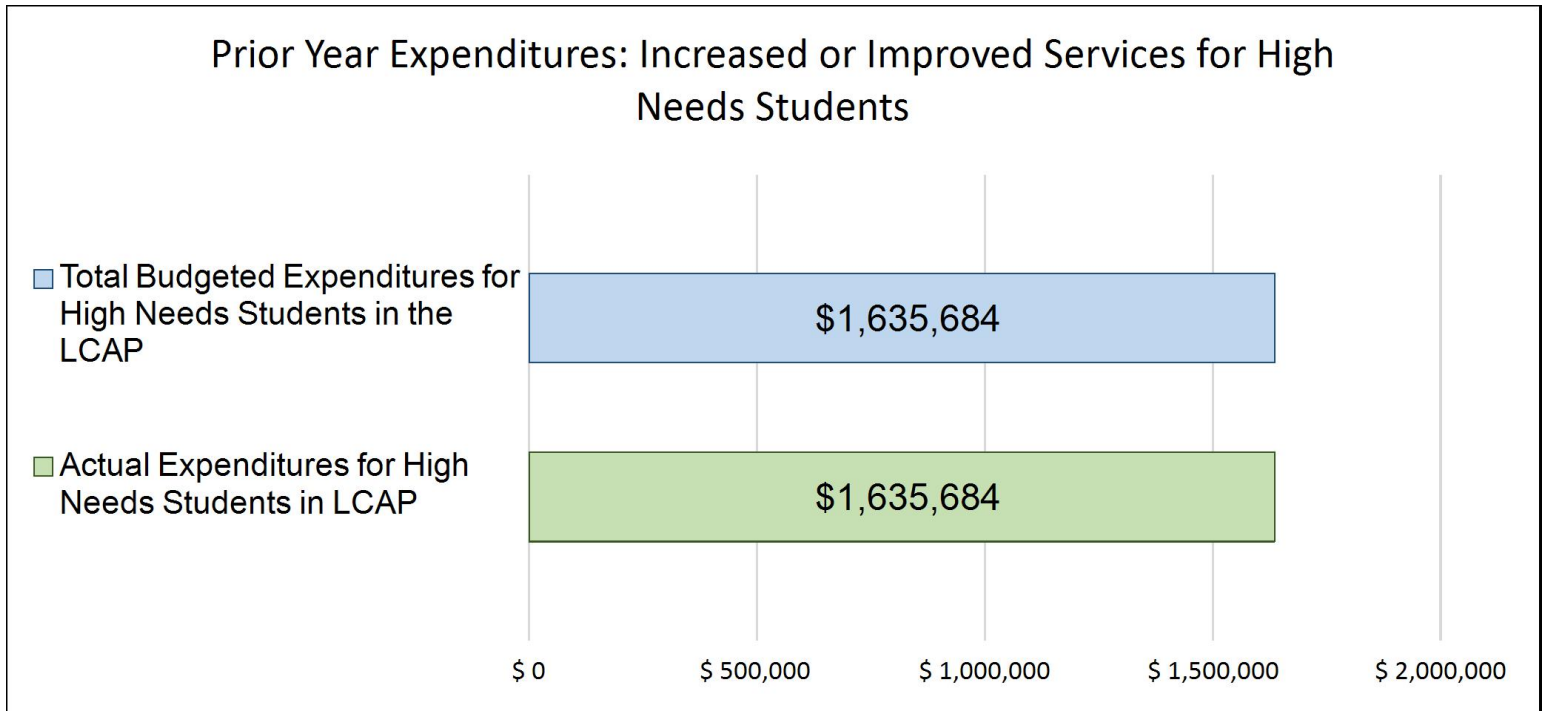

Plan Summary [2023-24]

General Information

A description of the LEA, its schools, and its students in grades transitional kindergarten–12, as applicable to the LEA.

Ánimo Pat Brown Charter High School (APB) is a public charter high school that is part of the Green Dot Public Schools California charter management organization. Ánimo Pat Brown, which is named for the former California governor who is credited with the creation of modern California through infrastructure initiatives, is committed to changing the landscape of public education so that every child can graduate from high school prepared for college, leadership, and life. Ánimo Pat Brown proudly serves the Florence-Firestone neighborhood and surrounding communities of South Los Angeles, providing free, high quality, college-prep education. The school opened in 2006 and currently serves approximately 600 students in grades 9 – 12. Demographically 98% of students are eligible for free or reduced price lunch, 12% are students with disabilities, and 16% are English Learners. 98% of students identify as Latinx. 11% of students are experiencing homelessness or housing insecurity.

To date, we have had 12 graduation ceremonies of approximately 150 students each year. In the 17 years APB has served the students of Florence Firestone and South Los Angeles, we have always been guided by one basic principle: What will best prepare our students? In order to best prepare them for the rigors of college, leadership, and life, all stakeholders are involved in our mission through a cycle of self-study, data analysis, and professional development. We expect that our students will be prepared for life after high school as self-directed individuals, critical thinkers, academic strivers, life-long learners, effective communicators, and civic actors.

Reflections: Successes

A description of successes and/or progress based on a review of the California School Dashboard (Dashboard) and local data.

Ánimo Pat Brown is proud to have achieved the best possible status rating on the 2022 California School Dashboard for school performance on Graduation Rate, English Learner Progress and Suspension Rate. In each of these areas, the school out-performed the state status levels.

On the Graduate Rate Indicator on the 2022 California School Dashboard report, APB earned a status level of Very High for All Students which is higher to the state's status level of Medium. The report shows that 98.0 percent of students graduated which is higher than the State at 87.4 percent. The status level of all three numerically significant student groups, English Learners, Hispanic students, and Socioeconomically Disadvantaged students is higher than the State's level for those student groups

On the English Learner Progress Indicator, APB earned a status level of Very High, which is higher than the State's Status level of Medium. The report shows that 72.3 percent of students are making progress towards English language proficiency which is higher than the State at 50.3 percent.

And on the Suspension Rate Indicator, APB earned a status level of Very Low for All Students which is below the state's status level of Medium. The report shows that 0.0 percentage of students were suspended for at least one day. Additionally, all five numerically significant student groups have Suspension Percentage rates lower than the state.

Reflections: Identified Need

Ánimo Pat Brown's 2022 California School Dashboard report on the school's performance in ELA indicates that the school has earned a Status level of Low for All Students which is similar to the state's Status level of Low. The report shows an average Distance from Standard (DFS) of -15.6 in ELA for the All Students group, which is higher than the State average of -12.2. Two of the school's numerically significant student groups, Hispanic and Socioeconomically disadvantaged, had a better DFS compared to the state average. English Learners and students with disabilities, however, had a DFS greater than the State's average DFS for that student group.

Ánimo Pat Brown's 2022 California School Dashboard report on the school's performance in Math indicates that the school has earned a Status level of Low for All Students which is similar to the state's Status level of Low. The report shows an average Distance from Standard (DFS) of -114.3 in Math for the All Students group, which is greater than the State average (DFS) of -51.7. All numerically significant student groups, English Learners, students with disabilities, Hispanic students, and Socioeconomically Disadvantaged students had a greater DFS compared to the State's average DFS for those student groups.

On the 2022 CA Dashboard, the school received a status of “Not Met” for all 5 local indicators. The school presented its findings regarding the local indicators to the public and Green Dot’s governing board. The local indicators were approved, along with the LCAP, by the Green Dot board on June 24, 2022. The school did not submit the local indicators by CDE deadline, therefore receiving a status level of “Not Met.” The school is continuously working to meet the local indicators of basic: teachers, instructional, materials facilities; implementation of academic standards; parent and family engagement; local climate survey; and access to broad course of study.

Ánimo Pat Brown’s LCAP demonstrates strong performance in many goal areas including the provision of basic services, preparation for college, leadership, and life, and stakeholder engagement.

Specific areas of strength include course offerings, quality of facilities, improved overall student performance on the CAST, low cohort dropout rate, high graduation and A-G rates, improved performance on Advanced Placement classes, low suspension rate and strong stakeholder engagement and satisfaction.

Areas of need include improved student performance on the ELA and math SBAC, improved average daily attendance, and decreased chronic absenteeism.

There are several ways that parents, teachers, and students influenced the LCAP. The LCAP was included in all School Advisory Council and DELAC meetings so educational partners have time to understand, reflect, prioritize, and determine school-wide strategic planning for the upcoming year. Those groups also monitor progress on current year strategic plans. In addition, the LCAP is included in our agendas for both Coffee With the Principal so that parents are able to understand and provide our admin team with input, feedback, and suggestions for improvement that meets the needs of their children. Teachers also give input by department and through grade level teams on instructional priorities. Our School Culture team provides oversight for the "Focus on School Culture" goals. The Instructional Leadership Team reviews the "Proficiency for All" and the "Preparation for College, Leadership, & Life" goals.

The School's efforts began in the fall of 2022 when the School Principal and Operations and Finance Manager reviewed the 2022-23 LCAP with the School Advisory Council ("SAC"). Since the first SAC meeting, the Principal referred to the LCAP and its goals during subsequent SAC meetings to ensure the LCAP was kept top of mind. The SAC is comprised of administrators, teachers, counselors, classified staff members, parents and students. The SAC also includes representation from the Asociación de Maestros Unidos, the union that represents Green Dot's certificated staff. All parents were also invited to participate in a Google Form LCAP survey sent to families by text message.

The Green Dot Public Schools Home Office ("Green Dot Home Office"), including members of the Education, Knowledge Management, Policy & Public Affairs, Finance & Accounting and Operations teams, provided the School with updated data for each goal to help monitor and track progress. The Principal reviewed the updated data with the SAC and reflected on changes from the previous year.

In conjunction with the different educational partner groups, the Green Dot Home Office worked with School Leadership to update the 2023-24 LCAP, taking into account the progress, revisions to actions/services, and updates to future expenditures.

Goal Analysis [2022-23]

An analysis of how this goal was carried out in the previous year.

A description of any substantive differences in planned actions and actual implementation of these actions.

Ánimo Pat Brown Charter High School maintained compliance with teachers being appropriately credentialed in their subject area and for the pupils they are teaching. We also maintained a broad course of study with standards-aligned materials and additional instructional materials and to the educational program as outlined in the school's charter petition. In the 2022-23 school year, Ánimo Pat Brown added additional elective courses including Digital Art and Project Lead the Way: Computer Science Essentials. Ánimo Pat Brown has continued transitioning into its new facility and made significant improvements including an exterior basketball court, netting between the soccer field and staff parking lot, adjustments to the front driveway to ensure a clear path of pedestrian traffic, and privacy enhancements on the blacktop gate adjacent to Beach Street. Student-created murals that were previously hung in the former school building have been reinstalled under a transparent, protective surface. Additional school branding aligned with the school mission was also installed in the gym and main entrance hallways. A wide range of college banners and flags are also now on display in hallways. The school facility is in excellent condition with additional improvements to improve the student experience planned.

There were no material differences between the budgeted expenditures and estimated actual expenditures for this goal.

Green Dot Human Resources and Human Capital reviewed teacher, counselor and administrator credentials, background checks and TB clearances at hire and at least once throughout the year to ensure all credentials are properly maintained. In addition, Green Dot Human Resources and Human Capital work with employees on appropriate renewals for credentials and other requirements.

School operations conducts regular walkthroughs of the school facilities to quickly identify repair and maintenance needs. Stakeholders participate in collaborative discussions in a variety of venues to identify additional improvements that would benefit the school facilities in service of our mission.

A description of any changes made to the planned goal, metrics, desired outcomes, or actions for the coming year that resulted from reflections on prior practice.

Ánimo Pat Brown Charter High School will further expand its course offerings by adding AP Computer Science as an elective available to all students who have completed the beginning-level Computer Science course or who have otherwise demonstrated prerequisite knowledge of coding.

Planned improvements to the school facility include the addition of built-in storage cabinets in two science classrooms as well as the drama classroom. Flexible furniture and staging equipment will also be added to the drama class to allow for easier transitions for classroom performances. The school plans to add an electronic scoreboard in the gym for use during athletic competitions.

Additional campus beautification efforts are planned for the coming school year including the addition of outdoor landscaping planters that will be painted by students enrolled in visual art. The school will also identify additional ways to display student artwork in public spaces. The school will also identify ways to display school branding, particularly the school logo, on the exterior of the building.

A description of any substantive differences in planned actions and actual implementation of these actions.

In relation to our “Proficiency for All” data, there are successes and challenges reflected in the available data. The percentage of students scoring proficient and above on SBAC ELA and Math assessments are essentially flat between the pre-Pandemic data and 2021-22 data for both the school as a whole and statistically significant subgroups of students, with the exception of housing insecure students. The school did however significantly increase the percentage of students scoring proficient on the CAST however, increased from 11.5% in the 2018-19 school year to 23% in the 2021-22 school year. Students who are not yet English proficient and students with disabilities, however did not

experience that same improvement on the CAST however. The school also significantly improved the percentage of students growing at least one ELPI level, growing from 37% in 2018-19 to 72% in 2021-22.

An explanation of how effective the specific actions were in making progress toward the goal.

Our core activity as a school to support Goal 2: Proficiency for all is through our rigorous Common Core-aligned curriculum, which includes reading, writing, and discussion in all content areas. We will also maintain our 9-12th grade advisory program, which provides students with college and career knowledge, academic counseling, standardized test preparation, and frequent opportunities for guided reflection of students' individual academic progress.

Professional Development at the school prioritizes department and grade level collaboration around an intellectual preparation protocol and student work analysis, with a particular focus on ensuring all students are using the language of the discipline on a daily basis. Teachers participate in professional development opportunities rooted in resources available on ELLevation, an educational platform that is specifically designed to provide teachers with strategies on how to provide high quality instruction, with particular attention to the strengths and needs of students who are English Learners. While these resources are intended as a targeted support for students who are English learners, they are valuable resources to support the learning of all students. Through these professional developments, our staff has been able to broaden its knowledge and skill in explicit language instruction so that students are able to verbalize their learning, thereby deepening their understanding of new knowledge and skills.

The ELLevation platform also empowers teachers to differentiate their instruction by using the students' English Learner data to determine the appropriate scaffolds individual students will need to support their learning. Through the platform, teachers have the ability to categorize leveled supports for students and instructional moves are strategically targeting a student's Zone of Proximal Development. Teachers also leverage the data in ELLevation and the diversity of learners in each classroom to create collaborative groups to ensure that there is precision pairing or grouping to support learning for all. Aside from ELLevation, the English Learner Lead and co-teacher supporting students who are English Learners with an IEP have been providing all staff with training on how to embed opportunities for students to engage in meaningful academic discourse and listening as well as how to appropriately accommodate for English Learners.

Additionally, to support students who are English Learners reclassifying as Fully English Proficient and to increase the percentage of of students growing at least one ELPI level, the school implements a strong co-teaching model in our designated program that focuses on differentiated small group instruction, rigorous standards-based curriculum with resources specifically designed for English Learners, stronger collaboration between English Learner Lead, Special Education Department, and General Education teachers. The school has also

Improved the reclassification progress, particularly through the IEP progress and increasing collaboration with the Special Education Department. Throughout the school year, the administrator over ELD programming has been consulting with the Special Education case carrier/team and the SEPA to determine whether these students should be reclassified at their next IEP meeting via the LTEL IEP Reclassification Process.

A description of any changes made to the planned goal, metrics, desired outcomes, or actions for the coming year that resulted from reflections on prior practice.

In order to ensure the school is achieving the goal of Proficiency for All, staff professional development and collaboration will remain focused on intellectual preparation, student work analysis, and academic discourse that is aligned with teaching and learning at the appropriate level of grade-level, standards-based rigor.

Additionally, the school will continue to address the whole child through a rigorous Multi-Tiered Systems of Supports that involves the collecting of relevant data for individual and subgroups of students in order to provide the appropriate universal, targeted, and intensified supports that are most appropriate in a given context. Particular attention will be paid to analyzing the impact of universal, tier 1 supports for students to ensure that those systems are effectively meeting the needs of at least 80% of the student body before going onto identifying additional supports. During the multiple progress monitoring processes that take place in a variety of contexts at the school, all stakeholders will collaborate on identifying additional support for individual and sub-groups of students for intensified academic support (one-on-one conferences, SSTs), additional or intensified social-emotional support via COST, attendance intervention due to chronic absences via the Student Services and Operations Associate addresses attendance.

There was a change made to Action 2.3 – Special Education. During the pandemic, students with disabilities had access to transportation in order to provide services per their Individualized Education Plan (IEP). Transportation was provided for students with disabilities because in SY 2020-21, distance learning was in full effect, and these students needed access to IEP services. Since the pandemic, SY2021-22 was the first full year of in-person instruction and IEP services were provided on campus.

Ánimo Pat Brown Charter High School has met all metrics in Goal 3: maintain low cohort dropout rate, maintain high graduation rate, maintain high AG-graduation rate, and increase the percent of Advancement Placement passing scores. In addition to meeting all of those goals as a school, all statistically significant subgroups met them as well.

The staff of Ánimo Pat Brown has an abiding belief in the ability of all students to graduate A-G. Through our focus on Intellectual Preparation and Student Work Analysis the instructional staff of the school remains focused on backwards planning with an emphasis on rigorous grade-

level instruction. Through our mastery-based grading policies, students consistently have multiple opportunities to demonstrate mastery of grade level standards. Teachers routinely use the results of formative and summative assessments to adjust teaching and learning to ensure all students have the ability to pass their classes the first time and make progress toward graduation and A-G eligibility. Additionally, our academic counselors consistently use current and historical data to provide additional support to students who may be lagging behind in A-G credits. Counselors work alongside them and their families as soon as a need emerges. The school has also added additional course offerings for students to expand the range of college-preparatory electives they are able to take in high school. Those courses include Project Lead the Way: Computer Science Essentials, Digital Art, and dual enrollment college classes taught during the school day in partnership with East Los Angeles College.

A description of any changes made to the planned goal, metrics, desired outcomes, or actions for the coming year that resulted from reflections on prior practice.

In order to maintain a high level of achievement on the Goal 3 metrics, Ánimo Pat Brown will be supplementing its existing professional development program to ensure new teachers and teachers of AP courses receive targeted PD and collaboration opportunities to develop the knowledge and skills necessary for their unique positions. Additionally, APB will add another AP course in the 2023-24 school year: AP Computer Science. As interest grows in the existing Dual Enrollment college program with East Los Angeles College, the school will seek to expand the number of sections of that course offered to students during the school day to ensure all interested students have access to this program.

Metrics 3F – CTE, 3G– CTE & A-G, and 3H – EAP, were added to be aligned with state requirements. The metrics were not added the year before because there is no data available for Metrics 3F and 3G. Currently, there is no data available because the school does not offer an approved CTE pathway. As for Metric 3H – EAP, there is no data available for SY20-21 and SY21-22 because the graduating classes of 2021 and 2022 did not test in the 11th grade due to the COVID-19 pandemic. The class of 2020 was the last class to have tested in the 11th grade. The data for the 2020 class was used as the baseline for the metric 3H – EAP.

A description of any substantive differences in planned actions and actual implementation of these actions.

With respect to Goal 4: Focus on School Culture, we have maintained a zero percent suspension rate and zero percent expulsion rate. Following the full resumption of in person learning, we have experienced an increase in chronic absenteeism (33%) and a decrease in Average Daily Attendance (88%). Of our statistically significant student groups, African American students had the lowest average daily attendance (61%) and the highest chronic absenteeism (100%). Students who are English learners and students with disabilities also had below average attendance compared to the school population as a whole (84% and 83% respectively) and a slightly higher rate of chronic absenteeism (39% and 40% respectively).

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

There were no material differences between the budgeted expenditures and estimated actual expenditures for this goal.

An explanation of how effective the specific actions were in making progress toward the goal.

Ánimo Pat Brown Charter High School has been working relentlessly to reduce chronic absenteeism by working with our School Leadership Team, counselors, and student support staff to determine the cause of student absences and identify interventions and supports to help students get to school everyday. Strategies employed range from having regular meetings with students who are chronically absent and implementing incentives when they achieve certain benchmarks. Parent communication and involvement is also a key factor and lever we are continuing to use. The school has added additional staff to address this need, including a Student Services and Operations Associate, who meets individually and in small groups with students who are chronically absent to set short and long term goals to improve their attendance. Other new staff who support students in resolving challenges that are impacting their ability to be at school everyday include an additional counselor, psychologist, mental health therapist, and Student Support Specialist. The school has added additional weekly incentives for perfect attendance including free dress every Friday for students who are at school everyday Monday through Thursday and who are not late to more than one class period during the week.

A description of any changes made to the planned goal, metrics, desired outcomes, or actions for the coming year that resulted from reflections on prior practice.

Improving student attendance and reducing chronic absenteeism are one of the chief priorities for the school in the new year. To improve parent awareness of attendance trends and overall communication between the school and home, the school will be transitioning to a new

parent communication hub, ParentSquare, which has enhanced, two-way communication features. Additionally, the school will be adding additional opportunities for parents and families to volunteer at campus during the school day and for special occasions to increase family visibility on campus and create a strong sense of community to motivate students to do their best at all times. One of the enhanced features of ParentSquare that will support these volunteer opportunities is the ability to enable volunteer sign ups for calendar events. The school will more easily be able to inform parents of upcoming events and the opportunities they will have to support those events.

With respect to Goal 5: Parent, Student and Community Engagement, we met all of our metrics. We hosted more than 4 School Advisory Council meetings and more than 2 DELAC meetings during the school year. On an annual internal family survey, 97% of families gave a positive rating on the a “Would you recommend this school to a friend?” question, far exceeding the goal of 80%. Additionally, 100% of staff provided a positive rating on an internal staff survey on “I feel successful in my role: I am developing my professional practice, seeing growth in students I serve, and enjoying my work in this community.

An explanation of how effective the specific actions were in making progress toward the goal.

The school has been successful in achieving all metrics in this goal. The calendar for Coffee with the Principal, SAC, and DELAC meetings are scheduled and publicized at the start of the year to ensure interested families are able to participate. School staff maintain consistent communication with the stakeholders who are involved in these teams to remind them of meeting dates. The school provides regular updates and reminders to parents about important school events through an automated text message system as well as through social media. The main office pursues a customer-service orientation when addressing parent concerns and questions. Additionally, teachers provide regular updates to families about student progress in their classes through the same text message system. School administration also regularly engages teachers and staff in small group and individual feedback sessions to ensure staff are able to share suggestions and ask questions so that they can continue to feel successful and empowered in their roles as educators. School administration also collects weekly feedback

from teachers and counselors at the end of professional development sessions to ensure that collaboration opportunities are aligned to the school's mission and staff professional development needs.

A description of any changes made to the planned goal, metrics, desired outcomes, or actions for the coming year that resulted from reflections on prior practice.

In the next school year we will be transitioning to a new parent communication platform, "ParentSquare" which has increased functionality to better meet the needs of parents and the school. The school will also be identifying additional opportunities for parents to volunteer on campus and attend school events.

For the goal of not meeting 80% for parents who would recommend the school to a friend, we did not send out the survey to families and that is why we received 0%. This upcoming school year, we plan to send it out to families so that we can reach our goal and gain insightful feedback from parents.

Required Descriptions

For each action being provided to an entire school, or across the entire school district or county office of education (COE), an explanation of (1) how the needs of foster youth, English learners, and low-income students were considered first, and (2) how these actions are effective in meeting the goals for these students.

Given the high percentage of unduplicated pupils at the school, the funds will be spent on improving the charter-wide educational program and meeting the academic goals specified earlier in the LCAP. The needs of low-income students are largely met based on the charter-wide educational model, with additional services provided for foster youth and Emergent Bilinguals. In order to meet the needs of its diverse student population the school will implement Green Dot’s academic model with fidelity.

The model outlines the framework that allows Green Dot teachers and administrators to be successful and focuses on four key elements: 1) Ensuring Quality Teaching and Instruction, 2) Cultivating a College-going Culture, 3) Eliminating Barriers to Learning, and 4) Promoting Leadership and Life Skills. Implementation strategies are provided in the areas of curriculum, student intervention, professional development, parent participation and school operations to help principals and teachers make the most informed decisions for their schools.

1. Ensuring Quality Teaching & Instruction: Dedicated, effective teachers with a passion for their work and their students are at the heart of the Green Dot model. Green Dot ensures high quality teaching and instruction in every classroom through its research-based methods of instruction, teacher effectiveness initiatives and robust professional development and support. The College-Ready Teaching Framework

("CRTF") – a rubric that defines the core competencies expected of all Green Dot teachers is the foundation of the evaluation system. In addition, teachers will be able to pursue professional development and coaching support from the Instructional Coaches as well as from the Green Dot Home Office Education Team.

2. **Cultivating a College-going Culture:** Green Dot strives to attain high college acceptance rates by creating a culture of college-for-certain. School leaders create systems for ongoing academic counseling with counselors and advisors and offering college tours at every grade level. In addition, the school master schedule offers elective courses that support core content development (i.e., drama), as well as pre-AP pathways (i.e., honors courses in high school). Courses are structured to build students' key cognitive strategies: intellectual openness, analysis, reasoning, accuracy and precision, and interpretation. School classrooms demonstrate the successful implementation of behavior management strategies. Support is provided to build key behaviors necessary for success in high school and college, such as self-monitoring, persistence, independent preparation abilities, and college-level study skills. Lastly, all Green Dot schools provide support to build students' contextual awareness of college systems and culture.

3. **Eliminating Barriers to Learning:** Students come to Green Dot from a variety of backgrounds. Academically, many are far behind grade-level. Socially and emotionally, many require emotional guidance in order to be able to succeed academically. Green Dot strives to provide the academic intervention, counseling and clinical services necessary to break down these barriers. Green Dot school leaders successfully implement all three tiers of the Multi-Tiered System of Supports by appropriately providing intervention in Literacy, Math, English Language Development and Special Education. Green Dot schools offer an Advisory program that provides academic guidance, school culture & safety; college and career; and personal development. Additionally, each school provides a menu of wrap-around services: mental health supports and psychological services; counseling groups; mentoring programs; supports for foster youth and students experiencing homelessness; and links to community partners for health and wellness programs.

4. **Promoting Leadership & Life Skills:** Green Dot aims to provide students with a broad set of tools, behaviors and skills to prepare them for college and beyond. Systems for student leadership such as student government, student ambassador program, student mentorship, and the Principal's Advisory Committee give students internal leadership experience. External experience is available through partnerships with community programs, including public speaking opportunities, job shadowing, volunteer work, mentorships, and summer internships. Advisory programs teach and promote life skills and help to reduce dropouts, foster youth development, enhance academic achievement, and promote whole-being development.

A description of how services for foster youth, English learners, and low-income students are being increased or improved by the percentage required.

"The schools' educational program will successfully meet the needs of its foster youth, Emergent Bilinguals and low-income student population. Examples of these supports include:

- Implementation of all three tiers of the Multi-Tiered System of Supports in Literacy, Math, English Language Development and Special Education
- Intensive interventions for students requiring additional enrichment and support, including Literacy Enrichment, Math Foundations, individualized tutoring, classroom push-in and co-teaching models and small strategic groupings
- An Advisory program for all students to prepare them with the tools and behaviors to succeed in high school, college, leadership and life – covering topics such as: academic preparation, promotion of college awareness, developing strong peer relationships, developing life skills in areas such as resilience/grit, growth mindset, organization, communication, health/nutrition and personal finance
- Integrated wraparound services to help address social and non-academic barriers to student learning including small group counseling and individual student counseling. Foster youth and students experiencing homelessness are provided services and supports tailored to their individualized needs including uniform and transportation assistance and navigation to community resources such as housing, food, and mental health services.
- Proactive and positive student behavior management, including various alternatives to suspension
- Opportunities for students to explore student leadership and other interests through participation in elective courses, student government, after-school programs and clubs
- Special education programs that cultivate collaboration between general and special education teachers to guarantee that students with disabilities are integrated into the school to the maximum extent possible to allow them full access to all programs.

The school has developed a research-based curriculum appropriate to the student demographics it serves that includes the following: course offerings, textbooks, curriculum maps, pacing guides, sample lesson plans, interim assessments and intervention programs. The model is derived from the following continuum of research-based practices:

- Planning and Preparation: Based on Essential Elements of Effective Instruction by Madeline Hunter. Madeline Hunter developed the teacher "decision-making model" for planning instruction known as Instructional Theory in Practice ("ITIP"). This approach to

teaching uses Direct Instruction (“DI”) as the framework for planning. DI refers to a rigorously developed, highly scripted method that is fast-paced and provides constant interaction with students.

- **Assessment and Learning:** Based on *Understanding by Design: Backwards Design* by Jay McTighe and Grant Wiggins. The emphasis of Understanding by Design (“UbD”) is on “backward design,” the practice of identifying the desired outcomes in order to design curriculum units, performance assessments and classroom instruction that will enable students to achieve these outcomes. The backward design approach is developed in three stages. Stage 1 starts with educators identifying the desired results of their students by establishing the overall goal of the lessons by using content standards, common core or state standards. Stage 2 focuses on evidence of learning by assessment. Teachers plan performance tasks and evidence of understanding. Performance tasks determine what the students will demonstrate in the unit and what evidence will prove their understanding. This can include self-reflections and self-assessments on learning. Lastly, Stage 3 lists the learning activities that will lead students to the desired results.
- **Instructional Techniques:** Based on *Teach Like a Champion* by Doug Lemov. *Teach Like a Champion* offers effective teaching techniques to help teachers become champions in the classroom. Additional details provided in the section entitled “Instructional Design, Methods and Strategies.”
- **Classroom Environment:** Based on “*Safe and Civil Schools*” by Randy Sprick. *Safe & Civil* provides high-quality programs and staff development services to help educators create proactive and positive behavior management strategies in schools. In addition, a focus on Restorative Practices provides schools with the resources to build community amongst staff and students. School site walk-throughs with administrators, teacher - leaders and members of the Green Dot Home Office Education Team are scheduled regularly to observe discipline and school culture. Findings from these sessions are compiled to create school-specific professional development for teachers and the necessary support to create an environment where students can learn and where teachers can teach.
- **Culturally Responsive Pedagogy:** Green Dot Public Schools believes that culturally responsive pedagogy can increase student engagement, provide access to content, and as a result, bolster feelings of confidence and understanding in students. School leaders and teachers have read Zaretta Hammond’s *Culturally Responsive Teaching and the Brain* and use her Ready for Rigor framework to work towards a culturally responsive classroom experience for all students.

Academic Support and Intervention is based on incoming student need and a schedule of intervention and acceleration courses will be available to students so that all students can complete the required courses:

- Summer Bridge: Summer Bridge is a recommended multi-week summer program that acclimates students to the culture of the school, high expectations and the development of a trusting community. During the Summer Bridge program, students will also be identified for special needs, English Learner levels, non-proficiency in standards and social-emotional supports, and staff will make the necessary adjustments to the master schedule to better accommodate them. Students receive standards-based instruction in Math and English Language Arts and are acclimated to the culture and expectations of the school. Students will engage in culture-building exercises that promote a positive community of trust and respect. Social and personal issues will also be surfaced in small group settings complemented with educational field trips.
- Literacy Intervention/Enrichment (Read 180): Literacy Intervention/Enrichment is a standards-aligned program for reading that is provided to students that test low in reading. Typically, this course is given to students through an elective class.
- Math Foundations: Students who are struggling in Math (not proficient and/or recommended by their Math teachers) will receive an additional period of Math support, where their teacher and tutors will work on skill building through their current curriculum, as well as remediation strategies to strengthen skills in group tutorial and one-on-one formats.
- Designated and Integrated English Language Development (ELD): Designated ELD classes are provided for all English Learner students and Integrated ELD is provided in all other content classes throughout the school day for Emergent Bilinguals. Designated ELD focuses on listening, speaking, reading and writing skills in English with the CA ELD Standards and Features of Designated ELD driving instruction. Integrated ELD focuses on academic content and English language skills in tandem so that Emergent Bilinguals practice English language skills with academic content in all classes.
- Special Needs/Academic Success: Designated SPED students will be provided extra support to reflect the needs outlined in the Individualized Education Plan (IEP) and in all of their academic courses through one-on-one instruction, group support and guided instruction.
- Homework Club: Students who are struggling with a particular class or want more support in a subject can attend Homework Club, which is offered an hour every day after school and run by a credentialed teacher and/or college interns.
- Office Hours: Teachers hold office hours twice a week before and after school to provide additional support.
- After School Program: Students who are not achieving a satisfactory grade within a particular class or simply want more support in a subject can attend tutoring, which is offered for an hour every day after school.

Social and Life Skills Development is a key component of the school meeting the diverse needs of its student population including the establishment of an advisory course and clinical services available to all students.

Students will participate in an Advisory class with the same group of students for their school career to maintain a tighter sense of community. Advisory serves as a structured time and space for students to reflect on their learning and to discuss the connection between learning and life-long success. Advisory activities are organized around four pillars: 1) school culture and safety, 2) academics, 3) social life skills and 4) civic engagement. During Advisory, students will:

- Discuss issues related to the pressures of being a young adult including but not limited to puberty, relationships, mental health, family, substance abuse, etc.
- Acquire different study skill strategies, test-taking strategies and communication tools that will enable them to succeed in their academic career.
- Learn about the college process as they are encouraged to think beyond middle and high school in an effort to realize that the tools they gain today will be beneficial in the near future
- Gain self-efficacy skills that will allow them to address the barriers of learning with resiliency

We have built an Advisory course into the master schedule to serve as a level 1 intervention using the Multi-Tiered System of Supports(MTSS). Using the MTSS, all students receive the core literacy and math courses as their Tier 1 instruction. In addition to the core courses, students who need more intensive intervention (Tier 2) and support with a lower student-to-teacher ratio are provided with math and literacy interventions classes. If the student continues to struggle, the Grade Level team will determine if there are specific individual interventions (Tier 3) necessary to address the student's needs or if a referral to the Student Success Team is required.

Our Clinical Services team provides individual, group and family therapy to the students and families, and serves as a Tier 2 and 3 intervention within the MTSS Framework. The main purpose of our clinical services program is to address the barriers to learning from the mental health perspective. In addition, we provide crisis intervention, parent consultation, teacher consultation, and case management which include providing resources and referrals to outside agencies.

In order to ensure services are provided free of charge, services are provided by pre- and post- graduate Marriage and Family Therapy, Psychology and Social Work interns who receive extensive training and supervision in exchange for their work. All services are supervised by one of our licensed Marriage and Family Therapists or Licensed Clinical Social Workers. Interns provide social and emotional counseling including small group and individual therapy.

The School Mental Health Services team uses a referral process for students to receive services. Once students and parents have consented to services, students will work with a School Mental Health Therapist or School Mental Health Intern (under the supervision of a Licensed Mental Health provider) that follows them through the process of services, and provides mental health services. Students are provided with assessments that measure symptoms of depression, anxiety, & trauma, along with other evidenced-based interventions during clinical psychotherapy. The School Mental Health Services team works with parents, staff, and students throughout the referral process to ensure they are aware of their options. School Mental Health Services provides a proactive approach to addressing the barriers of learning by utilizing prevention and wellness to enable our students to possess the necessary skills to navigate their academic and social skills.

The school will improve its entire educational program by investing in additional technology to increase its ratio of students to computers, additional special education services to support high needs students, and instructional material to increase support for classroom learning experience.

- The school will offer a spectrum of special education services that may include a resource program and special day program. The programs are designed to foster a high-quality program for students with special education needs. Additionally, our special education programs cultivate collaboration between general and special education teachers to guarantee that students with disabilities are integrated into the school to the maximum extent possible to allow them full access to all programs.
- The school will offer ELD courses to prepare Emergent Bilinguals recently arrived in the U.S. for success in English-medium instruction, including English Language Arts. Skills in all four strands of language – listening, speaking, reading and writing – are systematically developed. Students of mixed grade levels are grouped according to proficiency in English. Cultural knowledge needed for success in U.S. schools is integrated throughout. The Green Dot EL Master Plan includes the new CA ELD standards and a five step process for the identification of Emergent Bilinguals including: 1) Initial Identification, 2) EL Proficiency Assessment, 3) Primary Language Assessment, 4) Parent Notification, and 5) Program Placement. Green Dot schools provide on-going training for administrators and teachers on the identification process.
- All Emergent Bilinguals students are served in both Designated and Integrated ELD designed to meet their needs. Instruction is based on the CA ELD Standards and the Features of Designated and Integrated ELD. These programs are built into the school's

master schedule and take place within the school day. The school will work with the Human Resources (HR) Department to ensure appropriate staffing and authorizations for teachers in these courses.

- Technology is widely used at the school to drive higher levels of achievement and prepare students for the information driven economy of the 21st century. It is also used as a critical tool for gathering data for school management.

Technology investments will be made in the following areas:

- Increased computing devices (e.g., desktops, laptops, Chromebooks) that are available for student use;
- Each teacher is provided with a laptop and given training on effectively using technology in the classroom;
- Courses often include web-based research projects and assignments;
- Technology elective classes are included in the recommended curriculum to train students on computers and different software programs; and
- A web-based student information and school management system is implemented at the school and used by parents, students and school staff "

A description of the plan for how the additional concentration grant add-on funding identified above will be used to increase the number of staff providing direct services to students at schools that have a high concentration (above 55 percent) of foster youth, English learners, and low-income students, as applicable.

The LEA received additional concentration grant funding due to its high percentage of unduplicated pupils, which is well above the 55% threshold for receiving these funds. The LEA has utilized the additional concentration grant add-on funding to hire and maintain staff at the school who provide direct services to students. We have used these funds to provide high impact tutoring services through the hiring of instructional aides, as well as to hire additional staff such as clinical supervisors, a homeless youth coordinator, attendance case managers, African American Support Specialists, push-in substitutes, and additional support staff to address the ongoing impact of COVID-19. Retention efforts for existing staff include increased mental health supports and additional professional development opportunities.

Goal 2, Actions 2.1, 2.2, 2.5 and 2.8 address this requirement, as well as Goal 3, Action 3.1, and Goal 4, Actions 4.1 and 4.2.

However, because of the significantly lower attendance rate of low-income students, and because the actions meet needs most associated with the chronic stresses and experiences of a socio-economically disadvantaged status, we expect that the attendance rate for our low-income students will increase significantly more than the average attendance rate of all other students. (Measurable Outcomes [Effective In])

 - This percentage is the total of the Planned Percentage of Improved Services column
- Planned Percentage to Increase or Improve Services for the coming school year (4 divided by 1, plus 5)
 - This percentage is calculated by dividing the Total Planned Contributing Expenditures (4) by the Projected LCFF Base Grant (1), converting the quotient to a percentage, and adding it to the Total Planned Percentage of Improved Services (5).

Contributing Actions Annual Update Table

Pursuant to *EC* Section 42238.07(c)(2), if the Total Planned Contributing Expenditures (4) is less than the Estimated Actual LCFF Supplemental and Concentration Grants (6), the LEA is required to calculate the difference between the Total Planned Percentage of Improved Services (5) and the Total Estimated Actual Percentage of Improved Services (7).  - This amount is the Total Estimated Actual Expenditures for Contributing Actions (7) subtracted from the Total Planned Contributing Expenditures (4)
- 5. Total Planned Percentage of Improved Services (%)
 - This amount is the total of the Planned Percentage of Improved Services column
- 8. Total Estimated Actual Percentage of Improved Services (%)
 - This amount is the total of the Estimated Actual Percentage of Improved Services column
- Difference Between Planned and Estimated Actual Percentage of Improved Services (Subtract 5 from 8)
 - This amount is the Total Planned Percentage of Improved Services (5) subtracted from the Total Estimated Actual Percentage of Improved Services (8)

LCFF Carryover Table

- 10. Total Percentage to Increase or Improve Services for the Current School Year (6 divided by 9 + Carryover %)
 - This percentage is the Estimated Actual LCFF Supplemental and/or Concentration Grants (6) divided by the Estimated Actual LCFF Base Grant (9) plus the LCFF Carryover – Percentage from the prior year.
- 11. Estimated Actual Percentage of Increased or Improved Services (7 divided by 9, plus 8)
 - This percentage is the Total Estimated Actual Expenditures for Contributing Actions (7) divided by the LCFF Funding (9), then converting the quotient to a percentage and adding the Total Estimated Actual Percentage of Improved Services (8).
- 12. LCFF Carryover — Dollar Amount LCFF Carryover (Subtract 11 from 10 and multiply by 9)
 - If the Estimated Actual Percentage of Increased or Improved Services (11) is less than the Estimated Actual Percentage to Increase or Improve Services (10), the LEA is required to carry over LCFF funds.

The amount of LCFF funds is calculated by subtracting the Estimated Actual Percentage to Increase or Improve Services (11) from the Estimated Actual Percentage of Increased or Improved Services (10) and then multiplying by the Estimated Actual LCFF Base Grant (9). This amount is the amount of LCFF funds that is required to be carried over to the coming year.

- 13. LCFF Carryover — Percentage (12 divided by 9)
