3.0 Agenda:

4.0 Minutes:

5.0 **Principal's Report:**

The Principal's report was presented by Jennifer Fedele. Principal Fedele particularly presented the board with all new staff members, lottery update, the continuous recruitment efforts and the book fair update. She also informed the board about the biggest project of the school which is overall alignment in curriculum, the need for continuity and working on a gifted program because there are currently some students that are above grade level. PTC was held virtual and in-person with a great turnaround. Spring Academy is going to happen for students to prepare for upcoming State tests. An order of 100 laptops was placed for students which provide a safety net to ensure all students have access to technology. CMCCS is also pairing with Mercy College Nursing Program for health and wellness activities for students. The school is also working with Fordham University for training for staff. Christian Adamkiewicz updated the board on survey responses.

6.0 <u>Committee Reports:</u>

<u>Finance Committee:</u> Dr. Reva Gershen-Lowy submitted the Finance Committee report. Leslie Cruz presented the monthly financial report for the end of year. She explained the differences from the January report.

Academic Committee: William Ursillo submitted the Academic/Sanctuary Committee report. He updated the board that the CSI visit went well and that the observers were thorough. During the committee's March 16th meeting, Jennifer Fedele and Mary Anne DeVivio gave an overview of the visit. Currently they are working on making changes in the Accountability Plan and changes suggested by Jeff Wasbes. All changes will be approved by the Board and submitted to CSI.

<u>Governance Committee:</u> James McCarthy presented the committee report. He mentioned that the board is required for an annual meeting where they can propose an election of officers and committee chairs.
