Memorandum of Understanding	Updated MOU was not sent to legal for review and additional edits were made and sent to NHCSB on September 29th. Board vote needed.
10/07 Incident	Incident resolved with Dean of Students.
Academic Interventions	Mid-semester early alert notifications sent to students and families. Student Support Plans, Tutoring, Parent meetings and required Directed Studies and tutoring.
NHCSB Administration Presence	NHCSB prioritizing a NHCSB AOD on campus daily to monitor student behaviors, atten

a) MOU update

students' high school transcripts and submit course requests that include number of sections needed for each semester along with list of students who meet the required pre-requisites for each course for the next academic year including summer.

[NHCSB would like language that reflects MCC's record of placement determination in Banner] MCC will add Placement attributes to all NHCSB students once they have met pre-determined multiple measures and pre-requisites in math and ELA.

[NH would like language to reflect that MCC will provide courses registration numbers to NHCSB by May 15, and degree audits for current students by January 15.]

[MCC would like language that reflects how over-enrollment will be handled. The maximum enrollment number for a given course holds; rosters should be built based on those numbers. MCC can create a new section/contract for an additional cost; same course, same instructor, same schedule.]

(1) NHCSB will make a recommendation to the Board to adopt this policy.

- (a) NHCSB will have to request an additional section for students over the maximum enrollment, could have a significant impact on budget
- (b) Omari would like to have a discussion about whether or not we could pay a prorated rate for this before agreeing to pay for an entire section for a couple of students
- (c) Mike are the students in the same class or a separate one?
 - (i) Omari they would be in the same class
- c) 10/07 Incident
 - 4 of the 5 students involved were able to return to MCC with guidance regarding appropriate behaviors expected on campus
 - (2) 5th student can return with a support person who will attend campus and classes with them
 - (3) Maria met with the dean of students to discuss the resolving of the situation which opened new lines to support students from both NHCSB and MCC




- d) Meeting with President DiPasquale

 - (2) Ultimate goal is to feel more like a partner and less like a vendor
 - (3) Committed to figuring out how to improve partnership

- h) Judge Phillips Concerned about perception and how NHCSB is perceived by MCC. Are we confident that we are doing everything we can in terms of our image?
 - Omari Are putting 10th graders in college classes currently, looking at if we can continue this. Do have some 11/12th graders who we want to ensure receive all the benefits of college campus but aren't ready for the responsibility. Something that we're looking at for next semester
- 3. MCAS Data (Nicolas)
 - a) Nicolas gave a presentation linked below <u>Spring 2022</u> <u>MCAS Results Overview</u>

Highlights

- MCAS scores have not yet caught up to pre-pandemic levels.
- There are indications that student growth may have caught up to pre-pandemic levels.
- Scholars scored higher on English Language Arts than on Math.
- In general, our scholars start out with lower scores and lower growth in 6th grade, but surpass Brockton School District by 10th grade.
- This trend is more pronounced when comparing our Black and African American scholars to the same subgroup at sending districts and across the State.
- A higher percentage of our Multi-Language Learners (MLLs) meet or partially meet expectations in ELA compared to MLLs at sending districts and the Massachusetts State average.

- c) There was growth after 6th grade with students becoming more comparable to sending districts



- d) In 8th grade there is a shift and African American and Black Scholars outperformed state average in Math and ELA
- e) In math, percentage of students meeting expectations decreased and we saw an increase in scholars not meeting expectations in all grades. This is the same in ELA except for 10th grade which appears to be meeting same percentages as pre-pandemic

 g) Students still in MLL program by 10th grade typically perform more poorly, engaging methodologies with our MLL program.
- h) Mike any particular takeaways from analyzing this data?
 - Nicolas doing better in ELA than math so targeting math and middle school are a good direction to go. But not an ideal measure of success for us, MCAS not a good way of forecasting college readiness
- G. New Business
 - 1. Limited Staff Vaccine Mandate
 - a) Some staff have primary role to support students on MCCs campus and they can't be on campus due to vaccine mandate at MCC.
 - b) Asking the board for permission to mandate that any staff member whose primary role is to support students on campus be mandated to be vaccinated.
 - c) Graham how long are you thinking they will have to get into compliance for this?
 - (1) Omari that is something the board can decide
 - d) Judge Phillips how many are we talking about?



- (1) Omari 1 to 3 people would be impacted, have about 18 people who work with students on campus
- e) Vinnie is it better to look at it as a condition of employment? What's the job and what is the expectation? Shouldn't be an issue of mandating or not but simply meeting the conditions of the job if that requires being on campus.
 - (1) Discussion ensued on this
- f) Mike does MCC recognize any exemptions to the mandate?
 - Maria there is an exemption process, would have to submit a waiver and MCC will get back to them. Did have staff/students who did this and none were granted the exemption
- g) Mike caught between a rock and a hard place. Need resources on campus. You're not recommending a mandate but it seems like it's more outside our control in terms of the job.
- h) Motion that any employee of New Heights Charter School who, by their job requirements, is required to go onto the Massasoit Community College Campus must comply with all rules and regulations set forth by Massasoit Community College to be on their campus by Graham Bengen
