July and August combined fiscal information

- net \$331k decrease to projected operating income
  - -increase personnel costs in interventionist category
  - -currently under-enrolled by 23 students; effects state funding
  - -federal esser funding being shifted to next fiscal year funding → \$123k difference

-projections

- ended August with \$394, projected to end fiscal year with \$520k
- awaiting \$220k payment form charter school growth fund
