The State Charter School Commission held meeting on March 6, 2012, at the Cross State Office Building, 111 Sewall Street, Augusta, Maine. The following members were present: James Banks, Sr.; Richard (Dick) Barnes; Lynda Doyle; Jana Lapoint; Donald Mordecai; Shelley Reed; and William Shuttleworth.

### **CALLED TO ORDER:**

Chair, James A. Banks, Sr., called the meeting to order at 1:00 PM.

### **APPROVAL OF MINUTES:**

MOVED by Donald Mordecai, seconded by Shelley Reed, and unanimously voted by those present to approve the February 7, 2012 minutes as written.

### **OFFICER'S REPORTS:**

#### **Chair, James Banks, Sr.:**

#### **Vice-chair, William Shuttleworth:**

- Questioned the evaluation process by which local educational agencies will authorize a local charter school. Hopes that it is somewhat consistent with what the SCSC is creating. Applications must meet the same statutory requirements regardless of who authorizes them.

### **NEW BUSINESS:**

- A.** Deb Friedman distributed the revised Part 2 of the rule – *Procedures for Commission Authorization of Public Charter Schools*.
  - Revisions received during morning workshop session were inserted and now explained and discussed.
- B.** MOVED by Donald Mordecai, seconded by Shelly Reed, and unanimously voted by those present to approve the proposed rule – *Procedures for Commission Authorization of Public Charter Schools* and file with the Secretary of State to begin the APA process by March 13<sup>th</sup> at noon.
  - Will wait for approval from AG's office (Sarah Forster) and Governor's office (Jon Nass) before forwarding final draft to Commission members and Secretary of State's office.

- C. MOVED by Donald Mordecai, seconded by Jana Lapoint, and unanimously voted by those present to accept the DOE proposed timeline as presented.
- D. Don Mordecai and Shelly Reed will begin working with Deb Friedman on the application and letter of intent.
- E. March 5 public input session in Portland was discussed
- Went better than most expected
  - No clear direction on priority areas
  - Reaffirmed need for innovation in public education
  - Frustration from those in more rural areas that the Commission will view proposals from larger cities more favorably
  - A lot of interest in secondary level schools
  - Heard frustration and hope for relief
- F. Additional public input sessions should be scheduled for Presque Isle and Machias
