CALLED TO ORDER:

Chair, James A. Banks, Sr. called the meeting to order at 1:00 PM.

ADJUSTMENT TO THE AGENDA:

- A. Jana Lapoint requested to give James Banks authority to proceed in arranging necessary authorizer training(s) for Commission members.
 - James Banks has asked the National Association of Charter School Authorizers and SchoolWorks for a detailed list of services they could provide and the costs for these services. He will forward information to Commission members as soon as he receives anything.
- B. Jana Lapoint requested to give James Banks authority to begin process of hiring an administrative support person and a program director.
 - James Banks has asked William Shuttleworth to lead the interview process for these positions.

A. Recommendations by review teams -

Maine Connections Academy and Maine Virtual Academy
 Met and review both applications – extensive and thoroughly written

"It is the recommendation of the review team to hold the applications for the Maine Virtual School and the Maine Connections Academy until the 2013-2014 cycle. We believe it is essential to receive formal training on the authorization of virtual charter schools. In order to render due diligence to these highly detailed applications, we believe this training is paramount to this important decision making process. While it is our intent to review these two applications for the 2013-2014 cycle, the Commission must be allocated the resources to receive the identified and needed training."

MOVED by William Shuttleworth, seconded by Shelley Reed, and unanimously voted by those present to hold the applications for the Maine Virtual Academy and the Maine Connections Academy until the 2013-2014 cycle.

"It is our feeling at this stage that we would like to recommend to our board that we begin to take the next steps with Baxter Academy. It doesn't mean that they are approved in the end; it just means that we have received enough information that says to us that there is a possibility that we can provide them with a charter at a later date this year. But right now, we have been given enough information to say that it looks like it is at least a go ahead at this stage. We still have many, many questions that we need answered but those will come in the open session and I'm sure that the Academy is well prepared to answer those for us at that time. We will also be submitting their budget to Mr. Komich for a review."

MOVED by Jana Lapoint, seconded by Lynda Doyle, and voted favorably by those present to have an interview and public hearing with Baxter Academy of Technology and Science.

We would like to make that recommendation."
