

Notes from the Charter School Meeting Wednesday, July 27, 2011 3:30 PM – 5:00 PM Room 538 Cross State Office Building

A Charter School meeting was held on Wednesday, July 27, 2011, at the Department of Education in Augusta. The following were present: James Banks, Sr., Chair of the State Board; Judith Jones, Chairperson of the Maine Association for Charter Schools; Roger Brainerd, Director of the Maine Association for Charter Schools; and Mary Becker, SBE Secretary Associate.

- Roger applied for a grant on July 7, 2011. Sent a Letter of Intent and if accepted will need a proposal. Applied as a member
- The cost to become a National member is \$500.00
- Jim will appoint 3 Board members to the Charter School Sub-Committee at the August State Board Retreat
 - Look at how we formulate the Commission.
 - o What we need to be ready to do on September 29, 2011
 - o Can not seek other 4 members until after September 28th
 - o Board will confirm 3 members at October 10, 2011 Board meeting
 - September 12, 2011 Board meeting is in Ashland
- Will the Commission be applying for grants?
- How has other States started the process?
- Jim met with Deb Friedman, DOE on July 22nd
- Interested individuals should send to Mary Becker a letter of interest, resume, brief bio (see page 8 of law for experience)
- The 3 SBE members will review the letters of intent, resumes, etc., following the October Board meeting
- Positions to hire Executive Director and Administrative Assistant

- Sarah Forster Ask her what legal authority will the Commission have
- State Employees or contracted employees
- Law states "meet criteria"
- Location for Commission and staff Little or no money. Will ask the Commissioner if they can be housed at DOE to get started
 - Room 500, 103, or 105 as they will be public meetings.
 - A cubicle at DOE for 2 staff members.
- Commission will be separate from the SBE
- AOIS Software Call is in to David Hanson who manages data collection
- Idaho is an independent commission and not a good model they all have their own system
- Gates Foundation Judith and Roger can apply to
- Who is in charge of funds and payment of bills
- As a small non-profit there are things they can do
- Roger there are superintendents he has spoken with that have an interest in establishing a Charter School
- There are close to a dozen schools throughout the State that may want to be involved with training
- Financials are all formatted the same
