#### I. Call to Order

# V. SAC update

Never Cton Innovation

- The SAC representative provided the BOD with a memo containing suggestions for improved communications with parents and the community.
- The SAC page on the STEM website will advertise open SAC positions with elections for the open positions next month.
- The SAC representative indicated a need for better communication on social media.

## VI. STEM PTO update

- So far this academic year, PTO fundraising efforts have produced \$76K in donations and over \$4700 to direct requests from teachers. The total of over \$81K is significantly higher than the less than \$3k amount for last academic year.
- Discussion ensued on opportunities for involvement with STEMfest (4/28) and other activities such as parent socials activities during the summer.

# VII. Public comment

- A parent presented concern about Cody Blackburn's departure and suggested the most recent revisions to the bylaws caused the ratio of Class A directors to Class B directors to be too low to adequately provide representation of parents of STEM students on the Board.
- A parent presented continuing concerns over special education, response to intervention (RTI), individualized education program (IEP), and learning support services (LSS) implementation at STEM noting district posture toward the school on these matters.
- A parent inquired as to the possibility of video streaming STEM BOD
  meetings and noted a current block on google forms preventing students
  from completing assignments requiring access to that tool.

 Rudy Lukez motioned to adjourn public session and convene to executive session. Tracy Scroggins seconded. All in attendance approved.
