  - > Ensure the STEM vision by increasing stakeholder engagement
  - Ensure the STEM vision by creating alignment between Business Human Resource and staff
- Tracy Scroggins commented that the detail on the first goal included operational procedures and higher-level aspirations supporting the STEM vision and noted a lack of specific supporting goals. Mrs. Weyman indicated that the specific supporting goals would occur across levels and offered the meeting template created to improve meeting productivity and focus as clarification.
- Mark Alpert suggested including an additional goal pertaining to interaction with DSCD. Mrs. Weyman acknowledged the suggestion while indicating this point is alluded to in the third goal.


#### XII. Resolution to affirm Mission Statement


 Roy Martinez moved that the BOD affirm that STEM School Highlands Ranch mission statement is


















# Enrollment
