**BE IT FURTHER RESOLVED**, that Article X, Section B, “OTHER PROVISIONS” of the Bylaws of Bridge Prep is hereby amended to add the following language to said Section, as reflected by the boldface language:

B. Execution of Instruments. Except as otherwise provided in these Bylaws, the Board may adopt a resolution authorizing any Officer or agent of the School to enter into any contract or execute and deliver any instrument in the name of or on behalf of the School. Such authority may be general or confined to specific instances. **In accordance with the foregoing, the Board hereby authorizes the Executive Director to enter into contracts under \$5,000 and to deliver instruments in the name of or on behalf of the School.** Unless so authorized, no Officer, agent or employee shall have any power to bind the School by any contract or engagement, to pledge the School’s credit, or to render it liable monetarily for any purpose or any amount.

**BE IT FURTHER RESOLVED** that all other provisions of the Bylaws as adopted shall remain in effect and the foregoing amendment shall be incorporated into the standing Bylaws of Bridge Prep.

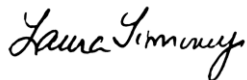
