### Renewal Update

- We have contracted with EdTec to support updates to our charter petition and creation of our data narrative.
- After reviewing our data EdTec believes that we should be classified in the middle tier according to state guidelines. We are currently working with our lawyers (who agree with EdTec) to determine available next steps.
- Depending on timing, we may need a special board meeting to approve our charter renewal petition before submitting.



## **Water Quality Updates**

- Lead in school water is in the news in Oakland!
- We have accessed the water testing data, testing for lead levels, for our campus and are happy to report that based on EPA guidelines 15ug/L, our water quality from all taps indicates no concern for lead pipes or other lead infiltration in our water systems.
- OUSD uses a limit of 5 ug/L and we have one tap in use that is at 5.1 ug/L.



## **Water Quality Updates**

- OUSD has agreed to add a below tap filter to this water source.
- > We have purchased on tap water filters for all water taps and have placed on on the tap in question.
- For the water source with a 5.1 ug/L level, we will run the tap for a minute at the beginning and middle of the day, and give students a choice to use the water from the tap with our attached filter until OUSD installs the under sink filter.
- We are working with OUSD to retest all of our water sources as soon as possible.
