MINUTES

International Leadership of Texas Board of Directors Meeting
Wednesday, March 19th, 2014 – 6:30pm
International Leadership of Texas – 3301 N Shiloh Road, Garland, TX 75044

- I. Call to Order- The meeting was called to order at 6:46 p.m. by Mr. Sevier. Roll was called and the following Board members were present: Mr. Sevier as meeting facilitator, Mrs. Wallace, and Major General Williams. A quorum was established.
- II. Approval of February 2014 Minutes- A motion to approve the February minutes was made and second with all voting in favor.
- III. General/Public Comment- 1) Girls basketball champions acknowledged photographs taken with Board members. 2) Major General Williams was introduced as a new Board member.
- IV. CEO/Superintendent Report: Eddie Conger- Mr. Conger discussed district priorities: academic achievement and fiscal responsibility. He explained that a state can dissolve a charter that fails to perform academically and/or mismanages funds. As a result of the requirement for charter schools to pay 1.5% of payroll into TRS, ILTexas may not be able to give a 2% pay raise as initially planned. The intention is to have the 2014-15 budget ready for review at the April meeting. Mr. Conger discussed the February trip to China and the recruitment efforts as a result of the trip are significant. Mr. Conger also discussed potential savings as a result of the

real estate investment considered by King Lee Private school who will visit ILTexas in March.

- A. Chief Financial Officer Report, Jerry McCreight- Mr. McCreight proved a financial update that included total revenue, total expenditures ad a budget to actual for all line items. It was explained that our per student rate is \$7,600. As a result of not bringing in the teachers from Monteraty, the substitute teacher line item has been over-extended. The ILTexas budget is based on 2800 students but we actually have 2500. The state reviews enrollment every six weeks and provides funding based on that number. (Written Report Provided)
- B. Chief Operations Officer Report, Chris Florance- Construction is on time and within budget. More information will be shared at the April meeting.(Written Report Provided)
- C. Chief Academic Officer Report, Dr. Laura Carrasco- Waivers have been submitted to the state for the additional inclement weather days. As for the 2014-2015 school calendar, a decision needs to be made regarding Spring Break week. The concern is being aligned with local school districts or DCCC as our students take classes there. ILTexas has had an increase in the number of English Language Learners (ELL). (Written Report Provided)

Operations & Facilities - July 15 Board Report

Facilities: Operations initiated weekly reviews of all campuses at the beginning of December. Mr. Bill Longley, Assistant Operations Director, continues to travel to all campuses and walking each campus, meeting with leadership. Any materials transfers will be done during scheduled days. This process is still working well.

Campus Updates:

All campuses are running well. Campuses, with new facilities being built, are getting ready and planning for the summer transition.

- A. Garland Elementary School / Garland Middle School.
 - * GES/GMS is running well with all systems a go.
- B. Garland High School
 - * Garland High School is running well. Operations personnel are continuing to meet with the Principal and leadership teams regarding FFE and working on Transition plans for the New High School.
 - * GHS / New Garland HS. The New ILT High School is under Construction with Heavy equipment on site. Plumbing is being roughed in. All slabs are being framed and formed getting ready to pour concrete within the next two weeks. All drives are being defined getting ready to pour concrete also.
- C. Arlington Elementary School
 - * Arlington Elementary school is running well and looking forward to the joint relationship they will have with Arlington Middle School when the new combination campus, (AES/AMS), is complete.

 The Operations department is still working with the various transition teams including FFE considerations.
- D. Arlington Middle School
- * Arlington Middle School is running well is also planning for the summer transition to the New Arlington campus.
- E.*AES/AMS <u>New Campus</u> -The New Facility is under way. The Main building rough in, for plumbing, is in and the slab poured. Walls are going up fast. Most drive lanes around the building are poured.

F. KES/KMS – New Campus. The project is now under way. The main building pad is defined and grading is rolling at an aggressive rate. The detention pond is being graded.

Operations personnel are still working with the Principal and Leadership regarding FFE and School Design.

District Offices.

Arlington and Garland District offices are fully functional.

Technology: C2M – Updates were included in the campus reports.

Security: Most Uniforms for our Security teams are in.

Nurses: Ms. Elizabeth Nelms, our head nurse, has completed mandated screenings and follow up screenings including Hearing, Vision and Spinal exams. Nurse Nelms just completed additional Continuing education units with all District Nurses regarding Seizures in a school setting.

Transportation: We are still working on cost effective bus service for field trips and eventual Student Service to District Schools.

Curriculum and Instruction Report - March 19, 2014 Board Report

I. Common Summative Assessments (CSAs)

The week before spring break, our students took the CSAs for the 4th grading period. This past Monday, 03/17, we held our Data Day for our 4th grading period. Our teachers had an opportunity to look at CSA data, celebrate gains made, and determine areas of need. This week we have begun our 5th grading six week grading period.

II. Rosetta Stone

ILTexas has ordered one student version of Rosetta Stone for each of our Spanish DL teachers, each of our Chinese FLES teachers, and each of our Chinese and Spanish LOTE teachers to pilot in their classrooms (supplemental instructional material). The student version will be good through October 31, 2014. It is meant to be used as an instructional resource to scaffold and support language learning. Additionally, we extended the offer to our faculty and staff to order a Rosetta Stone student license at the bulk price of \$46 per license, per language (a huge discount from msrp). Logins will be emailed out this week.

IV. Dual Language Professional Development

We brought in Blanca Herrera from Mission, Texas to assist us in providing professional development in dual language immersion the last week of February. Ms. Herrera has significant experience in dual language and with teaching in a Spanish Immersion program to students with no mastery of the Spanish language. She worked specifically with our Spanish Dual Language teachers at both divisions.

V. Language Proficiency Assessment Committee (district count- 607)

The first week of March the LPAC met to identify new ELL students as well as to make testing decisions on what language and on what linguistic accommodations each ELL student would receive on each STAAR exam. Decisions regarding linguistic accommodations were made *per student & per exam*. This week we will LPAC our ELL high school students. Additionally, this week's LPAC will make final decisions on students taking the LAT version of the STAAR exam.

To be eligible to take the Linguistically Accommodated Test (LAT) version of the STAAR exam, students must be in their first three year in US Schools. The LPAC will decide when the LAT version is the most appropriate assessment for our eligible ELL students. For the majority of these decisions, the LPAC relies primarily on the professional judgment/recommendations of our classroom teachers.

Item #2 Personnel

Due to Extreme Needs regarding student behavior, another special education teacher position was requested through an ARD committee at Garland Middle School. All committee members agreed to have position in place when we are back from Spring Break.

Update: A staff member was hired and started on 3/17/14 at the Garland Middle School

Item #3 Response to Intervention

Special Education is currently working on a district wide process for academic and behavioral interventions to be implemented in the same manner at all schools. A training is being developed and will be delivered to the teachers on the next staff development day.

Update: Training occurred for all campuses on 3/17/14 that reviewed the general education response to intervention model, and the referral process.

Item #4 Dividers

Room dividers are being purchased to divide the special education room into two or three working areas in Garland. This will allow the small office area within the room to be one area where a Diagnostician or Speech Therapist can do their evaluations. The Sped Peims clerk will move out of that office when utilized for testing. Speech therapy will also no longer utilize that space.

Update: Due to budget restrictions the dividers were declined. We are currently working out other space alternatives.

Item #5 Related Services

Region 10 offers related service providers (such as OT/PT, VI, and Adaptive PE) at a discounted cost if we join their coop. This year we could not join because the cutoff date was last February. We will join for next school year.

Update: We did apply, and received information from Region 10 that they would handle our related service needs for Garland.

6th Grade

- There has been marked improvement in 6th grade CSA scores in Math, English, and Reading, due to prescriptive RTI interventions and increased targeted tutoring. In some areas, scores have almost doubled. The 6th Grade Team has tutoring available before and after-school, Monday Thursday. The 6th Grade Team will also begin tutoring on Saturday, starting April 5, 2014. We will host several reading and math workshops for all reading and math students.
- The entire 6th grade class will be taking a field trip to The Dallas Holocaust Museum on Thursday, March 20·2014. We have concluded our novel study, Diary of a Young Girl: Anne Frank by Anne Frank. Students will use primary and secondary sources at the three Dallas history museums to explore lessons and attitudes about leadership while using the West End as a Classroom. Covering the 19th century to the present day, students will examine local, national, and international leaders to define the special characteristics that make a leader.

7th Grade

- There has been improvement of CSA scores in Math and English and double-digit gains on our campus-wide common assessments. The 7th grade team has composed a new targeted tutoring schedule for the next two weeks in preparation for the writing STAAR the first week of April. A new list will be constructed after the students take a mock STAAR for math and reading also during the first week of April.
- We are currently planning our upcoming school field trips The Ross Perot Museum. Our students will be attending the Robotics Classroom Program. The program introduces students to the fundamentals of robotics through each of the STEM disciplines. Science, Technology, Engineering and Math. The students will learn about the parts of a robot, including: the central processing unit (CPU), sensors, motors and power supply, logic reasoning, programming and basic electronics including conductors, insulators and circuits.

8th Grade

- There has been improvement of CSA scores in Math and English due to increased targeted tutoring. We are strengthening our interventions in Science to address the deficiencies reflected by the data. The 8th grade team has composed a new targeted tutoring schedule for These tutoring sessions are personalized to each student's individual needs based on their CSA disaggregated data and is intended to assist our students with their upcoming STAAR assessments. Each day of the week during our targeted, individually prescribed sessions, the 8th grade teachers are focusing on a specific TEKS that students performed below 70% on their CSAs. On any given day we have approximately 50 8th grade students in tutorials and we are collaborating with all content teachers for assistance and support.
- Each 8th grade teacher has implemented constructive response rubrics as a test taking strategy. We have observed exponential growth in our weekly formative assessment scores. Our students and parents have really enjoyed this new strategy!
