MINUTES

CONSENT ITEMS

Approval of June 2006 Board Meeting Minutes tabled until next board meeting.

BUSINESS ITEMS

Adoption of 2006-07 Budget changes. Proposed changes are as follows:

REVENUE

- The lunch program will now reflect \$155 in revenue.
- Middle school student fees increased from \$30 to \$60 per student.
 (clarification only approved in annual meeting with budget)

INSTRUCTION AND ADMINISTRATIVE SUPPORT:

- Teacher salaries increased from 22 to 23 teachers. Total amount increased to \$780,252. (Including benefits, this is approximately a \$40,000 increase.)
- Supplies is \$60,000 decrease of \$10,000.

OPERATIONS AND MAINTENANCE

- Supplies is \$7,000 a decrease of \$3,000.
- o Phone is \$7,000 a decrease of \$500.
- Property and Casualty Insurance is \$15,000 decrease of \$7,550.
- O Utilities is \$50,000 an increase of \$4,000,
- o Food Service will now reflect \$150,000 in expenses. (The Revenue less Costs is a \$5,000 increase to the school).

FURNITURE AND EQUIPMENT

o Budgeted \$10,000 – a decrease of \$5,000.

OTHER

Security and copier lease is \$6,000 – decreased by \$6,500.

Craig Bergeson motioned to have the budget reflect the changes as listed by Craig Bergeson and seconded by Shawn Stevens. Motion passed unanimously.

Debby Gomberg recommended reviewing Kathy Thornburg's Employment Agreement before the next board meeting.
