BUSINESS ITEMS:

 Craig Bergeson made a motion to table approval of budget amendments until further information is obtained. Second by Amy Sondrup, motion passed unanimously.

OTHER BUSINESS:

• Dr. Donna Milavetz has been the PE teacher for over half a semester. The student's physical activity since implementing the new program has increased by over 200%. Parents are volunteering in the PE program on a weekly basis as well. The program she is running has specific needs such as equipment and space to provide the ideal physical education program. The cafeteria is too small for the needs of the program. She has contacted the owners of the land surrounding OPA and MOPA as well as the city planning commission and the architect who built OPA. They have given their recommendations. Her request is for permission to write a capital expenditures grant to pay for the building. Approximate dimensions for the proposed gym is 32' wide at least 162' long. The multi-purpose room she is envisioning would be appropriate for after-school activities, school functions, community uses, summer camps, science camps, etc.

PUBLIC COMMENTS:

- Parents of OPA 8th grade students have expressed concern about their students moving to 9th grade next year. The board told the parents that adding a 9th grade is outside of their approved charter with the state. A new charter would have to be approved by the State Charter School Board. If the school wanted to pursue an expansion to the number of students and the grades served, the next window for charter applications for a 2008-2009 school year change closes in February.
