#### B. Call the Meeting to Order

M. Dudgeon called a meeting of the board of directors of State Charter Schools Commission of Georgia to order on Wednesday Feb 28, 2024 at 10:02 AM. Commissioner Scafidi was not able to join the meeting due to presenting at a conference.

#### **II. Approval of SCSC Meeting Minutes**

#### A. November 15, 2023, Meeting Minutes and January 26, 2024, Policy Retreat Minutes

Commissioner Dudgeon motioned to approve the minutes by unanimous consent. Both meeting minutes were approved unanimously after hearing no objections.

#### IV. Legislative Update

#### A. Update

 Amended FY24 Budget (HB 915) passed both chambers and is now awaiting the Governor's signature.

- **HB 318** is also awaiting the Governor's signature. This new legislation reestablishes the Georgia Department of Education's Office of Charter School Compliance under the SCSC. The Office of Charter School Compliance will continue to support local school systems as charter authorizers. Special thank you to our good friend, State Representative Scott Hilton!
- **HB 1122** has passed the House Education Committee. Notably, this bill would provide funding to each state charter school for the beginning salary of one superintendent. Additionally, state charter schools serving grades K-8 could earn funding for up to two principals. Schools serving grades 9-12 will earn funding for one principal.
- Crossover Day is Thursday, February 29.
- Sine Die will be on Thursday, March 28.

#### V. Charter Development

#### A. Training

#### Past Trainings:

- New School Orientation (1 of 2), Data Summary: The first in-person New School Orientation for FY-24 Pre-Opening Schools occurred on January 17th. 10 newly approved state charter school board members attended the training session.
- In-Person Governance Training Session (1 of 3), The first in-person Governance Training session for FY24 occurred on November 8th in Macon, GA. 47 state charter school board members, and school stakeholders attended the training event.
- The second in-person Governance Training session occurred on February 6th in Athens, GA. 104 state charter school board members and school stakeholders attended the training event.

#### VI. Pre-Opening Schools

#### A. Update

There are 5 schools in the pre-opening cohort, and 3 of those schools are projected to open in Fall 2024. The most recent pre-opening milestone was the submission of Governing

Board member rosters; 1 out of the 3 schools projected for Fall 24 opening did not meet the milestone. The lease submission milestone was due December 15, 2023. One school has been granted a lease extension until March 15, 2024. Facility, personnel, and enrollment milestones are scheduled for March and April; a more comprehensive preopening update will be given at the April board meeting.

#### VII. Petitions

#### A. Update

The online start-up petitions portal is currently open; petitioners have until March 15, 2024, to submit a petition for a start-up state charter school. As a reminder, we have posted several trainings and resources on our website, including an orientation that petitioners are required to view this year.

The SCSC received three letters of intent to replicate from schools in December. Those schools have until May 3, 2024 to submit their replication petition in the online portal.

#### VIII. Accountability

#### A. Comprehensive Performance Framework (CPF) Update

Staff shared results from the Comprehensive Performance Framework for the 2022-2023 school year with schools on January 30, 2024. Schools were given until Tuesday, Feb. 20, to submit related questions or provide documentation to rebut any scores. Schools' scores are now finalized and staff will present CPF results at the next SCSC meeting in April.

#### B. Finance

The SCSC Director of School Finance gave an announcement on the approved auditor program.

#### C. Operations

- The legal compliance team is reviewing FY 24 operations and fiscal monitoring Corrective Action Plans (CAPs), which were due February 20, 2024. We expect to have CAP responses for schools by the end of March. Schools should direct any operations monitoring questions to Tiffany Leach—Associate General Counsel, <a href="mailto:Tiffany.leach@scsc.georgia.gov">Tiffany.leach@scsc.georgia.gov</a>, and fiscal monitoring questions to Carmen Freemire—Director of School Finance, <a href="mailto:Carmen.freemire@scsc.georgia.gov">Carmen.freemire@scsc.georgia.gov</a>

A representative from the school spoke in favor of the staff recommendation.

<u>Charter Amendment Recommendation – Atlanta SMART Academy (contract extension)</u> The board **VOTED** unanimously to approve the motion.

#### B. Charter Amendment - Northwest Classical

- T. Lowden made a motion to approve the staff recommendation to amend the Northwest Classical charter contract to align the contract with the SCSC board's Grade Band Policy.
- B. Brockway seconded the motion.

A representative from the school spoke in favor of the recommendation.

<u>Charter Amendment Recommendation – Northwest Classical Academy (Grade Band Completion)</u>

The board **VOTED** unanimously to approve the motion.

#### C. Charter Amendment - Ethos Classical

- T. Lowden made a motion to approve the staff recommendation to the Ethos Classical charter contract to expand the grades served from K-5 to K-8, increase the enrollment limit, and amend mission-specific goals.
- L. Millan seconded the motion.

A representative from the school spoke in favor of the recommendation.

<u>Charter Amendment Recommendation – Ethos Classical (Grade Band Expansion)</u>
The board **VOTED** unanimously to approve the motion.

#### D. Charter Amendment - Yi Hwang Academy of Language Excellence

- L. Millan made a motion to approve the staff recommendation to amend the Yi Hwang Academy charter contract to expand the grades served from K-5 to K-8.

A representative from the school spoke in favor of the recommendation.



# Vision

# Mission

The mission of the State Charter Schools Commission of Georgia is to improve public education by authorizing high-quality charter schools that provide students with better educational opportunities than they would otherwise receive in traditional district schools.



# Comprehensive Performance Framework



The Comprehensive Performance Framework (CPF) is the tool the SCSC uses to annually assess state charter performance and track progress toward renewal.

In each of the three areas, the framework asks a fundamental question:

- Academic Performance: Is the educational program offering students a better educational opportunity than they would otherwise receive at a traditional public school?
- Financial Performance: Is the school financially viable?
- Organizational Performance: Is the organization effective, compliant, and well run?

# Academic Measures for 2023:



- 1. GaDOE CCRPI Content Mastery Scores
- 2. GaDOE CCRPI Progress Scores
- 3. SCSC Grade Band Scores
- 4. SCSC Value-Added Impact Scores

A school is considering meeting standards if it:

- Outperforms the schools from which it enrolls students on any one or combination of measures 1-4 in all grade bands served OR
- Outperforms the schools from which it enrolls students on a grade-band enrollment weighted overall school score for any measure 1-4.



# Academic Measures for 2023:

## 1. GaDOE CCRPI Content Mastery Scores

• Proficiency on Georgia Milestones Assessments (GMA). Schools earn points based on the percentage of students scoring in each category- Beginning (0), Developing (.5), Proficient (1), and Distinguished Learner (1.5).

## 2. GaDOE CCRPI Progress Scores

 Demonstrated growth on Georgia Milestones Assessments utilizing Student Growth Percentiles (SGPs). SGPs describe the amount of growth a student has demonstrated relative to academically-similar students.



# Academic Measures for 2023 (cont.):



## 3. SCSC Grade Band Scores

 A replication of the indexed Grade Band single score previously calculated by GaDOE. Calculation includes weighting of various CCRPI components to produce an overall score.

## 4. SCSC Value-Added Impact Scores

• A student's actual score on GMA is subtracted from their predicted score (based on their observable characteristics), and the differences are averaged across all tested students in a school. Adjustments to a school's score are made to account for the differences in the population of students it serves.



## Academic Performance by Measure, 2022-2023 School Year, 41 Schools

35 of 41 (85%) state charter schools are meeting academic standards for the 2022-2023 school year.

95% of SCSC students were enrolled in one of the 35 schools, that's 32,231 students.



- current ratio of assets to liabilities
- unrestricted days cash
- enrollment variance
- debt to income ratio, and
- default on debt


AND on the following sustainability measures:

- efficiency margin, and
- debt to asset ratio.





### Financial Performance by Measure, 2022-2023 School Year, 41 Schools





### Is the school able to project enrollment in a way that enables them to adequately budget?


- Meets Standard: Enrollment Variance equals less than 2 percent.




Schools may satisfy annual operational requirements by adhering to the requirements of their charter contracts and all applicable rules and laws as measured by:

- 1. the school's educational program (adherence to its essential or innovative features and implementation of required programs);
- 2. financial oversight (adherence to GAAP standards);
- 3. governance capacity and transparency;
- 4. protecting students and employees through the appropriate use of compensatory programs and employee qualifications;
- 5. maintaining a positive school environment by promoting student retention and support services;

AND any additional obligations including: the timely remediation of previous noncompliance.


*Meets Standard:* The school complied with all applicable laws, rules, regulations, and provisions of the charter contract relating to proper internal controls, expenditures, inventory, drawdowns, and cost principles when expending federal funds, including but not limited to:

- Proper segregation of duties;
- Source documentation for expenditures paid with federal funds;
- Complete and on-time submission of program budgets (Title I, IDEA, and grant budgets); and

### Operations Performance by Measure, 2022-2023 School Year, 41 Schools



## Common Issue Areas of External Data Sources

- GaDOE Federal Programs Cross-Functional Monitoring (CFM)
  - 16 SCSC schools were monitored in FY23. 10 schools were monitored in FY22. Prior to FY22, 3 to 4 SCSC schools were monitored annually.
  - Findings in CFM reports can impact **Indicators 1, 2, and 4**.





#### **Item Summary**

Charter Amendment – Ivy Preparatory Academy (contract extension)

#### Recommendation

SCSC staff recommends that the SCSC Board of Commissioners approve an amendment to the Ivy Preparatory Academy charter contract (Charter) to extend the contract term by two years.

#### Rationale

The school improved on two of three CPF sections. A review of the school's FY22 and FY23 audits indicated that the school decreased its debt service amount from two million dollars in FY22 to \$680,000 in FY23. It also lowered its debt-to-income ratio from 26.6% to 8.6%, a total decrease of 18%. While the school provided information that it did search for a more favorable bond package, the school explained that its existing bond terms are more favorable than what is available in the current market.

This recommendation aligns with the SCSC's recent renewal decisions for schools in similar situations in which the school's financial CPF score was impacted by existing terms of its bond agreements. The school will remain on high-risk financial monitoring to ensure it continues to focus on improving its financial CPF score while meeting the terms of its current bond.

#### Recommendation

The SCSC staff recommends that the State Charter School Commission Board of Commissioners vote to amend the FY24 charter replication petition cycle by approving the extended charter replication petition timeline as presented.

#### Rationale

In alignment with the SCSC's strategic objectives, we recommend extending the deadlines for replication letters of intent and petitions to encourage replication of high-quality charter schools in underserved areas of the state, including the areas that will be impacted by recent school closures (Fulton and Cherokee County areas). Petitioners are still required to meet the SCSC's replication and concurrent submission requirements. SCSC staff will confirm replication eligibility upon receipt of a petitioner's letter of intent. Eligible petitioners will receive a link to submit their applications.
