### **B. Petition Decisions**

Dudgeon made a motion to approve the SCSC staff recommendation that the SCSC Board of Commissioners approve the petition for Movement School Athens, authorizing the SCSC Chair to execute a charter contract for the operation of a state charter school for an initial term of five (5) years starting with the 2025-2026 school year.

J. Cole seconded the motion.

Representatives from Movement School Athens spoke in support of the recommendation.

The board **VOTED** unanimously to approve the motion.

J. Cole made a motion to approve the SCSC staff recommendation that the SCSC Board of Commissioners approve the petition for Excelsior Village Academies, authorizing the SCSC Chair to execute a charter contract for the operation of a state charter school for an initial term of five (5) years starting with the 2024-2025 school year.

M. Dudgeon seconded the motion.

Representatives from the Excelsior Village Academies spoke in support of the recommendation.

The board **VOTED** unanimously to approve the motion.
