## II. Review of Search Firms

### A. Discussion of Search Firm Proposals

Committee held a discussion regarding the merits of each proposal based on the following criteria:

1. experience with similar schools
2. local experience
3. cost
4. understanding of Audubon
5. presentation
6. availability
7. attention to detail

The committee also discussed the possibility of having to conduct an interim CEO search due to the timing of the search. The committee decided not to include conducting an interim CEO search in the consideration of which firm to choose for the permanent CEO search since the board had not yet decided to pursue that course of action. However, the committee instructed the current CEO to begin conducting outreach to potential interim CEO candidates both internally and locally including former leaders of Audubon.

Following the discussion, a motion was made to accept the proposal from Educator's Collaborative for CEO Search services as the lower cost option since the companies appeared to offer comparable services and supports.
