Dr. Corbett explains Greenspace dispute regarding land at Audubon Gentilly that is owned by New Orleans. He is meeting with Parks and Parkways to discuss compromise in order to maintain exclusive access during school hours.

## **IV. CEO's Report**

### **A. Development Report**

School celebrates world teacher's day and engaged in fundraiser that raised \$615 from 9 donors. Giving Tuesday coming up on November 29th. We received ARPA grants for \$137,000 for Uptown campuses and \$196,000 for Gentilly. We received \$10,000 from Louisiana's Disability Foundation of America and \$35,000 from RosaMary for Adoption of Tier 1 Curriculum.
