Proposed Action: Devin Krugman is proposed as the candidate to replace Jennifer Afdahl Rice on the EBIA Board effective immediately.

Devin Krugman currently serves as the Head of Content Teams for San Francisco Unified School District (SFUSD) after working for almost three years as the Director of Professional Growth and Development at SFUSD. Before working at SFUSD, Devin served five years as the founding Executive Director and Head of School at East Bay Innovation Academy, a grades 6-12 public charter school in Oakland. Before taking on this administrative role, Devin taught social studies for seven years at ACORN Community High School. She was selected as the model instructional classroom teacher for a network of schools. Devin has a Bachelor of Arts from the University of Maryland, a Master of Science in Education from Long Island University, and a Master of Educational Leadership and Administration from Columbia University. Devin lives in Oakland with her spouse and two children, where they love to spend a lot of time enjoying the outdoors,
