- Chronic absenteeism improved overall since last year, half of sites meeting internal goals
- K-2 literacy progress monitoring data mostly for kids who struggled on prior screener
- 3-5 and 6-8 ELA interims internally built to contain broader content; results indicate growth since earlier in the year

- Adoption of new org-wide ELA curriculum next year increase alignment and collaboration
- 3-5 and 6-8 Math internal interims indicate growth from earlier in year and progress toward SBAC goals
- Most sites on track to meet EOY suspension target, emphasis on restorative justice
