#### REPLACEMENT OF EDUCATIONAL PROGRAMS AND OPERATIONS LEVY

The Board of Directors of North Mason School District No. 403 adopted Resolution No. 3-G-26 concerning a proposition for an expired levy for education funding. This proposition would fund operations, including music, arts, athletics, teachers, custodial, counselors, nurses, mental health, safety/security personnel, special education services, curriculum, technology and cybersecurity, and authorize the District to levy the following excess taxes, replacing an expired levy, on all taxable property within the District:
