	<p>Schools are spending money according to the budgets. Revenue is coming in as planned except newly approved Tax Increase funding that is estimated to be around \$800 per child. In conversation with the district, it seems that the funds might start coming in in Jan-Feb, because district has not received the funds yet from the city. As a result, Intercoastal needed another infusion of \$50,000 from K-8 on Nov 29th to pay teacher salaries. On the good side, Intercoastal received its first Capital Outlay Payment on Dec 4. We expect it to take 2-3 months for it to receive first Sales Surtax Payment.</p>
