Public Comment Rules for Non-Agenda Items: Members of the public may address the Board or Committee, as applicable, on non-agenda items through the teleconference platform, Zoom, during the time allocation for public comment on non-agenda items. Zoom does not require the members of the public to have an account or login. Please either utilize the chat option to communicate to the administrative team of your desire to address the Board or Committee, as applicable, during this time or simply communicate orally your desire to address the Board or Committee, as applicable, when the Board or Committee, as applicable, asks for public comments on non-agenda items. Speakers may be called in the order requests are received. Comments are limited to 2 minutes each, with no more than 15 minutes per single topic. If a member of the public utilizes a translator to address the Board or Committee, as applicable, those members of the public are allotted 4 minutes each to accommodate translation time. By law, the Board or Committee, as applicable, is allowed to take action only on items on the agenda. However, the Board or Committee, as applicable, may, at its discretion, refer a matter to school staff or calendar the issue for future discussion.

Public Comment Rules for Agenda Items: Members of the public may address the Board or Committee, as applicable, on agenda items through the teleconference platform, Zoom. Zoom does not require members of the public to have an account or login. Please either utilize the chat option to communicate to the administrative team your desire to address the Board or Committee, as applicable, on that agenda item or simply communicate orally your desire to address the Board or Committee, when the Board or Committee, as applicable, asks for public comment on that item. Public comment will be allowed following the staff report, if any, on each agenda item. Speakers may be called in the order requests are received. Comments are limited to 2 minutes each, with no more than 15 minutes per agenda item. If a member of the public utilizes a translator to address the Board or Committee, as applicable, those members of the public are allotted 4 minutes each to accommodate translation time.

Note: The Board or Committee, as applicable, encourages those with disabilities to participate fully in the public meeting process. If you need a disability-related modification or accommodation, including auxiliary aids or services, to participate in the public meeting, please contact the School Board Office at (530) 927-5137 at least 48 hours before the scheduled board or committee meeting so every reasonable effort can be made to accommodate you.
