II. Educational Excellence

A. Agenda

MAP Data:

- Slight dip in reading proficiency, likely due to Kindergarten students no longer taking MAP reading.
- MAP predictor suggests strong results for Spring Milestones as compared to peers
- Average achievement for Black students growing, while gap between Black students and White students is narrowing. Opportunity Gap teams across both campuses have positively contributed to this outcome.
- Teacher workdays create ability for teachers to share best practices, plan vertically, and refine instructional practices.

Charter Renewal:

 - Green = good to go; Red = working on a few things; Yellow = waiting on a few things
