- Ensures adequacy of financial controls and monitor for compliance
- Ensure Financial literacy of Board Members by providing training

- Hold a yearly ECS financial training course.

- Ensure adequate financing for the facilities development for all school sites.

- Ensure salary schedules and benefits are supportable and sustainable.
- Engage board in a critical assessment of the budget as it relates to organizational priorities and goals.
