A. EdTec financial update

EdTec consultant Dorothy Lee presented the EdTec financial update slides:

- ECHS-L forecasted operating income increased by \$172k
- ECMS-G forecasted operating income increased by \$50k
- ECMS-I forecasted operating income decreased by \$24k
- ECHS-G forecasted operating income increased by \$35k

The reductions in ADA forecasts at all ECS schools except ECHS-G were noted as higher than historically normal but not as drastic as they could be, particularly considering the COVID safety measures in place that prevent even mildly sick students from attending in-person when they likely otherwise would.
