Material Amendment Request - Voices for International Business and Education

Rationale for Changes in Grade Levels Served

The Voices for International Business and Education (VIBE) board seeks to expand the organization's grade levels served to incorporate grades 6 through 8. The organization aims to enhance the overall performance of students in the International Baccalaureate Diploma Programme along with other key performance indicators like LEAP performance at the high school level.

VIBE was awarded a Reimagine School Systems grant to support this expansion effort in the spring of 2022.

Reimagine Advisory Committee meetings, stakeholder engagement, and other planning activities throughout the spring and summer have satisfactorily completed grant deliverables to the Louisiana Department of Education. VIBE is moving towards Phase II of the Reimagine School Systems process and the ultimate sustainability of a lower school as an eventual authorized International Baccalaureate Middle Years Programme institution.

Material Amendment Request - Voices for International Business and Education

Rationale for Changes in student enrollment in excess of 120% of the total number of students set forth in the school's charter

When Voices for International Business and Education (VIBE) and the International High School of New Orleans (IHSNO) were founded, the original vision for grade levels served was at the high school level. With the awarding of a Reimagine School Systems grant for expanding grade bands offered to grades 6 through 8, this will increase the enrollment above 120% originally stated in the school's charter.

To offer the unique and world-renowned International Baccalaureate Middle Years Programme (MYP) outside only 9 and 10 grades currently served at IHSNO and at a rate of adding 100 students per grade level through the additional middle school grade bands, the enrollment for the organization after grade 6 is added could be about 720 students in grades 6 through 12.

Adequate facility planning is being conducted; however, if grade 8 is added first, it is possible for the 2023-24 academic year to house grades 8-12 on the current IHSNO campus on Carondelet Street in New Orleans which has a building capacity of 825.

Background:

The International High School of New Orleans (IHSNO) submitted for and in March of 2022 was awarded the Reimagine School Systems Grant valued at \$720,000.00. To improve access to high quality education, this grant allows IHSNO to expand the International Baccalaureate Program (IB) to include a Middle Year's Program in grades six, seven, and eight. This is a two-year process with expectations of opening our doors to middle school students in 2023.

Together with Empower Schools and Steady State Impact, IHSNO staff have been working through Phase One, the planning phase, creating committees, norms, goals, and building plans, including the Stakeholder Engagement, Change Management, and the School Academic and Culture plan. There have been regular meetings to outline the planning and implementing stages of this process. The Voices for International Business and Education (VIBE) Board's role is to apply to the BESE Board for approval of a material amendment to our Charter to expand our services to the middle grades (Grades 6, 7, and 8). The VIBE Board can at any time in this process choose to or not to expand but the first step is to submit to the Louisiana Department of Education (LDOE) a Board Resolution stating our intent.

Recommendation: To approve the following Board Resolution.

The Board of Voices for International Business & Education operators of the International High School of New Orleans a Type 2 Charter hereby resolves after having been awarded the LDOE Reimagine School Systems Grant is now confirming its intention to expand the International Baccalaureate Program to include the IB Middle Years Program and in doing so will submit an application to BESE Board for a material amendment for changes in grade levels served to include grades six, seven, and eight. The application also requests changes in student enrollment which will result in enrollment in excess 120% of the total number of the total number of students set forth in the Voices for International Business and Education's charter.

We hereby authorize Adierah Berger to submit on behalf of the VIBE Board an application/request for a material amendment.
