Executive Summary

The 2024–2025 academic year represents a milestone for college readiness at The American Dream School (ADS). With Strategic Admissions Advice (SAA) continuing its partnership, the Class of 2025 achieved unprecedented levels of college application completion, selective acceptances, and enrollment commitments. This momentum is a testament to the school's mission-driven culture, its commitment to first-generation and underserved students, and the increasing cohesion of its college counseling team.

Beyond the data, this year's success marks the solidification of a new foundation: a coordinated, intentional, and student-centered college counseling program that is now positioned to support all three tiers of students—seniors, rising seniors, and alumni—with consistency and excellence.

Class of 2025: A Historic Year of Applications and Acceptances

The Class of 2025, **66 students** submitted **974 college applications** to more than **176 institutions**, a figure that not only represents robust engagement but also strategic diversity in student choices—from selective liberal arts colleges to CUNY, SUNY, and two-year programs.

Top Highlights:

- **Acceptance Volume:** Over **90% of the students were accepted** from colleges nationwide, with notable wins across public, private, and highly selective institutions.

Office Culture: A New Era of Coordination and Clarity

The college counseling office—led by 12th grade counselor Jennifer Marmol and 11th grade counselor Milly Albuquerque —has grown into a functional, student-centered team whose efforts now touch all three programmatic layers: application, readiness, and post-graduate transition.

Key Developments:

Curriculum Execution: The updated college counseling curriculum (starting from Lesson Plan 9) introduced better pacing, culturally responsive examples, and translated terms where appropriate. This shift increased student engagement in the 11th grade and better prepared the 12th grade for deadlines.

Class of 2026: On Track and Energized

With the Class of 2025 setting a new standard, the Class of 2026 has already demonstrated early promise and strong engagement.

Brag Sheets, Resumes, and SCOIR Lists: All juniors have begun brag sheet drafts and will finalize college resumes before the end of the academic year. They are building balanced college lists using a new spreadsheet system to replace SCOIR's unreliable list-building tool.

Essay Writing Prep: Summer 2025 will feature structured personal statement workshops, hosted in hybrid formats, with instructional support and one-on-one editing feedback built in.

College Visits and Info Sessions: 11th graders have attended on-campus events for Fordham, SUNY New Paltz, Stony Brook, and Penn State. These are not just symbolic moments but essential for access and yield management. The goal is to help students begin narrowing choices before senior year begins.

Alumni Support and Postsecondary Tracking

As of Spring 2025, the ADS team have formalized a light-touch alumni support framework:

- **Transcript and Matriculation Follow-Up**
- **FAFSA Refiling Support (where needed)**
- **Summer Melt Interventions for 2- and 4-Year Enrollees**



These efforts will be expanded with a July 2025 postsecondary tracking protocol designed to keep ADS compliant with state benchmarks and ensure our graduates persist in their next chapter.

Looking Ahead: Summer and 2025–2026 Plans

As we prepare for the next school year, we are prioritizing:

FAFSA Completion Drive (July–September): In anticipation of the new FAFSA opening in December 2025, our counselors will attend federal training and prepare bilingual family sessions.

Enhanced Alumni Tracking Dashboard: Collaborating with ADS data leadership to build a system that tracks graduation and enrollment data longitudinally and proactively supports alumni as they navigate higher ed.

Conclusion

The American Dream School's Class of 2025 has delivered great results in college access and success. Their progress reflects the convergence of strong student effort, refined systems, collaborative counseling, and strategic oversight. The structure now in place—spanning 11th to 12th grade and alumni—is stable, scalable, and rooted in equity.
