- First Day of School is Wednesday, August 27th
- Students are sitting for Regents on Tuesday, the 19th, and Wednesday, the 20th.

State Scores (NYSTP and Regents)

- Regents' data given by Dr. Melkonian
 - Educational Strategies & Student Performance
 - Mathematics: Emphasis on intentional six-week progress monitoring, targeted interventions, and use of Illustrative Mathematics.
 - Science: Mixed results improvements in art, science, and chemistry linked to consistent teachers; declines in living environment tied to turnover. There is a need for stronger literacy integration in science courses.
 - \circ ELA & History: ELA scores improved from 59% \to 63%. History scores remain the strongest subject area.
 - **Literacy Integration:** Push to embed literacy strategies into STEM courses to support comprehension and critical thinking.
 - Classroom Practices: Aim to reduce laptop dependency and return to more traditional note-taking to strengthen study skills.
