A. Financials Presentation

Cash Balance Projection:

- Submitted the last round of reimbursements to CSP and should get that cash infusion by July
- New School Venture fund infusion of cash should be released by July 24
- New cash infusions should put us back in a stronger position RE: cash flow
- Will have cleaner numbers and cash totals by July to August
- Dashboard:

- Doing well, cash on hand is still red by SCSC standards, but there is work being done to rectify that as we get reimbursements to adjust cash flow

B. SY25-26 Budget Presentation

- The budget is in a good place, with 223 students and 200 students on the waitlist.
- Will start making minor budget adjustments based on the new influx of money in July and August, because the budget was very austere
- Board Dues:
