(Procurement by Noncompetitive Proposals) Over \$250,000.00 see UGG 200.320 (f). (Procurement by Sealed Bids) Over \$250,000.00 see UGG 200.320 (c). (Procurement by Competitive Proposals) Over \$250,000.00 see UGG 200.320 (d).
