	We'd like to start with an acknowledgement of the traditional and stolen lands that we				

reside on. Lumen High School is located on the traditional lands of the the Spokane people – we are grateful to share space and time with you.

Prior to the westward expansion of white colonizers and settlers, the <u>Spokane</u> <u>people</u> had inhabited roughly 3 million acres of land. In 1881, President Rutherford B. Hayes, through executive order, limited the Spokane people's territory to 157,376 acres. In addition to this displacement, the damming of the Spokane and Columbia rivers also severely limited access to salmon, the main economic activity, spiritual base, and source of subsistence for the Spokane people.

This land acknowledgment is one way Lumen hopes to show respect and take steps toward correcting the stories and practices that erase Indigenous people's history and culture in our city.
