Recommendation — Outsourced Finance & Accounting Services, FY 2026–27

Overview

Kairos received five responsive proposals for outsourced finance and accounting services: Otterz, LDR (incumbent), CSBM, EdOps, and Mangen & Associates. Consistent with Board direction, this recommendation prioritizes capabilities, continuity, and risk over sticker price. After evaluation, the two finalists are LDR and EdOps.

Recommendation: Renew with **LDR** for FY 2026–27, with an option year for FY 2027–28.

Why LDR

- Institutional knowledge and continuity. LDR knows our chart of accounts, grant portfolio, payroll, board cadence, and Missouri authorizer reporting. No transition risk, no learning curve heading into FY 2025–26 close and FY 2026–27 budget.
- Full core scope by people already doing the work. Monthly reporting, AP, payroll (Paycor expertise on team), grant compliance, audit support, and — critically — ASBR and FER preparation, which LDR explicitly delivers today.
- Budget and forecasting gap closed via Charles Brazeale. The two areas where LDR's base proposal is not complete (3.9 Budget Development and 3.11 Dashboards & Cash Forecasting) are covered by Mr. Brazeale, who serves as my mentor and works directly with Jack and me on budget development and cash forecasting. This also materially reduces our reliance on Lindsay Phillips.
- Sage Intacct is included at >50% below market cost. LDR already runs Sage Intacct and Paycor for Kairos and includes the license in its renewal at a significant discount — a real cost saver not available under any other proposal.

Why Not EdOps

EdOps is a credible national provider with a broad scope. Three factors move the recommendation away from EdOps:

- Sage Intacct is not included. Kairos would procure Sage directly at roughly \$30,000 per year, which is not in the EdOps quoted fee.

- Year-end closeout. Mid-cycle transition would, in our judgment, require continued LDR engagement to complete the FY 2025–26 closeout cleanly — an additional, unbudgeted cost on top of EdOps.
- Loss of institutional knowledge. Re-teaching our COA, grants, payroll, and authorizer cadence creates a real risk of delayed closes and weaker audit prep in the first cycle.

Once Sage licensing is reflected, LDR is both the best fit for capabilities and the lowest total cost.

Risks and Mitigations

- Scope gaps in 3.9 and 3.11 are able to be mitigated through Mr. Brazeale’s direct involvement and a renewed SOW that defines deliverables for the 13-week cash forecast, BvA, and grant tracker.
- GAAP timing and variance commentary — reinstated and formalized in the renewal SOW (monthly variance commentary, quarterly GAAP-aligned interim reporting).

Decision Sought

Board approval to:

- Renew with LDR for FY 2026–27, with an option year for FY 2027–28 at published rates.
- Continue to utilize Mr. Brazeale’s advisory engagement for budget development, cash forecasting, and overall mentoring.
- Authorize finance leadership to execute a renewal SOW incorporating the scope clarifications above.

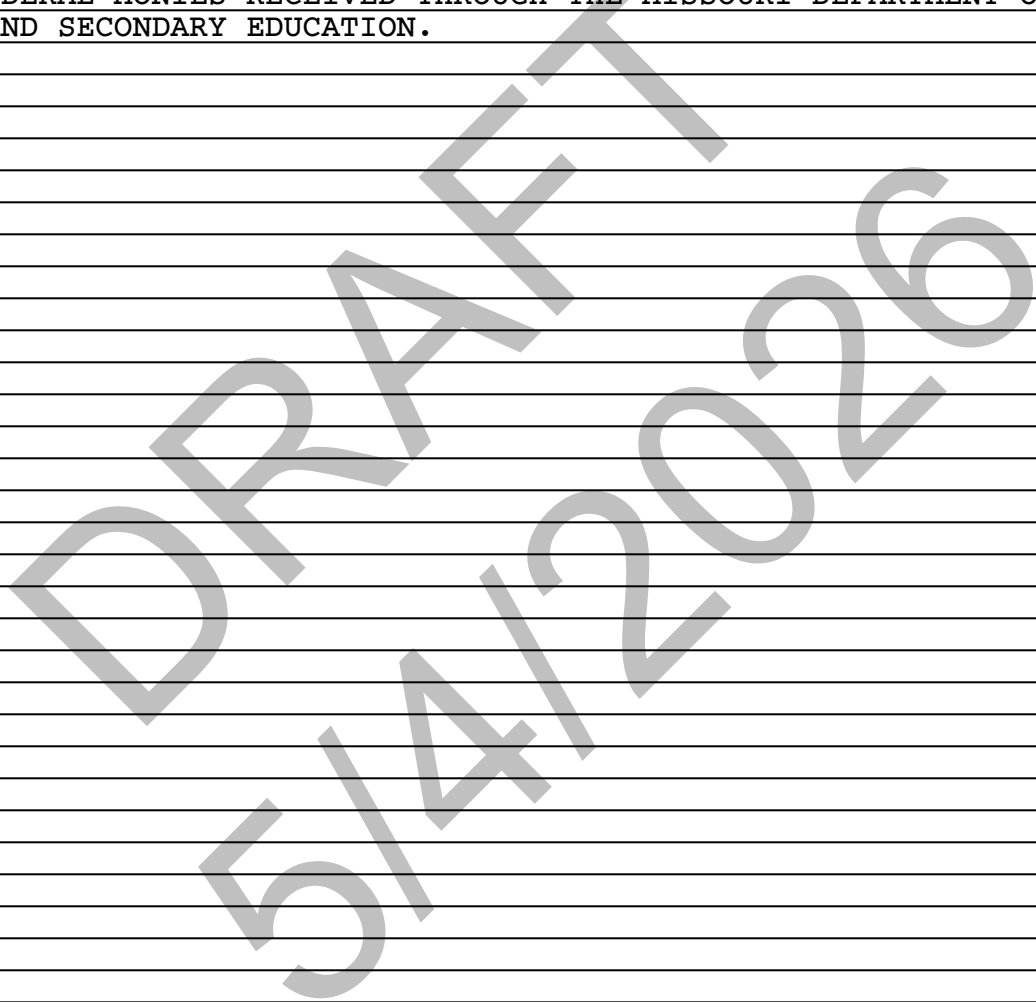
