Comparison of 2022 to 2019 data

- MS content mastery breakdown (2nd group of 8th graders); 5th & 8th take science / Social studies, everyone takes ELA & math. Overall this is the entire school's performance
- Compared to 2019: MS overall scores better/same
- Compared to 2019: ES overall scores dropped (high 90's to mid 80's) different group of students, COVID impact
- Focus on 1st column within subgroups breakdown. This data provides economically disadvantaged & ESOL learners & students with IEP's.
- Numbers have changed: more ED, more ESOL students in 2022 vs. 2019
- What can we do to double down on our efforts to reach and support economically disadvantaged students and English language learners?
