	Section 551.084 - For the purpose of excluding a witness or witnesses from a hearing during examination of another witness.		
	Should any final action, final decision or final vote be required in the opinion of the Board with regard to any matter considered in such closed meeting, then such final action, final decision or final vote shall be at either:		
	A. the open meeting covered by this notice upon the reconvening of this public meeting, or		
	B. at a subsequent public meeting of the Board upon notice thereof, as the Board shall determine.		
	*While FWFA and TeSA are public charter schools and, therefore, subject to the Texas Open Meetings Act, the Texas Boys Choir and Texas Dance Conservatory are not subject to the Open Meetings Act. Therefore, the Board may choose to discuss Texas Boys Choir and Texas Dance Conservatory agenda items in an open or closed meeting as the Board deems most appropriate.
