B. TCAA Parent Survey

- Approximately 1/4 of TCAA families participated
 - Parents understand how state funds and student fees are utilized to support students: 40.8% Agree
 - Our school communicates effectively about upcoming activities: 47.2% Agree
 - Teachers keep me informed regularly of how my child is being graded: 36.2% Agree
 - My child has access to support services based on identified needs: 39.4% Agree
 - My child is challenged with rigorous academic curriculum: 44% Agree
 - My child is provided numerous opportunities to collaborate, create, and perform: 42.2% Strongly Agree
 - My child feels safe at school: 49.5% Strongly Agree
