D. TeSA Accountability Ratings Summary

- Per Texas Education Agency TeSA's letter grade is a 'B'
- TeSA improved in all areas/domains from 2021 to 2022 and are close to being back to where they were pre-COVID
 - pre-COVID in 2019 TeSA was an 87% B and now in 2022 they are an 86% B

E. FWAFSA Accountability Ratings Summary

- Per Texas Education Agency FWAFSA's District (made up of two campuses) letter grade is an 'A'
 - Elementary Campus - 87% B score
 - Secondary Campus - 89% B score
- pre-COVID in 2019 FWAFSA was an 95% A and now in 2022 they are an 93% A
- Graduation Rate remains at 100%

VI. CEO Report

A. Updates

- Enrollment numbers are up for both campuses compared to this time last year
- Summer Camp attendee numbers were more than ever before
 - 229 students attended this past summer
 - looking to grow more next year with the addition of a High School Choir Camp
- SGT and TBC tours for this school year will likely be domestic
 - TBC - mid west Tour
 - SGT - mountain west Tour
- Gala - The Greatest Show in Fort Worth is this Saturday, August 27th

VII. Action Items

A. Dorothy Shaw Bell Choir Settlement

Mary A. Zimmerman made a motion to approve the material terms of the settlement that were disclosed in Closed Session and further to authorize Mr. Gravley, in consultation with our lawyer Mr. Fisher, to enter into a formal compromise settlement agreement with the usual terms embodied by a compromise settlement agreement for this type of case and to execute that to secure a full and final dismissal of the litigation against TCA+A with prejudice.
